

Aeronautical Systems Center



a new era of aerospace challenge and achievement.



Mass UFO Sightings Continue Over Mexico

As one can expect, after following what has been going on in the Mexican skies since the July 11th 1991 full solar eclipse, the UFO, or OVNI sightings (as they call them there) have continued in 1997 with many videos once more being taken by the dedicated people and skywatchers known as 'Los Vigilantes'. Some of the most spectacular video footage of UFOs ever taken was taken during daylight over Mexico City during May and June.

If you are familiar with the 'flotillas' of UFOs that have previously been filmed and featured on Genesis III's excellent documentaries, then you will be able to get an idea of what has once again been filmed, though this time there are larger numbers of UFOs present. The footage from May shows over 50 and the footage taken on June 14th (more than one



piece was taken) shows over 100! Many of these are moving in different directions and appear to be different, giving the event the feel that it is something out of a sci-fi film! Viewers in South America will be familiar with reports of the UFOs on popular TV show 60 minutes and other specials hosted by Jaime Maussan.

More recently a UFO similar to the one that was seen and filmed over Arizona in March was photographed over Mexico City. Needless to say, the next video release by Genesis III will be a cracker!

ROSWELL TRANSISTOR FURORE

Debate is raging in research circles over claims that Transistor technology and other breakthroughs of the the 1950s were made possible by study of advanced mechanisms of crashed flying saucers. Some of these claims have been further thrust into the public arena after a book by Philip J Corso, a retired Pentagon official, claimed that the Roswell crash was true and that many parts of the craft were farmed out to different high brow companies for research. Corso claims that these companies then claimed patents on the technology which was derived from the

extraterrestrials.(It would seem that if the extraterrestrials ever came forward they could possibly successfully sue the patent office for rights to technology and hold the planet to ransom over use of patented devices - as if...ED)

An independent journalist named Ed Wang says he has been looking into these claims. He believes there is an active cover-up ongoing at the moment. He believes that a web site which has posted articles about Bell Labs (Americas telephone giant) being involved had its offices broken into and it's computers hosed down in an attempt to silence the sources of information. It is claimed that business officials from named companies have been trying to intimidate the web authors and now moves are afoot by the web authors to move their web pages to protected Internet sites, perhaps in other countries in order to safeguard their information.

Web company ACC has apparently received threatening faxes, e-mails and phone calls, all over the course of the past three weeks. Wang also learned that Air Force OSI (Office Of Special Investigation) was in their site questioning them, and that they were queried by officials at the Pentagon, and from Langley AFB.

Wang says "It looked like they were going to take down the piece, but the head of the company, who I spoke with, instead said they had decided to mirror the site so it could not be further knocked off, and that he wanted me to solicit the UFO community for "correlational" info about 1947 Bell Labs (that was three decades before the Bell System's break-up, so it is not real likely that today's Bell Labs would necessarily be a resource, but lets' not rule that out - any BellabsGuys out there!) possible involvement in the Roswell incident. "

The president of ACC has expressed constitutional worries over these incidents. (It sounds like the script to the film Conspiracy Theory. Any persons who wish to get info to ED WANG can do so through the magazine address -ED).


- HALT SPEAKS OUT

Lt Colonel Charles Halt recently gave a presentation at the conference Saturday in which he made some interesting comments on the 1980 Redlesham Forest UFO incident in which many airmen witnesses a UFO outside an airbase in Suffolk.

Halt now claims that neither he nor the US component of the Air Base conducted any official investigation. The area where the sightings occurred were out of the US jurisdiction. The Military Police did not submit a Serious Incident Report.

Halt believes the UK police and services did not submit any reports either . Since the US and UK personnel co-ordinated closely on such matters, Halt did not doubt his counterpart's word. It is Halts understanding that local police investigated, but he did not know the results of these investigations.

The sightings were general



knowledge on the base. Halt got a UFO T-shirt as a going away present when he left.

He says that they were not told to keep quiet about the sightings. They did so out of concern for the careers and because of ridicule. There was also a concern of the US military presence in an area beyond their jurisdiction. This conflicts with Larry Warrens story who says that he was told not to speak about the incidents and was even hauled up in front of his commanding officers for breaching the secrecy by telling his

mother over a military phone.

COL Halt did not have control over the OSI. No OSI personnel investigated him. He felt there was an outside investigation because others told they were questioned.(Richard Hall told me that his information indicated that the witnesses felt something sinister about such an investigation.) The OSI could have submitted a report without Halt's knowledge.

Halt claims that there were no underground storage areas at the base. He also stated that the high water table makes underground installations impracticable. {Truthseekers investigators Matthew Williams and Richard Conway visited the site and found evidence of there being an easy potential for underground facilities having existed and been filled in. There was no such problem with high water table and we entered many tunnels along the runway which were used for service and cables. These were totally dry whilst outside it was raining heavily! Also the whole of the East Coast of England is riddled with underground complexes as a much closer to sea level altitude and water table than Bentwaters and Woodbridge! - so where does Halt get this from?}

Halt admitted that official telephones were subject to monitoring. This backs up Larry Warrens claims about being monitored and picked up for speaking to his mother about the UFO sightings. He stated that it was "unlikely" that pay phones were monitored.


Halt would not comment on Rendlesham having special weapons. This must be the nuclear weapons that weren't stored at Bentwaters then???

JAPANESE FIND UNDERWATER CITY

Divers off the shores of Okinawa, Japan are hurriedly exploring a hitherto unknown historical find - a sunken city complete with possible pyramid structures. Researchers have

UPDATES

In a previous edition of Truthseekers we published an article on a scientific paradigm. We did not have the name of the experiments in the article. The details were provided by Rob Bull.

Preliminary Findings Of Project MILAB: Evidence For Military Kidnappings Of Alleged UFO Abductees

♦ I. Introduction

UFO abductions are generally a very strange and complex phenomenon. For skeptics, journalists and the public, it is difficult to believe that abductions by alien beings have their basis in physical reality. Reports of alien beings entering bedrooms through walls, and levitating abductees through closed windows and into a waiting craft are hard to believe for the open minded researcher too. However, well respected researchers have shown that the core of the UFO abduction phenomenon cannot be explained psychologically as hallucinations or mass delusions [1]. The passing decades of abduction research have brought changes as well. Recently, some UFO abductees have reported that they have also been kidnapped by military intelligence personnel (MILAB) and taken to hospitals and/or military facilities, some of which are described as being underground.

Very few of the popular books on the subject of UFO abductions have mentioned these experiences. Especially disconcerting is the fact that abductees recall seeing military intelligence personnel together with alien beings, working side by side in these secret facilities. The presence of human military and civilian personnel occupying the same physical reality as alien beings exceeds the mind-sets of the skeptics and the open-minded researchers by several orders of magnitude. The skeptics would rather believe that stories of aliens and military personnel in governmental underground facilities are fabrications designed to elicit attention from conspiracy believers or hallucinations in general.

Researchers in the field of mind control suggest that these cases are evidence that the whole UFO abduction phenomenon is staged by the intelligence community as a cover for their illegal experiments [2]. The open-minded researchers who are trying to gain respect for abduction research ignore these stories, since they represent only a minor fraction of the cases in their files [3]. I think that abduction cases involving abductee reports of being abducted by the military as well as alien beings, are very important for two reasons:

1.) If the UFO community has evidence that a covert military intelligence task force is involved in the abduction phenomenon, we would know that this phenomenon represents a matter of national security.

2.) The alleged military involvement in the abduction phenomenon could be evidence that the military uses abductees for mind control experiments as test-targets for microwave weapons. Moreover, the military could be monitoring and even kidnapping abductees for information gathering purposes during, before and after a UFO abduction.

If either of these points are correct, researchers and victims can expect to run into early resistance when proposing Congressional hearings concerning UFOs and abductions. It is for this reason that I have created Project MILAB and present in this article my preliminary findings of this study. MILAB is the acronym for Military Abductions of alleged UFO Abductees. I reviewed the relevant literature, contacted UFO and mind control researchers, as well as MILAB abductees and mind control victims from all over the world. I have compared my findings with the comprehensive UFO Abduction Study by Dr. Thomas Bullard [4,5], the MUFON Abduction Transcription Project [6,7] and the MIT Abduction Proceedings [1].

♦ II. Helicopter Activity in Connection with MILABs

My study indicates that MILAB abductees are harassed by dark, unmarked helicopters that fly around back to the apparent interest in animal mutilations, but not in alleged UFO abductees [8, 9, 10]. However, well-known researcher Raymond E. Fowler reports some helicopter activity in connection with UFO witnesses during the seventies [11]. Dr. Thomas Bullard compared 270 UFO abduction cases worldwide from 1968 to 1984. The majority of these cases occurred during the seventies and early eighties [4,5]. I found only 4 abduction cases in Dr. Bullard's study where the abductees saw helicopters over or near their houses. Among these cases is the well investigated Betty Andreasson-Luca abduction.

Importantly, these helicopter cases occurred in North America; three within the United States and one in Canada. Curiously, there were also sightings of mysterious helicopters in England during the seventies, but they were not connected with animal mutilations or UFO abductions [12].

I have discovered that the helicopter activity associated with UFO abductions has increased from the eighties to the present day. Dan Wright has ten cases in the MUFON Transcription Project files (at the time of this publication), where helicopters were seen flying in the area of the abductee's home within hours of an alleged UFO abduction [7]. I have also found that many abduction researchers in North America have, on average, about three helicopter cases connected with UFO abductions, in their files. It appears to me that this is a North American phenomenon since none of the contacted researchers in Australia, Africa, Europe and South America have well investigated abduction cases that are connected with helicopter activity.

Well-known abductees such as previously mentioned Betty Andreasson-Luca, as well as Debbie Jordan, Kathy Mitchell,

Whitley Strieber, Leah Haley, Katharina Wilson, Beth Collins, Anna Jamerson and many more, have been harassed by these phantom helicopters [13, 14, 15, 16, 17, 20]. It is not appropriate to suggest that these helicopters are a nineties version of the black Cadillacs belonging to the Men in Black (MIB) [4], since some abductees have photographs of them and they have also been seen by witnesses who have nothing to do with the UFO phenomenon. [e.g. 10, 13, 18]. In other words, the unmarked helicopters are a physical phenomenon (perhaps contracted by a secret military intelligence task force), while the MIB phenomenon seems to have a paranormal derivation.

Let us summarize what we know about the mysterious helicopter activity in five points:

- 1.) The helicopter activity began during the late sixties to early seventies and seemed to be connected with animal mutilations.*
- 2.) During the above time frame, the helicopters showed only a minor interest in UFO abductees, appearing occasionally after UFO sightings.*
- 3.) The helicopter activity began to increase in relation to UFO abductions during the eighties and up to the present day. However, it also continued to be reported in proximity to animal mutilation sites across North America.*
- 4.) At present, many North American abduction researchers have some mysterious helicopter cases in their files.*
- 5.) There were reports of phantom helicopter activity in England during the seventies, but it seems that their interest in animal mutilations and abductees is limited to North America.*

◆ III. Alleged Kidnappings by Military Intelligence Personnel

Most abductees report interaction with military intelligence personnel after the helicopters begin to appear. Debbie Jordan reports, for instance, in a side note of her book *Abducted!* [13] that she was stunned by an alleged friend and taken to a kind of hospital where she was examined by a medical doctor. This doctor removed an implant from her ear!

The abduction experiences of Leah Haley and Katharina Wilson are full of MILAB encounters [15, 16]. Some of Katharina Wilson's experiences are comparable with mind control experiments. For example, she writes of a flashback from her childhood where she remembers being forced into what appears to be a Skinner Box-like container which may have been used for behavior modification purposes. Because of these types of experiences, Katharina Wilson published an excellent article on her Web Site titled *Project Open Mind: Are Some Alien Abductions Government Mind Control Experiments?* [19] Beth Collins and Anna Jamerson included hypnosis transcripts of an abduction by human military personnel in their book *Connections* [17], and the late Dr. Karla Turner investigated MILABs in her books *Into the Fringe* and *Taken: Inside the Alien-Human Abduction Agenda* [20].

A worldwide survey revealed that most North American abduction researchers have on average, between two and five MILAB cases in their files. At present, it seems to me that there are no UFO-related MILABs in Australia, South America, Africa, Europe, England or Ireland. I compared typical UFO abduction scenarios that were described in Dan Wright's MUFON Abduction Transcription Project with ten well investigated MILAB victims: Casey Turner, Katharina Wilson, Leah Haley, Debbie Jordan, "Polly," "Pat," "Lisa," "Beth," "Angie" and "Amy." The last six

names are pseudonyms of abductees from the late Dr. Karla Turner's book *Taken* [20]. What I found were many differences between abductions by alleged alien beings and abductions by military personnel.

MILABs involve the following elements:

Dark, unmarked helicopter activity, the appearance of strange vans or buses outside the houses of abductees, exposure to disorienting electromagnetic fields, drugging, and transport by a helicopter, bus or truck to an unknown building or an underground military facility. Usually after the military kidnappings there are physical aftereffects such as grogginess and sometimes nausea. There is also a difference when the abductors appear. In most UFO abduction cases, the beings appear through a closed window, wall, or the abductee feels a strange presence in the room. Most abductees report that they are paralyzed from the mental power of the alien beings. During MILABs the abductee reports that the kidnappers give him or her a shot with a syringe. It is also interesting that MILAB abductees report that they are examined by human doctors in rectangular rooms and not in round sterile rooms, as they are described during most UFO abductions [4, 5, 6, 7]. The described rooms, halls and furniture are similar to terrestrial hospital rooms, laboratories or research facilities and have nothing to do with "UFO" furniture.

During a MILAB, the examination is similar as during UFO abductions, however, the MILAB victim is not paralyzed, but rather, tied to an examination table or a gynecological chair. Sometimes, the abductee gets a strong drink before the examination. This is perhaps a contrast-enhancing fluid. MILAB doctors are usually dressed in white lab coats and show an interest in implants as well as gynecological examinations. In some MILAB cases military doctors searched for implants and sometimes even implanted the abductee with a military device. Therefore, surgeons extracting alleged alien implants should be prepared in the event they find military devices since human implant technology is very advanced.

◆ IV. Terrestrial Implants

To date, more than 3 million animals worldwide have been successfully implanted with an implantable transponder manufactured by Destron-Fearing [21]. The implantable transponder is a passive radio frequency identification tag, designed to work in conjunction with a compatible radio-frequency ID reading system. The transponder is activated by a low-frequency radio signal. It then transmits the ID code to the reading system. The smallest transponder is about the size of an uncooked grain of rice. The transponder's tiny electronic circuit is energized by the low-power radio beam sent by a compatible reading device.

A similar bio-chip for humans was developed by Dr. Daniel Man in the United States. Dr. Daniel Man has held a U.S. patent for a homing device since 1989, that can be implanted in humans [22]. He developed the implant for solving the missing children problem. This device is slightly larger than the Destron implant and cannot be injected with a special syringe. Instead, a small surgical incision must be made for it to be implanted. It is important to note, that Dr. Man claims that the best location for his implant may be behind the ear. MILAB abductees like Debbie Jordan have reported that doctors have removed implants from their ears!

Dr. Man says that the device is powered by a small battery that can be routinely charged with a device that is held outside the body near the location of the implant. Those individuals in charge of monitoring the implants (and therefore the people) could use three satellites or specially equipped helicopters if they wanted to find a

missing person. By using triangulation to follow the signal from the implant, satellites or the helicopters could pinpoint the implant's exact location. Before Dr. Man's device becomes available for use in humans in the United States, it will have to be approved by the U.S. Food and Drug Administration.

An agency interested in monitoring physiological information from an abductee during a UFO abduction could use biomedical telemetry. Biomedical telemetry is defined as a special area of biomedical instrumentation that permits the transmission of physiological information from an often inaccessible location to a remote monitoring site [23]. The transmitting unit can be implanted within a subject's body. Animals have been monitored with biotelemetry for about 30 years now. By using telemetric systems as a method of monitoring abductees, the military could obtain physiological data, such as respiration, muscle tension, and the presence of adrenaline in the bloodstream.

There is evidence that the military developed Dr. Man's implant technology years ago. Research in the observation and control of human behavior and its possible use in rehabilitation was performed during the sixties. National Security experts like Dr. Steven Metz and Dr. James Kievit predicted in their report *The Revolution in Military Affairs and Conflict Short of War* for the US Army War College, that in the near future every American at risk could be equipped with an electronic individual position locator device (IPLD) [24]. They suggested that such a device could be permanently implanted under the skin with automatic remote activation upon departure from the United States, while passing through a security screening system at the airport, for example. The predictions by these national security experts resemble the plans of Dr. Joseph A. Meyer, a computer specialist with the National Security Agency (NSA). During the seventies, Dr. Meyer proposed attaching transponders to all Americans arrested for various crimes [2].

During the late fifties and early sixties neuroscientist Dr. Jose Delgado invented the stimoceiver, a electrode capable of receiving and transmitting electronic signals via FM radio waves. Such a device implanted in the brain via the sinus cavity for example, will act as a powerful stimulant when activated by FM radio waves. One can suggest that the stimoceiver has since been modified to receive stimulation from microwave pulses and is capable of wielding a surprising degree of control over the implanted victim's response mechanisms [25].

Implants were being used on unwitting persons as early as fifty years ago. One well documented case of the implantation of an electronic device into a victim is the case of Robert Naeslund. Mr. Naeslund claims that he was unwittingly implanted during an operation in Stockholm, Sweden. He has X-rays which clearly show a mushroom-shaped device in his brain. He claims that the operation was performed by Dr. Curt Strand, who inserted the device in his head through the right nasal passage [26].

The transnasal approach to implants is in common use in Neurosurgery [27, 28, 29, 30, 31]. Interestingly, alien abductees have been reporting since the sixties, how alien beings have implanted them by placing small objects up their noses through the nasal passage and sinus cavity. Alleged alien abductees and mind control victims relay that either alien doctors or human doctors performed these procedures.

Robert Naeslund is not alone, he is now a researcher of Gruppen, an organization against illegal mind control experiments. Gruppen and other organizations like the Freedom of Thought Foundation have collected a lot of evidence that a secret

implantation program is underway [26, 27]. These organizations are in contact with many victims from all over the world who have experienced similar effects as Naeslund, but have nothing to do with the UFO community.

♦ V. Virtual Reality Scenarios and Microwave Hearing

It appears that some experiences of alleged alien abductees and mind control victims may be explained by an advanced virtual reality technology. The late Dr. Karla Turner called these experiences Virtual Reality Scenarios (VRS) [19, 20]. There are alleged mind control victims who claim that someone implants pictures in their brain [32]. If someone has been implanted with an intracerebral device, then the implant operators may be able to electronically implant pictures and memories into the brain of the abductee.

The New World Vistas was a major undertaking for the USAF Scientific Advisory Board (SAB) [33]. This military publication was published in June 1996 and is a forecast of possible military developments over the next 50 years. In this publication, military scientists suggest that the development of electromagnetic energy sources, the output of which can be pulsed, shaped, and focused and coupled with the human body will be able to: 1) allow one to prevent voluntary muscular movements, 2) control emotions and actions, 3) produce sleep, 4) transmit suggestions, 5) interfere with both short-term and long-term memory, and 6) both produce and delete an experience set.

The military scientists argue that the concept of imprinting a virtual reality experience set is highly speculative, but nonetheless highly exciting. If such a technology was developed in secret and exists today, the unexplainable vividness of some abduction accounts may be explained by the implantation of an experience set into the brain of an abductee. Dr. Joseph Sharp and Allen Frey experimented with microwaves and transmitted spoken words directly into the audio cortex via pulsed-microwaves. Dr. Frey's work in this field, dating back to the sixties, gave rise to the so called "Frey Effect," which is commonly known as "microwave hearing" [34, 35].

Again, alleged alien abductees and mind control victims sometimes report that they hear voices in their heads, although they are not schizophrenic. Certainly these scenarios cannot be the case for all UFO abductions like multiple abductions, but it may explain a small portion and may play a significant role in MILABs.

♦ VI. Otherworldly Journeys and Underground Military Facilities

It is interesting to note, that seven abductees of my test sample claim that they were allegedly transported to a military underground facility. The research of Dr. Richard Sauder showed that almost every federal agency and military institution has several secret underground facilities across the United States. Some of these facilities are so secret that there are only rumors about their existence [36]. Otherworldly Journeys to strange underground places are common in UFO abductions and Dr. Thomas Bullard found a specific pattern in Otherworldly Journeys in his abduction research [4, 5].

1.) Preparation: The alien beings put the abductee into a protective environment for the trip.

2.) Travel: Actual transit to the Otherworld occurs.

3.) Underground: The abductee passes underground.

4.) *Landscape: The abductee sees the surface of the Otherworld.*

5.) *Museum: The tour of the Otherworld includes a stop at a museum or zoo.*

In Dr. Bullard's study there are 10 UFO abduction cases where the abductee experienced an Otherworldly Journey in an underworld, during their UFO abduction. A typical Otherworldly Journey is Betty Andreasson's experience in 1950. She experienced seeing a UFO plunge into a sea and come out again, and then enter huge crystalline caverns which broadened into a vast underworld. Less frequently the examination occurs on the Otherworld. During an abduction experience in 1967 Betty Andreasson passed through a long dark tunnel similar to a mine shaft cut out of rock. In addition, Dr. Gilda Moura informed me that she has investigated UFO abduction cases during which abductees reported Otherworldly Journeys into underground caves in Brazil.

It is interesting that these Otherworldly Journeys are not comparable to well investigated MILAB underground cases. The Otherworldly Journey experiences have a mystical quality, while the MILAB underground experiences seem to be a manifestation in our reality. MILAB abductees describe elevators, hallways, generators, conference and medical rooms. Contrary to experiences during Otherworldly Journeys, if a MILAB abductee is kidnapped to an underground facility, the abductors examine the victims there. Some abductees report Otherworldly Journeys and MILAB experiences separately [16, 20]. Beth, an abductee from Dr. Turner's book *Taken: Inside the Alien-Human Abduction Agenda*, described flashbacks which began with her seeing a small flying disc and then entering a well lit underground city [20]. The craft flew through a tunnel passage into an enormous cavern that contained several buildings. UFOs were parked in various locations and alien beings were working side by side with human military personnel. In her next flashback Beth somehow flew through a body of water and into a tunnel, and then emerged from a lake.

Such flashbacks should be investigated very carefully since they could be a mixture of an Otherworldly Journey (entering a well lit underground city) and a MILAB underground experience (seeing military personnel). It is also important to note that some abductees have flashbacks and they remember aliens and military personnel together, but during hypnosis the abductee remembers only the military personnel [15, 37]. It is possible the abductee mixed an alien abduction experience and a MILAB scenario, or that the abductee underwent some kind of hypno-programming by military psychiatrists during the MILAB. It is also possible that the military is using Electronic Dissolution of Memory (EDOM). This is accomplished by electronically jamming the brain, causing the neurotransmitter acetylcholine to create static which blocks out sight and sounds. After this mind control procedure a MILAB abductee would have no memory of what he or she saw or heard. The mind of the abductee would be blank [2, 19, 25].

◆ VII. Discussion

We must consider the possibility that some of the information we are getting from MILAB abductees may be cover stories, induced by the hypno-programming processes of military psychiatrists. There is also the possibility that the military uses rubber alien masks and special effects during a MILAB. MILAB abductee Katharina Wilson reports flashbacks where she remembered holding a rubber mask of an alien head in her hands [16]. Facts such as these lead some mind control researchers to believe that all alien abductees are used in secret mind control and/or genetic experiments staged by a powerful black arm of the United States government [2]. However, I have

found some arguments against this over generalization:

1.) If all alien abductions are a cover for secret mind control or genetic experiments like the Lebensborn Project of the Nazis [38], why have abductees only reported military intelligence involvement since the early eighties and not before? We should see the opposite of this, since the mind control technology would be much better in the nineties than it was during the sixties and seventies!

2.) Why are there mind control victims who are implanted and used for secret weapons tests, but have nothing to do with the UFO phenomenon or alien abductions? It seems to me that the "mind control agenda" does not need UFO abductions as a cover story, since nobody believes the claims of ordinary mind control victims in the first place, although they have X-rays where everyone can see anomalous objects in their heads.

3.) If all alien abductions are a cover for mind control experiments, why does the military perform gynecological examinations of female abductees?

Serious researchers should investigate all possibilities. Some UFO abductees may indeed be mind control victims or they may have been used in black-ops genetic experiments from the eighties or earlier. However, I think there is another motive that is more plausible for the military's involvement in the UFO abduction phenomenon. My preliminary hypothesis for alleged military kidnappings of UFO abductees is as follows:

MILABs could be evidence that a secret military intelligence task force has been operating in North America since the early eighties, and is involved in the monitoring and kidnapping of alleged UFO abductees.

In the early 1980s, a lot of money became available for top secret military projects like the Strategic Defense Initiative (SDI). I believe this secret task force may be financed by a portion of this money that is set aside for SDI. It is no coincidence that the genesis of SDI and the reports of military intelligence personnel interfering with abductees coincide with one another. It seems to me that they










Footage taken 5 May 1994 by SR Francisco Javier M. Flashing light was seen away from the craft at the point where the arrow as directed (not shown in this still).






ALIENS - CLOSE ENCOUNTERS OF THE METAPHYSICAL KIND

UFOs - Unidentified Flying Objects. These exceptionally random affairs have been experienced and recorded, in one form or another, from cave paintings to the written word, ever since higher-order man first walked the earth.

Although details of UFO emergencies have always been relatively few and far between, over time this has amassed into thousands of Close Encounter testimonies. Yet, despite such an impressive collective total, we still have next-to-nothing in the way of hard, physical evidence to support these claimed episodes, leaving us only with cold trails, hearsay and speculation to ponder upon.

Nowadays, thanks to the innovation of film and video technology, there are even commercially - available movie documentaries, [such as the Roswell Autopsy], featuring what is alleged to be actual alien cadavers, sporting bulging heads and diminutive torsos, but strong doubts have been expressed over the authenticity of these.

On top of this, we have numerous, witness home-movies of apparently structured alien vehicles, which, detailed and visually impressive though they are, have ALL, without exception, been anchored by suggestions of chicanery.

Could the reason for such a distinct lack of sure-fire proof, I wonder, be that genuine alien manifestations are occurring on an extra-sensorial or spiritual level? It is worth opposing the UFOlogical 'sacred cows' of flesh-and-blood space-beings and structured ET hardware for a while, and begin exploring the idea of incorporeal, multidimensional intelligences as a major possibility.

Here at B.E.A.M.S. The British Earth & Aerial Mysteries Society, (Britain's only combined UFO & Paranormal research Organisation) , I have personally interviewed subjects, including ex-military personnel and other respected members of the community, who have observed alien intruders, both flying objects and entities, actually passing directly through solid, material walls, closed doors and windows.

In point of fact, classic abduction cases internationally, feature screen-memories where both the abductee and abductors freely float through material obstructions, as if by magic!

Judging by such accounts, it is doubtful that these events are taking place on the corporeal plane of consciousness

because, if this were the case, then it would involve a complete molecular breakdown of the human anatomy, and reassembly of said in its correct order, ("beam me up, Scotty!").

Often overlooked is the fact that strong parallels exist between "ET abduction" and human NDEs, or Near-Death Experiences, in which a person clinically dies for a few minutes, and then, either by miraculous or artificial means, is resuscitated. Near-death experiencers often speak of "leaving their flesh and blood bodies" and levitating up to, and through the ceiling, or along a dark tunnel at the end of which is a welcoming, brilliant light.

Might it be that aliens behave like, or are similar in make-up to, our own astral bodies, the ghost-double that is thought to reside within each of us, and that they are in fact denizens of unseen multiverses or inner space, a parallel world to the spiritual spheres where we may all go in the end --- the higher, or even subordinate realms of angels and demons?

Along with this potentiality, we must also consider the contingency that these figures are 'living creations of the mind', which congregate in a type of 'hallucinatory ocean', a place where abstract bodies with an element of objectivity are, given the ideal conditions, capable of manifesting in the spectral field, (a vibrational reality believed to co-exist with the physical realm), either autonomously, or as the result of the actions of one or more unconscious minds.

Basically, if the biological aliens concept is the result of indoctrination and misguidance, as I am inclined to think, then part of the problem rests with witnesses investing psychic phenomena with archetypal sci-fi imagery.

A natural tendency for the human brain is, when presented with unfamiliar data, to embellish, falling back on or gap-filling with accepted paradigms. At its most disturbed, the human memory will confabulate, even generating imaginary scenes, which, perhaps after being dragged back into the waking memory during hypno-regression, are eventually accepted as actual experiences.

A leading expert has estimated that as many as four million people have been affected in some way or another by aliens. One of these so affected is screen-

writer and author, Whitley Strieber.

With such best-sellers as "Communion " and "Transformation" (which is a detailed account of his relationship with aliens), to his name, Whitley has hinted that, in his experience, aliens are able to manipulate the human mind and penetrate our ordinary space-time consciousness.

Contact is made by inducing a waking dream situation in humans. Although their true image is more of an energised mass, they are able to appear in a recognisable presentation when wearing physical "cloaks".

Strieber goes on to describe how one of the "ships" that he was taken onto was itself a living energy. Some free-thinkers have further postulated that the mystery fliers of our airspace may be protozoa-like creatures, or constructions of ethereal matter, motivated by an unknown force, and that the laws of nature as we read them are sometimes overthrown under special circumstances to unveil animations of Earth's Intertwined Worlds.

If just one of these ideas is somewhere bordering the truth, then supernatural and metaphysical must become definitive bywords for all close encounters of the unexplainable kind.

Astronomically, the location for what has been termed "the alien realm" may be all around us, within the fabric of area space.

Never mind x-files ... The truth is ... That Ufology may have been led off the correct track by the temptingly easy, and sugar-sweet beacon of Hollywood, rather than pursuing the equally exciting yet brain-taxing and largely suppressed discoveries in quantum mechanics and sub-atomic physics.

Every day we are informed that there is no conspiracy to keep the truth from the public. Those within many sections of the media, and inside the religious and scientific establishments, they who decide what the public have access to, are terrified that millions will learn of the surprising truth concerning alien intervention.

INCIDENT AT WEST FREUGH

Most of us, including myself were not around in the 1950s during the course of certain incredible events and so, for this article, I want you to enter a time machine of the imagination. Cast your mind back if you will to Thursday, 4th April 1957. Tom Finney of Preston North End FC had just been voted Footballer of the Year and the recently elected MacMillan Government had come to the somber conclusion that the sun was setting on the British Empire.



Consequently, it was announced on the day that there was going to be a radical change in the defence policy of the UK, more reliance was going to be placed on a nuclear deterrent and large cut backs would be made in conventional forces; especially those serving overseas. The world was also becoming a dangerous place to live as Britain was one month from exploding its first H-Bomb over the Pacific and the USSR was about to announce that it had developed long range missiles capable of delivering nuclear warheads.

With all the ballyhoo over the defence cuts, it was small wonder that little attention was being focused on extraordinary events that were happening near Stranraer in South West Scotland. On the morning of the 4th, radar operators at

the Ministry of Supply, Bomb Trials Unit, West Freugh picked up an unusual response from an almost stationary object. The first return was picked up on the screen of a radar at Balscalloch. Although its range remained appreciably uniform for about ten minutes, its height appeared to alter from about 50,000 to 70,000 feet.

A second radar was switched on and validated this return as the unidentified flying object was detected at the same

range and height. The radar sets used were capable of tracking the objects automatically and the information was obtained in the form of polar coordinates. These could then be converted to give plan position indication and were printed out onto a plotting board via an electronic pen, the heights were read off a meter. The unidentified object was tacked on the plotting table and after ten minutes, it moved in a north-easterly direction with a gradual increase in speed (70mph groundspeed at 54,000 feet).

Further confirmation of the unidentified object came from a radar station twenty miles away from Balscalloch which was equipped with similar height/position monitoring equipment. After the radar return had traveled about twenty miles, it did a sharp turn and proceeded in a south-easterly direction whilst increasing its speed. The Balscalloch radar tracked an object at 50,000 feet moving at a speed of 240 mph while the other station tracked four objects at 14,000 feet and 4,000 yards line astern from each other. The Balscalloch radar also picked up these returns. It was noted by the radar operators that the sizes of the echoes were considerably larger than would be expected from prosaic aircraft. *In fact they considered that the size was nearer a ship's echo.*

In the previous December, a memo marked SECRET had been issued by RAF HQ No 11 Group (Ref. 11G/S.1803/7/Air Int. Paragraph 3 of this memo stated:-

"It will be appreciated that the public attach more credence to reports by Royal Air Force personnel than to those by members of the public. It is essential that the information should be examined at Air Ministry and that its release should be controlled officially. All reports are, therefore, to be classified "CONFIDENTIAL" and personnel are to be warned that they are not to communicate to anyone other than official persons any information about phenomena they have observed, unless officially authorised to do so"

Despite these standing orders, it appears that the *Evening Standard* must have gotten a handle on the story as a reference was made to West Freugh in the Saturday edition (8th April). It would seem that the newspaper's Air Reporter was told by an Air Ministry spokesman that the radar returns were attributable to a weather balloon which had been sent up from Aldergrove airfield in Northern Ireland. This rather mundane explanation seems to have been accepted, the reporter had his story and the case was to all intents and purposes closed.

The *Evening Standard* was not the only newspaper to have reported a UFO that Saturday for The *Daily Sketch* quite sensationally had obtained a photograph of a UFO from a 25-year-old cabinet maker called Reginald Queree. He had taken the picture at his home at First Tower, Jersey and the tabloid's "photographic experts" were absolutely convinced as to its authenticity. You can imagine the embarrassment felt by the tabloid editor when told that the Jersey photograph was not authentic and on Monday, 8th April 1957, The *Daily Sketch* published a small paragraph stating that the "flying saucer" was in fact a fake and had been constructed of cardboard and silver paper suspended from a clothes line. Mr Queree confirmed that he took the photograph some months prior to going public and was waiting until someone else reported "something strange in the sky", he also wanted to demonstrate how easy it was to

"fake" a photograph of a flying saucer. *It would seem that the Daily Sketch missed out on another major exclusive, namely, the apparent clairvoyant skills of the First Tower Snapper. He would have had to have given the newspaper the photograph and story by about a 10.00 pm deadline on Friday the 5th April - The Evening Standard did not publish until Saturday 6th April !* It is apparent from historically authenticated Public Record documents that The Deputy Directorate of Intelligence (Technical) took a rather unusual interest in this particular faked story although I would not like to speculate upon the reasons for this. Suffice to say, it will be interesting to see the full intelligence dossier on the *Daily Sketch* article and the background of "Mr Queree" if, and when Britain's Intelligence Files are released from this particular era (If I am still around, I will be visiting the Public Record Office for these answers in 2057 !).

Returning now to the West Freugh incident, it would be interesting to see what the Deputy Directorate of Intelligence thought of this. In a report dated the 30th April 1957 (Ref. DDI (Tech)/C.290/3/, the following observations were made:-

It is deduced from these reports that altogether five objects were detected by the three radars. At least one of these rose to an altitude of 70,000 feet while remaining appreciably stationary in azimuth and range. All of these objects appeared to be capable of speeds of about 240 mph. Nothing can be said of physical construction except that they were very effective reflectors of radar signals, and that they must have been either of considerable size or else constructed to be especially good reflectors.

There were not known to be any aircraft in the vicinity nor were there any meteorological balloons. Even if balloons had been in the area these would not account for the sudden change of direction and the movement at high speed against the prevailing wind.

Another point which has been considered is that the type of radar used is capable of locking onto heavily charged clouds. Clouds of this nature could extend up to the heights in question and cause abnormally large echoes on the radar screens. It is not thought however that this incident was due to such phenomena (author's note:- clouds, like balloons would also be unlikely to move against prevailing winds at high speed).

It is concluded that the incident was due to the presence of five objects of unidentified type and origin. It is considered

unlikely that they were conventional aircraft, meteorological balloons or charged clouds.

It is interesting to note that observation 2 states that there were no meteorological balloons in the vicinity at the time in question which contradicts the version of events given to *The Evening Standard* by an Air Ministry spokesman. Was this a blatant cover-up of the facts ? Certainly the Deputy Directorate of Intelligence were unhappy that the radar incident fell into the hands of the press and this is alluded to in a secret memo (Ref DDI (Tech)/S290/). However, even more damning were the draft notes prepared for Mr George Ward, The Secretary of State for Air. A Parliamentary Question was tabled by Mr Stan Awberry, a Labour MP for one of the Bristol constituencies on Wednesday, 17 April, 1957 (*Hansard*, col 206). The question read:-

To ask the Secretary of State for Air, what recent investigations have been made into unidentified flying objects; what photographs have been taken; and what reports have been made on the subject.

Extracts from the Ministerial notes prepared for George Ward read:-

3. The Ministry of Supply Bombing Trials Unit at West Freugh, Wigtownshire reported a radar sighting made on 4th April of an object which was tracked 36 minutes, continually increasing in speed whilst losing height. Enquiries so far made reveal that that no service or commercial aircraft was in the vicinity at the time. It is possible that the object was a private aircraft, and enquiries on this point are still being made. The object could not have been a balloon since it was moving against the wind.

4. A reference to this report was contained in the "Evening News" and "Evening Standard" on 6th April (cutting attached). If S. of S. is asked questions on this point, it is suggested that the reply should be on the following lines:-

"That report is still being investigated, and the cause has not yet been established. It may well have been a private aircraft."

You will notice from these draft notes that the Minister was not informed of:-

The size of the object
The appreciable height
The fact that it was hovering

Also, no mention was made of

objects ; was there a cover-up? You bet there was !

No doubt, sceptics will come up with the usual rubbish such as clouds, conventional aircraft etc so, let us become sceptical to the sceptics, let us turn the tables by saying what the West Freugh returns could not have been:-

Helicopters.- I agree that helicopters can hover and reach speeds in excess of 290 mph; however, in 1957, helicopters were an emerging technology and I am certainly not aware of any, even today, that could reach a height of 70,000 feet.

Clouds.- No, these do not move against prevailing winds (or weather balloons).

Powered Airship.- I think 290mph is a little excessive as is 70,000 ft.

Meteorites/bollards.- my answer to this sounds very similar to bollards. These do not fly in formation or change direction and are very susceptible to the laws of gravity

Flock of birds.- I do not know of any birds that can fly at this height. Probably because they would have great difficulty in donning oxygen masks and trying to fly at the same time !

Harrier Jump Jet.- There may well have been harriers prototypes about in 1957; however, I don't think the service ceiling of the harrier exceeds 40,000 ft and it certainly would not give a radar return the size of a ship (note:- in an interview with Sir Ralph Noyes, Jenny Randles was told that the West Freugh returns were more akin to battleships !).

Psychological delusion.- Three radar sets at two separate stations- extremely doubtful.

So there you have it, a classic case of a UFO. No whiff of a down to earth explanation and most definitely a structured craft under intelligent control. Let us be honest about this, any powered craft that hovers from 50,000 to 70,000 feet, changes direction and speed has too be under intelligent control. Otherwise, the object would fall down to Earth with a resounding thud, as I have no doubt said before, the laws of gravity are very stringent on this point. In conclusion, the next time someone debunks UFOs, do them a favour, show them this article. The West Freugh Files are available at the Public Record Office, Kew, Surrey (Ref. MONKS PARK - BUSTED!

AN UNINVITED VISIT TO THE MONK PARK FACILITY

In trying to gather evidence of UFO research at a remote underground RAF Base in Wiltshire two UFO researchers found themselves at the heart of a massive underground complex and in doing so nearly got themselves shot!

As readers will no doubt be aware I have been slowly gathering damning evidence against the RAF Rudloe Manor facility to help prove that is lying about its operational functions and capacity. We now have documented proof that Rudloe Manor was involved in UFO investigations in the 1960s and continued in some unknown role till 1992 - possibly even until the present.

We wanted to prove that lies were being espoused with the base not having extensive underground facilities and its non involvement in UFOs. We knew that military at RAF Rudloe Manor operated out of the extensive underground facilities for command and control functions. These functions include the command and control centres having access to military satellites which can see RADAR as well as the ground RADAR network. I had been tipped off that these facilities were capable of and indeed had tracked UFOs. Knowing the UFO investigations aspect carried out by the Provost & Security Services I was eager to find out more about the operations centres underground.

JUSTIFIED

I certainly feel that we are not being told the whole truth about the base. In proving lies in every area of our research we feel we are justified in saying that we are being lied to about the UFO investigation work being carried at Rudloe Manor.

An example of lying is the time I contacted Flight Lieutenant Karen Brough and Sergeant Graham Coppins to ask about the underground facilities. We decided to take up one of the statements that we were give by officers at Rudloe Manor. I was told by these two officials that the underground parts to Rudloe Manor were not as extensive *as I thought*. I was also told that the facility would "not be a nice place for anyone to go as it was damp dark and cold and not used". After asking Graham Coppins to be specific with me about which part of the underground facility were in fact in this condition I then got an admission that not all parts were in this state. He then tried to wriggle out of this admission by stating that most of the facilities were being sold off soon anyhow. I asked within what time scale the bases would be sold off and was informed that they would be up for viewing in about 3 months. The only base that Sgt Coppins would be specific about was Monks Park

being up for sale.

I waited for the allotted time plus 2 months (a total of 5 months) before contacting Sgt Coppins again. This time when I got through to him he seemed well aware of who I was and appeared agitated by speaking to me. I asked him if he could tell me if the Monks Park facility was indeed now up for sale. He wouldn't answer my questions and kept on turning my questions around and asking me questions like "I don't know if Monks Park is up for sale - is it?" & "...is that what you are saying?" I explained that he had been the one who told me that this base would be up for sale. He quickly responded by saying that he had never spoken to me nor would he discuss anything of that nature with me, nor would any of his staff or anyone else at Rudloe Manor. He cited official secrets acts and security which meant that people would never have spoken about this in the past. Quite unusual behaviour I thought. My Rudloe Manor publicity campaign had made the quite open liars go to ground. Many of the guards have even changed their play down stories since





PHOTO: LIFTSHAFTS AT MONKS PARK

our actions. This must be a positive result if anything, not to be misled as a member of the public.

About 1 year ago I decided to look into the Monks Park facility in question because I suspected that something was going on which had changed the plans of the MOD in their sale of the base. Upon arrival I observed what looked like a very closed down base with no security guards or cameras. Unsecured bases are prime targets

for vandals or professional thieves. Considering also that this underground facility connects to Rudloe Manor via a secret tunnel (gleaned from a Public Records Office file) one would not imagine such a base to be unguarded. Through the fence I could see lift shaft buildings and signboards which gave the operational status of the lifts. The fences looked a bit imposing so I decided not to climb over and take a further look at that time.

LONE SECURITY GUARD

Then a few months ago I was back in the area of Monks Park with UFO research colleague Richard Conway and we decided to take a look at the facility again. This time I was aware that there was a lone security guard at the facility. I decided that perhaps, with two of us for safety, that now it would be a good idea to take a look

inside the base. We climbed the Y fork security fence at the back of the site and made out way, out of sight of the guard, around the facility. We observed the lift shafts which were locked and secured.

We found that many of the buildings were open and unsecured and we moved through them finding that most were empty and disused. Then we came across a warehouse building which was full of crates and boxes. On the sides of the boxes were stapled on plastic wallets with pink folded slips inside. The slips were professionally printed manifests for the contents of the crates. We company that had produced the slips was "Logistical Services" and the logos used on the top of the paper were a Navy warship and submarine. The prints were made in July of 1997. It appeared that the warehouse we were in was a loading bay. We moved further into the warehouse and spotted a tram access way - it seemed to go downwards and the tram was not present.

Upon closer inspection both Richard and myself were able to look over the safety barrier down into the depths of the underground storage area. To our surprise there were lights on at the end of the long descending tram corridor. The tram could be seen at the end. Looking at the wall we could see the controls for the tram. I suggested that we try and go underground on foot by walking down the rail tracks for the tram. Richard was reluctant but I reminded him that this was the whole reason we came here and after some coaxing Richard agreed to descend into the tunnel.

The steep angled descent of the tramway was made harder by the fact that there were lots of wires and floor

obstructions. We carefully made our way down the corridor towards the waiting tram. Being aware of certain objects that looked like they could be trip switches and alarm sensors we navigated around these carefully. It took us five minutes to get to the bottom of the tunnel. Looking back upon the way we had just come from, the entranceway seemed like a small spec behind us. Climbing up and over the tram to allow us access to the facility we got our first look at the underground tunnels.

MASSIVE UNDERGROUND FACILITY

What we saw made our mouths drop. My heartbeat got more excited at the fact that I was at the doorway to a potentially massive underground facility, tunnels all around me and nobody to be seen and stop us going in. It seemed too good to be true. Richard climbed to the point where I stood. We observed how modern it looked and how clean - even the rock-face walls were painted. There were fork lift trucks sitting around at various places in this high loading bay in front of us. We both pondered if we should go in and what were our chances of getting caught. I managed to convince Richard that we would be safe and that the facility seemed empty of people. In a few moments Richards feelings understandably changed!

As I took a step inside the tarmac of the base I jumped as alarms sounded. Now, in the distand, we could also hear Klaxons and sirens were going off. I turned and caught Richards glance. Almost instinctively Richard had turned and was already starting to climb out of the tram to make an escape up the corridor. I stopped him and said that we had a better chance of hiding in the underground facility and said it was our best change to escape. I pointed out to Richard that by the time we got to the top of the entrance tunnel we had just come in through there *would* be security waiting for us. By going in we had the chance of hiding and perhaps finding another way out. He agreed with me reluctantly so I said, "Lets go... Run!".

We both leapt off the tram and started running along corridors. The lighting on the ceiling changed from




PHOTO: TARMACK ROADS LEADING DEEPER UNDERGROUND

fluorescent tubes to orange, red or green lamps. This gave the atmosphere of the tunnels the most eerie effect. We ran and ran taking lefts and then rights along various tunnels. As we ran I said the best idea was for us to try and lose ourselves in the tunnel system, perhaps even to hide. As we ran and looked and took photos I realised that we could easily lose our film so we decided not to give up the film voluntarily.

As we ran we were getting deeper and the tarmacked roads were getting longer. We found ourselves passing long off-reaching storage bays of hundreds of feet deep full of containers and crates. We passed

too many of these to take in what they were full of. We passed bays with marking for various MOD departments and even one bay which had the sign CIA written on it. We didn't stop to look at what was contained within, and later on forgot to go back here. We eventually came to a large theatre of storage bays. We ran to the end of a bay and turned along another. Surrounded by wooden boxes stacked up to 20ft around us and in the dark of this obscure storage bay me and Richard hid next to some cardboard crates.

I said that we would need to wait at least 2 hours to allow any security to have checked the facility and hopefully given up. I set my watch timer. The air



temperature was a stark contrast from the blistering sunny weather outside - now at a chilly ten degrees (approx.) underground. We sat close to each other for warmth. Richard took in the cold much more than I but refused the offer of my sweatshirt to keep warm.

HOURS PASSED SLOWLY

Our two hours passed slowly and Richard pondered on the fact that there was so much stuff stored down here that we were bound to be picked up by security guards. Thoughts of would we ever make it out alive crossed Richards mind. I thought that this was nonsense and assured Richard that nothing like that would happen - that was too much like conspiracy theory. Still I could understand how Richard was feeling as this was his first trip to a base with me, let alone getting into the fabled underground facilities! This must have been a shock to the system. I must admit that I was quite enjoying the whole thing so I made light of the situation and ribbed Richard about the situation we were in. In the end Richard did make the valid point that I jumped out of my skin when those alarms went off.


Eventually our two hours passed and after hearing many clicks and imagined footsteps we emerged from our hiding place to find out where we were. Having a very good route

off at the end of the Kingston quarry, where did this quarry come out?

We then decided that perhaps the easiest route would be back up the

finding memory I was confident I could find our way back. We got to a main roadway and saw some maps framed on the walls. After studying these maps and photographing them I looked for exits. For the next two hours we walked around tunnels visiting different exits, most of them led to the "Kingston Mineral Quarry". All of the door were alarmed and had infra red sensors on them along with high powered magnetic door locks. I decided that trying to get out of one underground facility into another was not a good idea, for after all the other underground escape route could be blocked

main entrance shaft. We got near it and located the offending infra red devices that we tripped on the way in. They were posted at many locations, so many in fact we wondered *how we hadn't tripped them earlier*. I decided that we had no chance of getting past these and so we had to retreat. Just before we started to attempt to sneak past the devices both myself and Richard quite clearly heard gun shots echoing down the tunnel way. We could differentiate shot gun fire and also semi-automatics rifle fire. This certainly excluded this escape route from being used!

We were stuck now and it seemed like attempt to leave via any exit could mean capture. Just then we found a long sloping staircase that led to the surface. We walked up it slowly and nearly at the top were stopped by an infra red sensor that was registering our presence with a frail yellow light. The light sequence was yellow, amber and red - amber or red would mean alarms going off. We moved very slowly away from this sensor. So yet another escape route was out of the question to use. As we retreated we then heard voices of many people laughing and joking and diesel vehicles moving around past the doorway that we had been attempting to reach. It seemed like we would have walked right into the hands of security, perhaps even into the security guards building, if we had left via this route.

Now we left and started to scour many

parts of the base that we had overlooked in hope of finding other escape routes. By now we had been underground for 5 hours. It was nearing 10 p.m. and we still had no idea of how to leave. In the time we had been down underground we had photographed many areas and had run out of 35mm film. It was at this point that I remembered passing a sign posted exit which did not appear on the underground maps. We decided to have one final look to see if we could get out. Expecting all sorts of alarms and infra red sensors we slowly made our way though the passage that led to the exit way. We were confronted with a metal spiral staircase which was anchored into the rock. Knowing that we were at

least 200ft underground we expected a long climb and we certainly got it.

Finally we reached the top of the stairs and I halted Richard as I spotted some alarms. This seemed like the way out but I could not see any way of passing the alarms without setting them off. Freedom was just one emergency door away. We had no real way of knowing where we would be above ground. We made a run for it setting the alarms off a second time. Bursting though the door into the darkness we were able fairly quickly to adjust to the darkness enough to be able to see our way back to our entry fence. We scaled the fence quickly and jumped. I twisted my ankle when I landed and was then in excruciating pain. Richard ripped the skin on this hand on the barbs.


As we composed ourselves from our less than successful fence hopping attempts behind us we heard gunfire. These were shot guns. We didn't look back to see where the shots were coming from. As we ran I was slowly able to overcome the pain of my ankle a little more which was just as well because to top it all off we then got stampeded by a herd of Friesian cows who were almost trampling us as we ran. That was all we needed! I had to stop running and turn to face the cows and shout at the them to make them turn away. This gave away our location but thankfully we didn't have far to go.

We got in the car and drove away through a route I knew would bypass any major roads. The next day we got


PHOTO: HASTA LA VISTA RUDLOE - LOVE TRUTHSEEKERS!

our photos developed and distributed copies. So quite an exciting day all in all. The follow up to this is that I went up to the guardhouse at Monks Park and was given a cock and bull story about the base being nothing to do with the MOD anymore. As I knew otherwise I kept pushing and in the end got the admission that the base had been sold to a private company that was an MOD contractor and some MOD "stuff" was stored there. This being a classic MOD tactic in these times - to make important facilities seem unused and insignificant they sell them off to agencies or contractors who work with the MOD. The guard seemed to know more than he was saying although one thing he did say that there were entranceways from this base to Rudloe Manor underground facility, but to the best of his knowledge those were sealed up. Unfortunately we didn't see these areas so we don't know if this is true or not (probably not...).

As I and Richard remember the boxes we saw contained possible component parts for weapons and electronics equipment including satellite gear and test equipment.

Following our incursions into this facility perhaps security has been stepped up. I would always warn people against entering bases. It is your own responsibility when you do so. Many people I have spoken to have said that we were foolish to have attempted this but the way I see it is that the lies we have been given regarding RAF Rudloe Manor have given us licence to bend the rules. I don't like liars. As you heard we nearly got shot so this gives you some idea of what to expect if trying to penetrate underground facilities. I guess this day we were lucky.

Lastly like a scene from the X files I couldn't help but think that somewhere in amongst all those hundreds of thousands of boxes there could be a part of a UFO or some secret weapon designed by the MOD. The truth may still be down there!

Recently Matthew Williams took a TV crew from the US TV show Sightings to Rudloe Manor. To illustrate the presence of working underground facilities I took the team to The Corsham Computer Centre.

Matthew Williams was "radio miked" up and got the team ready for a mad run into the area where the bunker entrance starts. Camera team at the ready Matthew gave the word and we rushed down the leafy alleyway and toward the distant bunker. As we got nearer we were surprised to see that nobody had rushed out to stop us from entering. Surprised at this Matthew gave a signal to the team and we continued into the bunker entrance.

Faced now with a thick, bullet-proof glass door we thought that this was the end of the line and I talked to the camera to say that this is probably as far as we would get. Then as if by magic the door bolts retracted and the door started very slowly to open. The beckoning bunker inside Matthew could not resist and led the team into the bunker. What mistake could have been made to let us in, I wondered?

We were now in a hallway with plush carpet and cream and brown walls which led to a reception area. We were underground at this point. Security doors prevented us from going any further into the tunnels. These cylindrical doors were made of toughened glass and were big enough for one person to go into. A person types their number in to a pad and the door opens, then another number is typed in whilst inside the cylinder and if both numbers are correct then access is

given.

As Matthew and crew walked towards this security section, he noticed a window area with security guards happily drinking cups of tea. As Matthew approached one of them greeted him and asked if he could help. Matthew then pointed to the cameras and asked if the guard could tell us anything about UFO research going on at Rudloe Manor.

The guard nearly spat his drink back in its cup and said "Shit, Get 'em!". Two other guards jumped to attention and one ran out and around to the other side of the security doors. He typed his number in and got into the booth and then appeared to have botched the second number up and was then locked in. We watched and the camera crew filmed as he struggled to be freed.

The ISRAEL Alien That Almost Was...

I was recently made aware of a set of events which were taking place in Israel, regarding UFO sightings and an apparent alien creature which was thought to have been left behind after a UFO sighting. The reports started coming in to the UK about Christmas time. One may say that the feel to the story would almost put it on par with a biblical myth - with elements such as the holy land, lights in the sky and things being left behind near stables. OK well perhaps not quite that far!

Still, even if I joke, the press coverage of the story was more jocular to say the least. Even some UFO journals, who were aware of the facts surrounding the case, chose to take a less than favourable line and sided with very unscientific remarks. Some of these remarks were passed around the Reuters news wire service.

The premise to the case was that a set of UFO sightings had sparked interest and then after such a night of sightings a strange creature was found outside the cowshed of an Israeli farmer. He brought various people to see the creature which at the time was still alive. He and many others described it as a green mini humanoid, moving in an erratic fashion.


The chief of police was called and attended the scene and too observed the creature and noted it's strange appearance. Also the farmer and his family noted that the creature had decreased in size considerably since its being found. Nobody was able to identify what the creature could have been - bearing in mind the farmer and his family having seen many indigenous creatures in their time. The chief of police was worried

about the creature escaping. In advance of advice by experts on what do for the creatures well, the chief ordered that the creature should be contained. A bucket was found and placed over the creature to keep it safe. When the bucket was removed the creature became very agitated and started jumping or perhaps "flopping" around. After the media had become involved it seemed as if the creature - which was observed by many witnesses as moving and alive - had now dissolved into a green wax like solution and was no longer recognisable as anything that had been alive.

Yet despite all the above accounts being reported to local journalists and subsequently reports being provided in Israeli newspapers and on TV the western press and media seemed absolutely unable to represent the story properly. Reuters reported that the "alien" was nothing more than cow dung and other sources had put forward that it was an aborted

salamander foetus. All of these reports contained information which was not provided by any first hand witnesses nor people who had analysed the substances. As I mentioned earlier, this sort of sloppy journalism was to then

rub off on the editors of many UFO magazines who chose to copy the comments made by many of the news



wire services. You think that these UFO magazine editors whilst having a specific interest in the subject would have done at least some of their own investigation in order to either bury or uphold the case.

The worst case of media misrepresentation of the incident was on Fortean TV, on UK's Channel 4. This program followed the story as a hype piece whereby paranormal personality Uri Geller had offered to buy the leftover mucus of the creature for one million pounds if it proved to be extraterrestrial. Debbie Segal, one of the original UFO investigators on the case came over to the UK with the substance and

regardless of the offer from Geller had intended to have it analysed at a laboratory. The results came back inconclusive - showing that the object was comprising of elements that could be found on earth, which could mean that it was not extraterrestrial. However the analysis could not prove that the object was not extraterrestrial or terrestrial as no proper analysis of the substance was made to determine exactly what it was. There was also supposed to be some contamination of the samples which hindered the testing process. In addition to this the sparse tests which were carried out could only show carbon and nitrogen levels and no other factors. So how can we be sure that the tests were effective?

On the sensationalist TV programme produced by "Rapido TV" Uri Geller ended up being the main feature of the piece and although Debbie Segal presented all her findings at a lecture at Westminster University under the watchful eye of the British UFO Research Association (BUFORA), to which Fortean TV camera crew attended, the story was still misrepresented. They did not put forward any of Debbie's points on the TV show. All present saw video recordings and heard all the extra information about the creature having been alive and been unrecognised by even the police. Still this didn't stop Fortean TV representing the whole sample as being cow dung and possible salamander foetus - Fortean TV did not get any of this information from the BUFORA lecture, so work that out!?! Will this sort of rubbish tabloid journalism reporting ever get any better?

The next step in the follow up of the story was to have the samples provided to BUFORA and Uri Geller analysed. Unfortunately the only form of analysis to be supplied was of little use. This was undertaken by BUFORA and did little to determine

the samples true nature, just its component quantities of Nitrogen and Carbon. One would think that Uri Geller with his offer of millions to buy "alien artefacts" could not see himself even slightly interested in paying for a better analysis. Never the less on the basis of such a small analysis the scientists at the lab which undertook the test were confident enough to say that the substance was *definitely not extraterrestrial*, even though they could not tell us on their record what it was!

One of the tests which was carried out is supposed to be able to determine which type of star system a material originates from by its atomic signature. It was by this analysis that it was stated that the origin was likely to be that of our solar system via the well known signature. As open minded researchers pointed out, there could easily be thousands of other solar systems similar to ours out there in the depths of space which could give similar signatures. This is not to say that we disregard the analysis but it just goes to show that proper analysis of the substance would have been better than a rough guess signature match - which is not a 100% fit. A valid point I made was that the substance/creature could have originated closer to home - perhaps in our star system - and therefore would have a similar atomic signature.

The £1000 spent on the tests were a very good way to throw BUFORA members money away. Many who found out about the costs of the tests were shocked and later on it was learned that had the BUFORA investigators who were undertaking the tests checked with other BUFORA members then one research department member would have been able to get the tests done for free.

The bottom line is that no real explanation of the substance has yet been given. Debbie Segal went back to Israel, very upset at the analysis. In fact many British UFO Association researchers were not unhappy to see her go because in their opinions she was very hard to get on with. Indeed she was kicked out of one researchers home for apparent obnoxious behaviour of which I heard many rumours. So coupled with trials of getting around not only personality conflicts but an inability to sample materials correctly we are stuck with no answer to this case. What people are quick to forget in this case is that the initial reports of the witnesses are the most credible information we have. We also have a set of UFO sightings which were widely reported in the area and a possible unidentified creature which was associated with the sightings. Without further information from Debbie Segal on extra analysis on the sample, this story may be destined to be filed in "Future Myths & Missed Opportunities" drawer. MW.

New Life Under The Seas

DEEP below the earth lies the Dark World, a place shut off for five million years.

There, like a story from science fiction, live 33 previously unknown species of life.

In an environment devoid of light, all are blind. They live in an atmosphere of hydrogen sulphur that would poison most life on Earth.

There, in the land of the scorpion that breathes through its tail, food comes from an alternative energy source, chemicals in water seeping the rocks.

The blacked-out world was discovered after builders tipped off cave experts ten years ago that something unusual lay below Dobrogea, west of the Black Sea in Romania's Casimcea Valley.

A shaft was sunk when scientists at the Speleological Institute in Bucharest heard the news, and among the experts who went down was biologist Serban Sarbu. 'What we found was the most exciting discovery of my life,' he says.

Experts combing what is now named the Movile Cave discovered new types of spiders, crayfish, snails, beetles and scorpions.

Five million years adapting to a world without light mean that in addition to losing their eyes, their pigment has gone too. AU are a pale yellowish colour.

Their species had somehow arrived underground and never found the need or inclination to leave, remaining sealed from the rest of the world. Only air and water could filter in through tiny fissures in the limestone rocks.

But Dr Sarbu was forced to leave his amazing discoveries behind. He was unable to carry on his research while Romanian dictator Nicolae Ceausescu was in power.

Dr Sarbu moved to America, where he is now installed at the University of Cincinnati. But after the Romanian dictator felt the biologist returned and at last can tell the world of his findings. The previously unknown species, he says, live in "airbells",

bell-shaped underground eaves 3ft high by 3ft wide and 12ft long.

Dr Sarbu goes on: 'All around you is new fauna, dense mats of microbes on the cave walls, spiders creeping above the surface, millipedes hurrying away, bugs swimming past you, the occasional leech.'

'What is exciting is that in this isolated system they have a totally different source of food, using chemosynthesis instead of the above-ground system of photosynthesis (using oxygen to break down organic food material into glucose and protein). Their energy comes not from the sun but from chemicals seeping from the rock.'

'As yet, we have discovered only invertebrates living there. In the absence of sunlight, the microbes at the bottom of the food chain have turned to using hydrogen sulphide to live.' The air in the Movile Cave has 100 times as much CO₂ as the air we breathe, and less than 10 per cent as much oxygen.

THE NEW species include at least two earthworms, three pseudo-scorpions, five spiders, two mites, four pill bugs, three centipedes, a millipede, four primitive insects, five beetles, three roundworms, a flatworm, a leech and a snail.

Some can be seen only through a microscope, others are clearly visible versions of familiar earthbound creatures.

Dr Sarbu goes on: 'All the creatures have lost their eyes, except for one spider. What's neat about the {Lasconia Cristiani} - named after a colleague, a speleologist from

Bucharest - is that when it hatches it has eight eyes, but by the time it is a year old it has lost them all. I Leeches in the cave do not suck blood. 'They eat earthworms, the same as surface relatives that live in lakes,' says Dr Sarbu.

Of all the new species we discovered, the oldest is a kind of water scorpion dated

by DNA as some five million years old. It is one of the most interesting finds. It has no sting in its tail and uses the tail as a snorkel, sticking it out of the water to take in air.'

HE HAS explored caves in America, Italy and Meideo, but Dr Sarbu has never seen anything remotely like this. The nearest he has come to such life forms are m vents in the ocean bed, where hot springs also support life in a chemo-autotrophic ecosystem, but the Movile Cave has a freshwater environment.

Is there an application for the intriguing discovery? Dr Sarbu says: 'I can't say there is anything like bringing something back from the moon that you can turn into non-stick pans or anything like that.'


'But it helps us to understand life in general. We learn there is already a mechanism for adapting to eaves if we had to, and we're seeing how life can develop over five million years for creatures to look like this.'

'Now we're trying to understand how such ecosystems function, how energy has been transferred from one rung of the ladder of life to another.'

Dr Sarbu is currently heading for Panama to tell scientists there about his discoveries. Yesterday he was in Ohio. The day before he was in B- ore, addressing the American Association for the Advancement Science.

Sexual Magic

A temple is a place of worship, a construction wherein God is served and realised. Tantric tradition holds that "God" is one's true Self, the soul, to be worshipped in the Temple of red rivers; here are the sun and the moon, as well as all the holy places of pilgrimage. I have not encountered another Temple as blissful as my own body."

--Saraha Doha

We have all probably heard about sexual magical rites and the fact that sex can be used as a part of a process of gaining power to perform magic. Is there any truth in this. Well certainly there are many groups of magicians or priestesses who would swear by this practice. Still, very few of us like the idea of involving ourselves with a magical procedure. So what is there in this mysterious area which would appear safe? Well, Tantric Sex magic may be one safe form of magic, for it's principles and ideals seem solid and based on good moralistic principles.

Tantric sex practitioners have taken some of their beliefs from books such as "The Kama Sutra" - the good sex guide of the Eastern cultures. The word Tantra, comes from the meaning "Woven-Together". The practice of Tantra involves sex for the purposes of worshipping the male and female principles. To complete the sexual act there are modified and controlled orgasmic responses or restrictions. This then leads the partners to be able to advance on a spiritual level through the control of the energies that are involved in sex.

Tantra was a development of the Hindu Yoga system, which involves meditation, breathing control and posture modifications and exercise.

Why would anyone want to control or modify, or even stop their orgasms, you may ask. The answer would be because modification can lead to different types of orgasm, all as varied in feeling as a natural orgasm. This difference can be exhilarating for the participants. Some forms of modification involve techniques which help the practitioner to achieve states of multiple orgasm or extended orgasm. The act of suppressing the orgasm is seen to be a heightening of mental and spiritual levels or powers, which will become of obvious benefit to those who try to attain these states.

CONNECTION WITH GOD

Perhaps a reason that Tantra persists as a religion despite the persecution of sexuality in most modern civilisations, the reason it arises spontaneously in different eras and places, and the reason that it crosses socio-cultural lines is that it is based upon some neurological hard-wiring of the human body; something which, when practised correctly, allows the participants to experience what seems to be the presence of deity in the sexual partner. I.e. a closeness and connection with GOD.

When Tantra first became known to the West during the last half of the 19th century -- traditional Hindu and Tibetan Buddhist Tantra texts and teachings only emphasised MALE control, because it was only MEN who were supposed to be raising their Kundalini (spiritual energy

seated in the base of the spine) and re-absorbing their sperm into their brains, rather than releasing it. Women were seen as "Shaktis," that is, empowering incarnations of goddesshood who endorsed or validated the male spiritual experience.

Most Tantric gurus up until the end of the late 1970s had stated outright that women need not learn to control their orgasms. Some teachers took a misogynistic viewpoint or that females can't have religious or spiritual experiences anyway, so why bother teaching them... Others took a misogynistic-disguised-as-worshipful viewpoint, in that women are already so holy and sacred that they need learn or do nothing to be spiritual. Some Tantric schools recommended the use of prostitutes as Shaktis, although the British rulers of India tried to put a limit on this form of religious freedom.

Alice Bunker Stockham was, as far as I have been able to determine, the first writer to promote sexual equality in Tantra. That is, she stated that if men will benefit spiritually from learning to control their orgasm response, so will women. This placed her in contradistinction to the Oneida Community approach, where "Male Continence" was practised. "Male Continence," as the name implies, allowed women to have all the orgasms they wanted, while men were expected to restrain themselves.

In describing her methods, one metaphor Stockham used was that of a fountain that fills a basin slowly, drop by drop. The build-up of sexual desire, she believed, continued day by day, filling the basin until it overflowed naturally. The result of the basin overflowing gently is orgasm. If the basin was drained dry through continual orgasmic sex acts before it filled naturally (which she estimated took two weeks to a month), she believed that the drained person would be in a state of "magnetic depletion" during that time.

On this basis Stockham argued that the traditional Hindu technique of draining the woman's basin of sexual desire through allowing her to have an orgasm, while leaving the man's basin full through teaching him Tantric methods of self-restraint, produced a n

inequity that would in time create aversion in the couple.

The man could be represented as being always fully magnetically charged and using the woman as a source of energy and subsequently keeping her drained of all her energies.

Stockham's solution to this problem was to instruct couples to engage in sex whenever they wanted, as often as they wanted, under three conditions:

1) Each sex act should be preceded by some form of spiritual dedication (she recommended writing love letters and making "dates," spending at least an hour before making love away from the children, lighting candles, sharing a glass of wine, and other common adjuncts of romance — up to and including maintaining separate bedrooms so that each sex act would be obviously intentional and not merely a prelude to going to sleep)

2) If they did not want more children, couples should not have orgasms during the woman's fertile time. (Remember, there were no birth control pills or diaphragms when she first wrote — and condoms were illegal.)

3) The accomplishment of orgasm should only occur when it resulted from "overflow" of the basin of desire. How often this happened was left to the discretion of the individuals.

People who have practised Tantric sex know what Stockham was describing as the overflow type of orgasm. It occurs when, after several days of Tantric lovemaking it becomes impossible to distinguish pre-orgasm from orgasm and without any pelvic thrusting on either party's part, both people achieve orgasm together. No techniques exist to bring this condition on, as far as I know; it is simply a by-product of Tantric practices.

RESEARCH

John C. Lilly did research on monkeys in the 1950s (before he got into dolphin brain research). As documented in his book, "The Centre of the Cyclone," he found that there are four points in the mid-brain, arranged

in a row, that control the sexual response of (male) monkeys. The mechanisms are the same in both sexes.

The first neural point in the series regulated arousal (erection). The second point regulated muscular contraction (ejaculation). The third point regulated the orgasm itself (sensation of sexual culmination). The fourth point he called the "master switch," for when it was stimulated, it entrained the three previously-mentioned centres, causing the monkey to experience erection, ejaculation, and orgasm in the usual predictable order.

The discovery of these four neural points in the brain indicates that through conscious and learned control, one can separate orgasm, or erection, or ejaculation from the other responses.

We all have experienced this disassociation of the entertainment centre at one time or another (not always under our conscious volition) as when, for instance, we achieve erection but not orgasm, or have

an "involuntary" ejaculation, or have an "unsatisfying" orgasm in which the contractions are truncated in duration. What Tantra teaches is how to control these things so that one can experience orgasm without contraction, thus prolonging it beyond the biologically-regulated constraint imposed by the amount of time it takes to complete the 8-25 contractions you would normally have.

Where does the experience of spirituality come from? Perhaps it is part of our neurological hard-wiring. Human beings seem to be naturally equipped to experience the metaphysical world. Many ages-old techniques for perceiving the realm of spirit make use of repetition (of hymns, prayers, chants, dances) while engaging in single-minded attentiveness to cosmic forces. Tantra provides both

repetition and attentiveness. It is not the only way to achieve spiritual bliss, as its religious practitioners assert.

PRACTICE

The first thing you have to notice, is what your orgasm reflex is. Just observe it a few times (ten or more times) and pay attention to how it works. Literature suggests this is best done while masturbating, as it could prove distracting to a partner. Especially, notice that there is a brief moment at the onset of orgasm when you are consciously aware that it is about to occur but it has not yet become inevitable. That's where you will later spend your time.

In the typical orgasm (both male and female) there are 8 to 25 muscular contractions (women may have more than men; how many you have will vary

at times). Get to know how many contractions you experience. Now, rather than "suppressing" an orgasm, try to let one or two contractions happen and then relax. If you can learn to let one or two waves of orgasmic contractions occur and then relax (by breathing and being attentive, NOT by trying to think of something else to "distract" yourself), then you can learn to repeat this over and over again. Imagine yourself at the edge of a breaking wave of pleasure, not plunging over the edge.

While you are learning to ride the wave-edge, take turns with your partner. As one of you rides the wave of bliss, the other acts as a "lookout," keeping the wave-rider from falling into the undertow of orgasm-when the wave-rider reaches saturation and relaxes, you trade roles. During the course of one sexual encounter, you may trade roles often. You may also rest (in a semi-detumescent state), and begin again later if you like. When you and your partner become attuned to one another, you will no longer think about who is riding the edge and who is guiding; the roles will blend and mesh and you will both simply "be" there. That is basically the "secret teaching" of Tantra.

SPIRITUAL GOALS

It is stated that the great part of these techniques is that they are not simply a recipe for great sex. Believe it now or not, you will have spiritual feelings while doing this. It is these spiritual feelings that have formed the basis for several sexually-oriented religions and magic cults. When taking part in ritual sex one can perceive that they are in attendance at a temple.

GATE OF BRAHMA

Tan Tains version of Tantra lists nine "gates" to the bodily Temple; these being the anus, the Yoni or Lingam, the mouth, the nose, the two eyes, the two ears, and the "Gate of Brahma." The Gate of Brahma, known in current medical terminology as the "fontanel", is an actual opening, visible at birth, which closes as the baby grows (also known familiarly as the 'soft spot' at the crown of an infant's skull). Eastern tradition holds that the soul enters and leaves the body through the Gate of Brahma. Note should be made that, the number 9 having mystical significance, either the Tantras or those translating them have not been entirely accurate with the 9-gate description. For instance, since the eyes are counted as two gates; so should be the nostrils, rather than naming "the nose" as a single gate. Additionally, Yoginis (females) possess an extra "gate," our urethras being separate from female Yonis; unlike males whose Lingam contains but a single gate used for sexual and urination processes.

Although the bodily Temple may be entered via any gate; it is the Gate of Brahma which some say leads to higher spiritual realisation. This is where the concept of energies passing from the gates of the loins to the head via the spinal cord comes from. In addition however there is supposed to be another energy system at work in addition to the physical and spiritual field and this is known as the Aura, or "Subtle Field". This is where the chakra energies in a body originate. The two things are treated as an important part of the bodies energy flow and it is an ideal requirement that the practitioners of Tantric sex embrace this extra energy and incorporate it into their rituals.

One can choose to combine the use of other gates in the sexual act to balance the energies and control them better. Close contact breathing from one partners nostril to another partners nostril is one method. This then helps the participants to concentrate on their breathing patterns.

The surroundings in which one has sex can affect the experience. A special area in

the house designated for sex would be best created. This can be decorated with soft lines and curves as opposed to hard corners. This is supposed to then mimic the curves of the human form. Drapes can be used to help achieve rounding and softer lighting. Colours are important too as colours have different meanings to the spiritual essence that one should feel inside ones' self. The colours red and purple excite and stimulate the sexual body and mind whilst the colours blue or violet calm and invigorate.

It is not advised that electric light is used during love making because of the electric fields which will have an effect on the subtle magnetic energies which are at play. Instead candles are an excellent substitute, which provide not only soft light but an energy which is conducive to the sexual energy. Open fires are also recommended but not essential.

Objects which have a personal nature to the partners should be placed around the room. If love making is possible outside the home in a natural surrounding then objects such as rocks or wood can be brought home and be used as talismans of your sexual energy.

OUT OF RELIGION

To allow spiritual feelings to evolve without embedding them in a religious context, try looking into your partner's eyes, thinking about the universality of sexual congress among all species, and then extending your awareness out beyond the pair of you to the world and to the cosmos. You may find yourself in what is called by some "the magnetic ocean," a sensation that you are partaking of a universal, ongoing sexual experience that is life itself. If you have no partner, the best way to do these things is to "invoke" a partner. In the Tibetan Tantric practice this imaginary lover is called a "tulpa". Do not imagine that your tulpa is doing whatever it is that you consider "hot" or "sexy;" imagine that your tulpa and you are doing what is described above.

Some people have felt that under certain circumstances the energies of trained persons has been able to manifest the energies of a tulpa so well that the being has become physical. Sometimes the substance of the creative energy is so strong that the tulpa has remained physical permanently and there is one story of a Buddhist temple that has a tulpa which lives inside the temple.

There are some who believe that the energies of sex are what may be causing

physical manifestations of demons and incubi and succubi which may indeed be the basis for the alien abduction scenario. Still there is little physical evidence available to the average person to prove any of this.



SPACE AS A COMPUTER

Telepathic Experiments in Czechoslovakia

By Petr Novak & SIRIUS

It's 4:55 p.m. I realise that I am to be transmitting in five minutes. I relax. Suddenly I see a nun in front of me. The vision seems so real! The nun is holding a prayer book with a cross on it. She doesn't disappear. In the last minute it enters my head to transmit the cross. I leave the nun and concentrate on the transmission of the cross.

I look at the top of the highest pine tree and project the image of the cross onto the bright sky beside it. The cross is massive for a split second and then starts "falling". Again, I manage to project the image onto the sky beside the top of the tree, but soon it falls like before.

The experiment is over. Today I do not expect a positive result, as I didn't see the light contour of the image, which I marked both during the transmission of the triangle on 16th August and the golden-haired fairy on 23rd August. This

luminescence always tells me that the reception is working.

An important remark: it is 7:00 p.m. We are driving through a village in the Giant mountains (Krusné Hory), a place that I know very well. I know that there is no monastery in the area, yet suddenly I behold a real nun standing in front of a cottage, talking to some man. Even if my experiment is not successful this time, I experienced a strong vision that became reality in two hours!"

Kveta Koutna 30.8.1975, Krusné Hory transmitter:

At about 4 p.m. I arrived at Zbraslav near Milevsko. I visited my aunt who is very religious. In her house there are several crosses on the walls as well as pictures with biblical motifs. It creates a very special influence on me.

At 5 p.m. sharp I started to concentrate on Mrs Koutna's transmission. On the following page I state everything I received (see picture).

Vlastimil K., 30.8.1975, Milevsko, receiver:

The above extract is taken from a book by Kveta Koutna (Soubor dokumentů dalkových i mezinárodních myšlenkových přenosů, Praha 1991). It describes the course of a telepathic experiment of information transmission which was not organised by any established scientific institution involved in any research into parapsychology. Few people know that in the period when this kind of research was restricted only to select institutes, Mrs Koutna and her friends organised private telepathic experiments reaching even outside this country.

The experience of these experiments is summarised in the collection Mrs Koutna edited on her own in 1991 in an edition of 100 copies.

The book is rich in material, but it is sold out today, although it would deserve a larger edition and more attention. The conclusions of this book are brief, but they are supported by real evidence.

The members of SIRIUS visited Mrs Koutna two years ago and made the following interview with her, one of the few Mrs Koutna had ever given. The interview was preceded by an incident which shows something of this sensitive woman's perceptiveness. Before the actual interview she said to me: "on Friday evening, I fell into deep thought and felt that there is so much I wish to tell you. Suddenly, the name 'Erik' came into my mind. And I probably said the name aloud. Then I woke up from this state and saw the bewildered face of my husband. Did I say Erik?" I asked him and he replied in the positive. "But the young man (Petr's) name is totally different!" he objected. But I was definitely thinking about you. Do you happen to have a relative abroad?" "Yes, I replied, "my grandfather is German in origin." This is how our interview started.

P.N.: Regarding the conditions of the totalitarian regime, how did you manage to contact and win for example the Japanese experts for your telepathic experiments?

K.K.: During one experiment, a yellow face appeared to me in the corner of the room. I wanted to cry out, but its slanting

eyes calmed me. When the vision gained intensity, the face spoke: "You must go to the ...nese embassy. 'I wasn't able to recognise the hum before the ending '...nese.' Although I asked in English what this was supposed to mean, the face of the yellow man disappeared. After this experience I left the dark chamber for the living room. I concentrated and then transmitted the image of the face into space together with its sentence "You must go to the ...nese embassy." Then I sent out a request: "I want to know what the hum before '...nese' means and I want a prompt reply."

In a very short time I received an unexpected letter from Dr Bayer from Istanbul. He wrote to say that one day, when sitting at his desk, he got into a semi-hypnotic state and started to receive information from space. He was very surprised, because no experiment had been arranged between us at that time. During this state he received the following words in English: "apparent", "significant", "joint" and then the whole expression "very great and clear sight". Beside the received information he also started to draw large pictures of the Sun on the writing paper lying on his desk.

In his letter he asked me for an explanation of what had happened to him when we had not agreed on anything. I immediately wrote him a letter in which I described the revelation of the "yellow man" in the dark chamber. At the same time I thanked him for a spontaneous explanation that the face belonged to a Japanese ... Japan's symbol is the rising Sun! On this occasion I asked him whether he knew of some Japanese person who would be willing to take part in the telepathic experiment between Prague and Tokyo. Shortly after that Dr Bayer sent me the address of Dr Hideo Uchida, a Japanese scientist.

P.N.: Does the long-term or momentary mental state of the participants affect the quality of the experiment in any way?

K.K.: I wouldn't consider this factor that important. What matters more is concentration. You can achieve concentration by carrying out breath exercises some five minutes before the experiment.

P.N.: And what about external influences, e.g. weather?

K.K.: The best transmission is into a blue sky. You concentrate on the object and then you "hang it onto" [transpose] the sky and watch as the white condensed image of the object seems to be falling down. It is very important to concentrate on a thought that will not allow the object to drop to the ground. It is even possible to lift the object higher than the original position by means of such thought, which is the best case. If you are successful in this, the image of the object disperses into the direction of the transmission. A blue sky is indeed best for these experiments, especially when you are a beginner. This does not mean though that telepathic transmission is not possible under deteriorated weather conditions. In a way, it is possible under any conditions, but this requires certain training and much experience.

P.N.: During one of the experiments you used a card on which you had drawn a disc-shaped object resembling a UFO. What made you do this?

K.K.: I don't remember what exactly made me do this, it all arose somewhat spontaneously. But the fact is that the drawing was followed by a real experience, right on the site of the experiment.

P.N.: Can you tell me what exactly happened?

K.K.: I was sitting by the fire, concentrating on the transmission. Fire ionises the environment very well. Suddenly I looked up to the sky and saw some light signals flashing towards the earth from underneath one of the stars. The signals were three strips of light. After a few seconds they disappeared and I calmed down. Simultaneously, a thought arose in my mind: "Be quiet, we are with you...". I felt as if I were becoming some instrument and I knew I would be aided in that experiment. After this short meditation I spotted the signals again. But I felt completely relaxed this time. I held the card and looked at a small pine tree which stood nearby. I vividly recalled the object that was hovering nearby. I didn't have to watch the UFO on the card any more. I felt intense heat and perceived the object clearly. I vaguely recall my husband's bewildered expression. I didn't have time to pay much attention to him though. What I remember clearly is the feeling that accompanied his vision: "You don't have to try so hard today, we are with you..."

P.N.: I know I should have asked this at the very beginning what exactly made you start and improve your experiments with telepathic transmission?

K.K.: As a child I was attracted by all sorts of mysteries and man's extra-sensory abilities. one day I gave it a try.

But the real experiments started after one particular experience. This experience included a vision of some contact..

P.N.: Can you be more specific about this?

K.K.: I was looking out of a window and suddenly I felt very tired. I left the window open, sat down on a chair. I laid my hands on the table and then laid my head on them. Suddenly I got into a state of some half-dream and saw three transparent beings with stunningly beautiful and noble faces drift into the room through the window. One of them was a few inches higher than the other two and I heard it say: "Put it in here, in this part of her brain..." "Why?," came the question from my subconscious. The reply was: "for you to be constantly in contact with us."

After this experience I felt much more inclined to carry out telepathic experiments and perhaps even something more. It gave me the idea of transmitting information aimed at some alien intelligence. I turned to several American institutions that were involved in this subject. I needed at least two persons stationed in different places. In the end, a hundred Americans took part in the experiment at various time intervals. With joined forces we transmitted what we wanted to transmit - the image of the cross. I wrote an article about my experience of this experiment and Dr Leo Sprinkle from the U.S., who studied the experiment closely, replied that my feelings were identical with those of Many Americans during similar contacts.

P.N.: What was the effect of the experiment with the Americans?

K.K.: During the transmission I felt no special effort was necessary. I felt that the Americans were really trying hard. The image of the cross was not falling down from the sky, on the contrary - it was as if it nearly materialised. My thoughts informed me that it was due to the effort of the Americans. The following week we waited if something else would happen and one day, a UFO appeared on the ranch of one of the participants. But the American experts do not consider this sighting to have any connection with our experiment.

P.N.: This looks to me as underestimation from their part.

K.K.: Oh no, it's not necessary to take it personally. I do not take seriously even the fact that two American ladies, participants of our experiment, observed some more flying objects that were

following them.

P.N.: So did your experiments gain some respect with the Americans?

K.K.: Yes, but rather after the second, unsuccessful experiment. After the first one I wrote to Mr Sprinkle that I would like to repeat it. But the second experiment was very tiring for me and I felt that the result would be nil. It seemed to me that the Americans were doing nothing... I confessed this impression to Dr Sprinkle and he admitted that they indeed didn't do this experiment this time. I felt they were testing me in some way...

P. N.: But the experiments continued.

K.K.: Yes, and an interesting thing occurred. During a transmission of a triangle to the U.S., there was a sudden gush of black smoke out of the picture. Then I saw an elegant, fair-haired lady covering her face in shock. I immediately told Mr Sprinkle about this vision. He confirmed that one of the female participants had an experience of some negative force during her reception. Later on I "received" advice that I shouldn't waste my energy and ought to aim the images towards the Moon. The following practice proved that this was really more effective and less exhausting. But this is all a part of another story. As a whole, I can say that these experiments brought a lot of a lot of interesting findings which would be worth documenting. But for this I have neither time nor energy. So perhaps this is for other researchers...

The lives of people who are trying to find knowledge beyond the world of the five senses are never easy. Not only because they have to face misunderstanding on the part of the others, but also because they have to keep struggling to understand themselves - unless they are helped from elsewhere. *Petr Novak*

ISRAELI ARABS MET DEMONS

The Most recent wave of UFO Israeli UFO encounters which began in earnest in February of 1996 with a number of filmed sightings had, by late summer and early autumn taken a turn to the bizarre. The wave can be divided into three categories: 1) Sightings of craft by respected Jews. 2) Jewish witnesses of aliens. 3) Encounters with what could be demons by Israeli Arabs. Israeli journalist Barish Chamish investigates...

First the sightings of UFOs; On October 4, Yediot Ahronot reported that two weeks earlier an Israeli air force helicopter was ordered to chase a UFO sighted by the air traffic control tower at Ben Gurion airport. The army spokesman refused to give details of the incident. The same day, the weekly Yerushalayim reported that Avi Gabai, an aide to Rabbi Kadouri, the most revered spiritual leader of Sephardic Jews, witnessed a flying saucer above the city of Maale Adumim, near Jerusalem. Another witness to the same event, Batya Elav, reported, "Twenty five meters above us we saw two strong lights that stared at us like two eyes. suddenly, two more lights went on and we saw a saucer floating above us without making a sound." Gabai asked Rabbi Kadouri what it all meant and he answered, "Angels are arriving to spy, to witness the affairs of men and if need be, to destroy."

ANGELS ARE ARRIVING TO SPY

He went on to explain that sometimes bad angels are sent to overthrow good ones. Finally, in this category, on October 28, a traffic cop, Asher Avsarah, saw a "huge saucer standing motionless above Kiryat Gat," in the northern Negev Desert. The incident occurred at 5 AM before he began duty. A strong white light shone on his squad car and he and his partner left the vehicle to investigate. "We were scared," he admitted. "The saucer had two small white lights with very strong beams. Suddenly the saucer did circles round and round and the lights were extinguished and re-lit in turns. I noticed that when the saucer stopped turning, the lights stayed on constantly again."

Now Jews see aliens; The following reports were collected from Zman Tel Aviv (Maariv's weekend magazine) and Yediot

Ahronot. It is important to recall, in light of the stories, that these are Israel's two largest and most respected newspapers. Because of the length of the material, the incidents have been paraphrased in places.

On July 29, Udi Barban turned on his bathroom light and it began flickering. A few minutes later the same thing happened in his kitchen. He then joined his wife Semadar in bed. She recalls, "I couldn't sleep. I felt something was watching me. I turned my head toward the wall and almost had a heart attack. I saw a creature glowing at me. His hands were by his side. His eyes were holes with two gentle rays emitted from them. He didn't move or make a sound. His head looked like a big light bulb and it stood on a skinny, long neck. He had a distended grey belly. He was the size of a human being and his finger tips were covered with some kind of material that made it look as if he didn't have fingers. I tried to yell but no sound was emitted. I turned to Udi but he kept sleeping. Then I got another shock. There was another creature on the other side of the bed standing motionless, just staring at me. His hands were grayish brown and a gentle silver light was emitted from his eyes. The communicated with each other in a humming sound. Suddenly there was a strong wind in the room, like someone turned on a fan, and they were gone."

The noise woke up Udi and he grabbed a knife and went looking through the house for a thief. When he returned he saw his wife cowering in the bed "like a frightened little girl."

EYES WERE GLOWING

On August 1, M.S. (name withheld), aged 51, of Alpehi Menashe was reading in bed when strange a spiral of blue, violet and red light entered the room through the window. Within the spiral floated a 60 cm. tall creature. He was bald, his eyes were glowing and the skin was grey. Instead of a nose, he had two nostrils. "I covered my eyes with my hands and when I removed



them, the creature stood beside me. His hands were thin and glued to his body like a soldier. I wasn't terrified, rather I felt frozen. Then my body warmed up like I received an electric shock. My lips felt suddenly prickly and I screamed for help. My father, who slept in the floor below me, heard me and began climbing the stairs. Then, all the lights in the house shut off. My father screamed at me for shutting off the electricity. When he got to my room, the creature was gone."

On September 18, the most publicised incident of all occurred. The saga of 62 year old Yuri Isaacov was related in all the media and even made the headlines of the evening news programs of both television networks. The reason for the excitement

was physical evidence that the retired seaman was, in fact, abducted by aliens and taken on their craft.

At 7:50 in the evening Isaacov walked towards the post office of Upper Nazareth when a giant saucer-shaped craft floated three meters above him. The craft glowed and had antennae projecting from it. In a blink of an eye, he found himself inside the craft, surrounded by metre high beings. The beings were "bald, small, had large eyes, three fingers, big heads and no noses. They spoke in a strange language. I sat like a baby and kept quiet for about an hour until three creatures that looked a bit different arrived. They gave orders to the smaller ones and one of them threw a yellow powder at me. After that I don't remember anything."

Isaacov next found himself in a soccer field near his home. He walked to the police station and reported his experience to inspector, Eli Ben-Anat who later reported, "He wasn't crazy. His clothes were clean but yellow powder covered his arms from the elbow to the hand." The powder was later examined at Haemek Hospital in Afula and at a private laboratory, Krina Shimushit. The first report of the laboratory manager, Mickey Coby was, "The material is composed of 55% aluminium and is very strange." No similar soil exists in the region.

On October 22, two teenage girls, described in Zman Tel Aviv as "serious and believable," sat in a car on a side street not far from Tel Aviv's City Hall at 2 AM. "Suddenly we saw a short man with sloping shoulders approach us. When we saw his face we screamed hysterically. He wasn't a human being. He had an oval face, wore a shiny red vinyl suit and black shirt which covered his neck and hands. He had huge blue eyes in a strange, white socket. I stepped on the accelerator and backed up at full speed. But he followed us either floating or at a very fast run. My

headlights lit up his face so it was always visible to us."

Finally, Arabs meet demons. The Jewish experience in Israel in 1996 was certainly astonishing but it fit into standard world-wide patterns. Saucers were seen by policemen and religious people who had no desire to be UFO

They contrasted with the white colour around them. It was as if he was reading my thoughts and I couldn't take my eyes off his for six seconds. He lifted his right hand and Muhmad pressed on the gas and took off."


On October 19, Khaj Muhmad Jamal Kavah, 45, a Tel Aviv cab driver who lives in the Arab village of Al-Arian met his cousin Ataf Kavah at 6 PM at Mei-Ami Junction to drive to a dinner party. "I saw him and signalled that he wait a moment while I relieved myself first. I heard him say, "Okay" When I was finished I approached the car and saw that Ataf was wearing a shiny suit. I thought to myself, in his whole life Ataf never wore material like that. I bent down to open the door and saw that Ataf wasn't sitting in the driver's seat. I



witnesses. And equally stable people had encounters with the prototypical small grey aliens described by witnesses in dozens of countries.

The Arabs of Israel had very different stories to tell. They did not follow the Jewish pattern and seemed to be unique, also, to international encounters. On September 13, Dr. Harav Ibn Bari, a physician at Hasharon Hospital in Petach Tikvah, was returning from Beersheva by car with his cousin Dudi Muhmad at the wheel. He relates, "After passing the bridge to Tel Aviv at 3:30 AM, I saw strange figure on the opposite side of the road. We did a U-turn stopped the car. The figure came out of the shadows and into the light. He was small and his body colour, light. He lifted his right leg and approached us at terrific speed. He had huge, bulging, round black eyes.

stared over and over but the driver paid no attention to me. Then I saw the weird creature. He had long hair reaching to his shoulders, his nose was enormous like an eggplant, coloured purplish black. I almost had a heart attack. But I regained my senses and began walking backwards towards the highway. My plan was to make a break for the cars if he followed me. But I couldn't run because I felt something holding me in place for fifteen minutes. Then Ataf opened the door and

came out looking totally confused. I shouted at him, "You're not Ataf. What do you want from me?"

Ataf recalls sitting in the car and wondering why it was taking Muhammad so long to get in. He got out of the car and asked him what he was waiting for. He remembers Muhammad yelling, "You're not Ataf. Who are you? Where's the shiny suit you were wearing?"

Since the incident, Muhammad took and passed a polygraph test arranged for him by Maariv. His home has become a pilgrimage centre as dozens of people a day come to hear his story. Included among them are Muslim religious leaders who have concluded that Muhammad met a demon and irritated him by relieving himself in his territory. They say the demons are rising because so many Arabs are straying from their religion.

The next night, October 20, will never be forgotten. Eli Hawald, 33, of a village near Haifa called Kfar Hawald. The tiny village has no electricity and when Eli Hawald went outside at 11:00 PM, all was too clear for him. "Out of nowhere I saw a gigantic green light, the colour of a traffic light, fall out of the sky. I ran into the house, locked the door and watched from the window. When the craft was about ten metres above the ground, the light was dimmed and three figures were 'shot' to the ground in it. I began to shake. They had human-like bodies but because they were 20 metres from my house, I couldn't distinguish their faces, just their colour, which was completely black. They acted oddly. They would fan out, quickly return to one formation and fan out again. I remember two things distinctly. They

reformed after a siren was sounded that resembled puppies crying. And their speed was fantastic, tens of metres in two seconds. At this point, I alerted my wife and children and we escaped through the back door."

Two days later, Jenin was the site of perhaps the most remarkable incident of all. According to Yediot Ahronot reporter Said Badran, a Jenin resident picked up a hitchhiker on the Jenin-Dotan road. A few moments after he sat in the front seat, the driver looked at him and saw his face had become that of a dog with one eye. The driver stopped his car, got out and fainted after he saw the hitchhiker disappear.

Badran concludes, "The incident has become the talk of Jenin. Some of the religious leaders believe that the passenger was a demon who lives in the area. Others believe he is a devil known as The Blind Liar who has returned to presage the arrival of the messiah. The driver is still in shock and is being treated at Jenin Hospital.

The situation, then, in Israel during the Autumn of 1996, is that Jews are experiencing encounters with the small grey aliens well known by UFO students around the world, while the Arabs are either interpreting similar experiences very differently or are, in fact, being pestered by demons.

PALESTINIAN POLICE INVESTIGATE ALIEN KIDNAPPING ATTEMPT

On September 19, the Israeli newsmagazine Yerushalayim reported that the Palestinian Police were investigating their first alien kidnapping.

The event occurred three days before when a young girl, Suha A'nam from the village of Dir Al Awasan near Tulkarem, was rescued by fellow villagers from the clutches of an alien. The Police report states that Suha, a grade ten pupil, was standing on her 2nd floor balcony when suddenly an alien began pulling her left hand. She screamed hysterically, alerting neighbours to the scene just in time to save her. She was taken to Tulkarem

Hospital with scratches to her arm.

A neighbour told the Police that she heard a noise like a helicopter, looked out her window and saw "a whirlpool in the air, spreading ash everywhere" opposite Suha's balcony.

Two other witnesses saw aliens the same week. Six days before, sixteen year old Muhand Faras was walking home from school when he came upon a strange being of a man's size but with a small "root" in the middle of its face. Its skin was coloured "like a frog's," it had two tiny hands with three fingers on each and long fingernails. The alien made a threatening, clawing gesture at Muhand's face, screamed something and "flew to the sky." He does not know where the creature flew because he "was too frightened to look at it anymore and thought it might shoot something dangerous" at him.

Three days later, an engineer, Raid A'anam saw a black creature in the sky just before sundown. He told police investigators that the outline of the flying object was "human with two arms and two legs."

Palestinian Police have since set up ambushes to trap the "intruders" and put an end to the villagers' terror. Needless to say, many villagers believe the Israeli intelligence agency, the Shabak is behind the sightings. When asked why the Israelis would stage such an incident, the villagers answered, "To scare us."






Book Review

THE UNINVITED by NICK POPE Review by Matthew Williams

I was glad to see that finally Mr Pope has got some style introduced into his writing. His latest book effort "The Uninvited" was, in my opinion, 1000% better than Open Skies Closed Minds, which with small sentences and stunted paragraphs read in bits like a Janet and John book.... "John saw the UFO. John was excited. John called to Paul." Etc. Whilst you read the Uninvited you do get taken inside the mind of the author a little more than in the last book and this makes reading far less robotic.

However as one reads on it becomes obvious that what we are reading is not original work. The way that cases are presented smacks of rewrite and reappraisal. This in the most is what this book is about and Nick tells us this much. What Mr Pope has chosen to do is to read about the abduction phenomenon and to review the current theories. Whilst he is very forgiving of what he sees as other peoples failings (when we could be looking at his opinions and ask the same questions) the read is an interesting one, as long as you are not a Ufologist who has heard all these stories before. In short this book then serves well for somebody who is new to the world of UFOs and Aliens.

What worries me here is how can somebody fully appraise such a complicated issue as abductions to the satisfaction of UFO peers, without having been part of the original investigations. One can not read too far into the minds of other authors and one is then left to question the balance of the author who rewrites others works of investigation. One is left in the position of having to judge whether we feel that the portrayal of previous authors and researchers is a fair one.



Mr Pope does tell us that he has done his own research into the alien abduction phenomenon and I get a strong feeling that I know what he is talking about - although the level of his research does not come across in the book. I am prevented by agreement of confidences between myself and Mr Pope not to reveal certain details about the book

which to be quite honest, I think would have made the book a complete and more sincere read if those details were included! The phrase I will use is "Bite the Bullet"

In one section Nick proceeds to patronise the reader with a section of devoted to a hypothetical abduction story which contains elements of most commonly reported abduction scenarios; these then exaggerated. Do we really need 20 pages devoted to "Textbook Abduction" when we could learn as much though reading about the real thing for ourselves? Are we not adult enough to hear about real cases - perhaps for the £15.99 we could even expect some new cases instead of kindergarten chalkboard.

I was rather disappointed and put out at the size of the book. The pages totalled to 313 with about 25 pages of blank interspersed, making an effective 288 readable pages! My favourite blank pages were 150 and 164 - as these really excelled at being... blank. The fonts (typeface) used in the book was rather large which along with the giant margins gives us 220 words per page (approx.) compared to 450 per page (approx.) of a Timothy Good book - a marked difference in value for money!

In balance I would say that if you could pick it up in paperback and cheaper than the RRP it would then represent a good value book, but in hardback - forget it. I do not agree with many of Nicks observations in respect of MOD matters but I quiet liked his outlook on the abduction world. A book only for those who are very new to the subject.

Fairies - Real Encounters With Little People by Janet Bord. Reviewer Malcolm Robinson (SPI)

Ask anyone in the street what they think of Fairies and I'm sure you get a mixed response, from the obvious (!) to the "I don't know". This book presents an absolute wealth of data about Fairies (the wee folk) which when reading it proved a big surprise to this reviewer. I didn't know so many incidents had been recorded and its well done to Janet Bord for finding them. Janet tells us that most often the people who see Fairies, do so most unexpectedly, more so when their mind is blank and they are idly daydreaming. The witness is usually alone, however, if someone else is there, sometimes a parallel vision can be experienced. Folklore states that Fairies are often seen dancing, and Janet speculates that perhaps they are performing some kind of ritual in a similar way to the Witches who for centuries have been seen in the habit of congregating at lonely places at night, that's a fair point.

Also a fair point is when Janet goes on to say that "perhaps" if we were all psychic and not preoccupied with the trivia in our lives, then we would all see Fairies, (and probably other things as well I think- !) What amazes this reviewer is, the constant bright colours that these Fairies wear. The green jacket, the red bobbed hat, the yellow trousers, etc. It would seem that there is no fashion sense in being a Fairy, (mind you, some would say otherwise!). The largest number of Fairy sightings this century have come from Ireland where the Fairy tradition has lingered

longest. One of the more recent sightings of a Fairy, was in the early 1990's in the Aran islands off Donegal. 15 year old Brian Colm witnessed 2 little men about 3 and a half feet tall dressed in green with brown boots who were laughing and tiking in Irish. The surprising thing about this book that I found, was the fact that not only do we have reports of Fairies seen outdoors, but there are many reports of Fairies seen indoors as well hich I found most remarkable. But wait, there's more, what about a Fairy car, a Fairy boat, a Fairy plane. Yes all this is described in detail within this book.

Probably the most remarkable tale to be told, is the story which concerns one "wee man" about 18 inches high being torn to shreds by two dogs. This case is from - America, and apparently he was dark green in colour and had normal internal human organs, as was seen by his ripped body. The following day, there was no one to be seen at the site of this incident. Most sightings of Fairies are seen by children, we are told, but there are of course sightings by adults, some of which are given in the book. One of the more interesting chapters, particularly to this reviewer, was the chapter devoted to UFOs and their occupants, which in some cases Janet tells us, are very reminiscent to Fairy accounts. Janets' own speculations are that "some " of the little people "might" be real and that they live in another world which exists parallel to ours (Mmmm).

I for one never expected this book to rise above a dozen or so Fairy cases, but what I found was a multitude of cases concerning reports of little people from different parts of the world (though the majority featured in this book came from the British Isles). There is no doubt about it this HAS to be a classic of its kind, for a study book of this nature, and I take my hat off to Janet Bord for a thoroughly interesting and thought-provoking book. This has opened up my eyes to the subject of small "fairy entity" reports, and I would suggest that you purchase this book, sit down with a glass of wine, and enter the domain of the little people. Yes, a thoroughly entertaining book.

A MEMORY OF THE FUTURE by DENIS A J HOLWILL


This 56 page A5 book is a culmination of information that the author himself presents at lectures and to the media. Whilst many of these theories have been expounded before and in more detail than is presented in this book I would say that the concepts presented here are a good beginners overview to the research presented as "facts" by the new age researchers. I would reckon many of the sources for the presented information as G Hancock & R Bauval, Jaques Valee, E Von-Daniken, Zacharia Sitchin and Alan Alford to name but a few.

As an introduction and modestly priced at £3.50 (inc. P&P) each you have very little to lose and this type of mini-book It is the type of book I often keep handy to lend to your friends for them to digest in small chunks; Gods Of The New Millennium being a nightmare size read for any

normal sceptical neighbour.

In my brief read-through of the book I had only one point which I was wondering about the significance of. The author says that there is amazing accuracy in the way the pyramids were lined up on 30 degrees on both latitude and longitude. I cannot see how the pre Egyptians would have known that Greenwich Observatory would happen to be picked in 1884 for the point for zero degree longitude (east/west). Arguably the latitude (north/south) mystery of accuracy to 30 degrees does ask questions. The point I would have preferred to make is did modern men make the zero degree longitude Greenwich to serve a higher plan - one known only to secret societies such as the masons, (who control most of the western world) who indeed have great interests in the Pyramids. The author did not make this point.



Having read many things about the formation of the SETI project and the difficulties that it had in its implementation and its funding I thought this film was a perfect representation of the problems that it faced. The first I heard of the story Contact was two years ago when I was half way through a book by the eminent physicist Michio Kaku, originator of the quantum superstring theory. I remember that Kaku had had a call from Carl Sagan (SETI scientist) and had been asked how it was



physically possible to travel from one place in the universe to the other without the effects that took place due to time dilation and special relativity. Kaku told him that it would be physically possible to create a wormhole with enough energy, to rip a hole in space so that point a to point b would be near instantaneous in travel time (and outside space-time effectively).

I was so moved by the film! Although I thought MIB was a great flick, this walked all over it for style and effect. Although somewhat long-winded in many respects it told the story of one person, played by Jodie Foster, who

although had a very scientific outlook on the world and didn't believe in G-D only in science, still had a faith of her own in extraterrestrials. This was not apparent until the end of the film when although there was a hearing to show that there was no evidence of contact Jodie Foster could not deny what she had experienced. The powers that be in the senate committee were trying to put it down to hallucinations and hoaxes and all the normal stuff in order to debunk what she claimed had happened to her. Of course they knew what the real story was and there was a suppression of evidence by them.

Remind you of something happening now? The moral of the story according to

Carl Sagan was that we still weren't ready for contact. Until our faith in ET can depose people who would lead us into a state of fear and military panic and rash reaction then we are not ready for contact. This seems like a truism if ever there was one, if ET wanted to destroy us we would be dead, simple as that, no government action in the world will save us.

There is a certain irony in the fact that it wasn't mainstream science in the film that had the

courage of their convictions and looked for extraterrestrial life. It was one solitary person. This can be paralleled with the

formation of the SETI project in the first place. It wasn't the scientific community that got the project off of the ground but lone rebel scientists working at home in their garages on radio receivers and probable frequencies. Several times things were found and thought to be anomalous.

Recently at my university graduation ceremony, the lady that discovered pulsars, Jocelyn something or other was given the title of honorary doctor of the university. The chancellor muttered something about how she had written LGM (Little Green Men) on the sheet of paper with the results and how 'lucky' it was that there was a rational explanation. She had in fact discovered pulsars.

Similarly enough in 1977 a university student wrote WOW on the results sheet of an unexplained blip, which never reappeared. This is probably the closest we have got to alien life with the SETI project.

I would recommend this film to all that want to be entertained and just let their hair down and their imagination take over. Not one to miss. *R.Conway.*



The Death Of Phil Schnieder

A letter to Truthseekers by Cynthia Schnieder

IN PREVIOUS EDITIONS OF TRUTHSEEKERS MAGAZINE WE HAVE COVERED THE STORY OF PHIL SCHNIEDER AND HIS MYSTERIOUS DEATH. WE LET HIS WIFE TAKE UP THE SHOCKING STORY.

Dear Matthew Williams:

It is wonderful to have you (as well as many others) reach out to me about Philip Schneider's murder. I have a lot of information to share with others. I can give you more details about Philip, his work, the work of his father, Oscar Schneider, Capt. United States Navy, M.D.

On 1/17/1996, Philip's decomposing body was discovered in his apartment in Wilsonville, Oregon (Clackamas County). From the bits of information I have been able to gather, I believe he actually died 1/11/96. My material will go into more details. The sheriff who investigated his death sent for the coroner, but the coroner and his assistant DID NOT come to Philip's apartment that night. The sheriff decided that his death was a stroke, was natural, and I instructed them to move his body to a funeral home in Portland, Oregon (Multnomah County). The county changes are important to this story, because each county has jurisdiction over themselves and they do not work together well. The next day I went to the funeral home and talked with the funeral director, indicating I wanted to see his body but the director suggested against it due to the decomposition. I was worried that he had not died of natural causes, and might even have a bullet wound to his head. I guess that caused the funeral home director to take a closer look, because that night I got a call from the Sheriff's office that Philip's body had "something wrong with his neck" and was being taken to the Medical Examiner's office in Portland.

The next day I met the Clackamas County Sheriff at Philip's apartment, and they gave me the results of his autopsy. Philip had a catheter rubber tubing wrapped tightly around his neck, and from the Medical Examiner's office it had been determined that Philip had killed himself - he had COMMITTED SUICIDE. At that point I knew in my heart that Philip had been murdered and it had been made to look like a suicide. Anyone in the business of whistle blowing on the government knows who it usually ends, in murder by suicide. Thus, the police are not looking for any murderers, they have closed their case. In the autopsy, blood and urine samples were taken, and the ME told me she would keep the samples for 1 year so that I could cremate Philip's body. It was a hard decision, but finances dictated the decision. After about 11 months I had raised enough money to conduct tests on the samples, and arranged for a laboratory to receive the samples from the ME's office. When I contacted the ME's office, however, the samples were GONE!

A day after Philip's body was found, I went into his apartment and tried to find some items that I knew he used in his lectures, books, metal specimens, large laminated photographs, notes for a book he was going to write. All of it was missing. Telling the truth is deadly. What little I did find I immediately transferred to my home and made arrangements to transfer it to a friend of Philip's, Al Beilek and Mark Ruffener. As I was transferring the suitcases to these people a black military helicopter flew over my home and hovered, looking at the license plates and observing the people. Later, my garage was broken into and my home was also, and photos were taken from a photo album. This is serious stuff, and I have to admit that it scares me. I am a single parent now with two young children. I am all they have now, my daughter is 9, her name is Marie Bernadette Schneider, and her father loved her very much. I did not realise how much until I started contacting friends of Philip's after his death. I also have a son, Michael Philip Jesse Moreci, and Philip was his godfather. When we talk about the death of Philip, we are not only talking about the murder of an individual, but the murder of a FAMILY!!

Until people actually started asking about Philip Schneider, my ex-husband, I didn't realise just how much of our lives together had been so "unusual" and spiritual. Again I can only relate to you information from my memories about what Philip told me, as he is deceased, but what I do remember has all the topics of several X-File movies. As I have heard tell, Fact can be stranger than Fiction.

DUMB BASES

Philip conducted work for Morrison-Knudsen, a company that has had many military contracts. I have social security records on Philip's work history that proves that he had at last two projects with Morrison-Knudsen and one with the U.S. Navy. Philip was a structural engineer specialising in explosives and their impact on rocks. He stated in a lecture that he was in Dulce, NM during the alien fire-fight in which many US citizens gave up their lives, and where he received a large wound to his chest. There has been much debate about his involvement with this particular project, and that he may have been synthesising information from others. However, many facts and information he gave to me BEFORE he started lecturing, have been shown to be truthful information when compared to books that have been published AFTER he started lecturing, such as one book on Underground Mountain Bases. He also talked about an underground shuttle system that connects all of the Dumb bases and the underground tunnelling equipment used to create them. These systems and equipment have been verified by others. However, he states that he never travelled in any of them, which leads me to believe that he is being truthful about seeing them. My feeling is, if you are going to lie about something like this, why not go whole hog and say you have ridden in one.

I remember Philip telling me (before his lecturing tours) about going into a hole created by one of his blasts, and finding a cave already being used by aliens (this may have been Dulce, but he never stated where this had been).

He was confronted by tall aliens (I don't have in my memories a full description) and there was a "vat" of some sort filled with what he believed to be human parts and blood. A fight with guns ensued and the vat was spilled over. It smelled very bad. Apparently some alien species are sensitive to ammonia, so he urinated into his hard hat and threw it on one of the aliens. It killed it. He was then blasted by another alien with what he stated to be a "cobalt" gun, and the radiation from that is what gave him cancer. (He never stated that this is where he got his injury to his chest).

I can verify that Philip did have TUMORS in his legs in June, 1996, and that they were multiple tumours in both of his upper thighs. These were removed that same month leaving long vertical scars on his thighs (some people have tried to say that Philip self-mutilated himself, but I know for a fact that these scars were from the removal of tumours). I can not say, however, whether these tumours were cancerous, but they were fast growing. It is interesting to note that several years later, after Philip related this story to me, a T.V. program called "War of the Worlds" came out and one of the episodes also indicated that aliens were super sensitive to ammonia. Fact or Fiction?

ATLANTIAN GUIDE - HALL OF RECORDS - GOLDEN SCROLLS

Philip related to me about "vivid dreams" that he would have. An elderly man in a flowing white robe would come to him and show him the "hall of records" in Atlantis. There were golden scrolls there where he could see

information known to the ancients, the past, present, and future. He saw futuristic/ancient (as they seemed to be both) houses and flying craft and boats. Philip was an artist and drew two pictures. I have a small one on my wall of a "mushroom" shaped home set in a hill side. My daughter, Marie, has a large drawing of a boat, with unusual sides and shape, very futuristic.

The guide on the tour of these records was always trying to "enlighten" Philip in laws, meditation techniques and morals, as well as items. Philip always thought of himself as an "old soul", a "warrior", a "lone wolf", and a "wanderer". Perhaps these terms will mean something to the readers of this article. What is your interpretation of them? These dreams were always very positive and beneficial, and he told me during the last 2 years of his life that he had learned how to travel anywhere in time he wanted. I believe this is termed "remote viewing".

STAR FIGHTS

Philip also had "vivid" 3-D dreams of fighting on a "red" planet with "several" moons (I can't remember how many). He was fighting an alien race, "the bad aliens", who were at war with the "good aliens". I asked him once who the good and bad aliens came from. He said the aliens from Draco and Beta Reticuli were bad. The ones from the Pleiades were good. The Draco's had power over the Beta (greys), and they had joined forces against the Pleiades (who apparently looked like us). His dreams were very "real" physically. When we were still married and waking up from sleep I could see that Philip was upset. He told me about his "dream" of fighting on the planet and described in detail the planet (sorry, my memory fails me on the details now) and what the aliens looked like and the weapon they had. I could tell that he "felt" like he had actually been there. In his dream he is actually "shot" by some type of ray gun and is starting to die, when he "woke" up in bed with me. His facial features seemed to tell of a "bad nights sleep" and was still full of emotion.. When he got up to go to the bathroom, the bed on his side was literally soaked in bright red BLOOD. I screamed....Well, after the shock wore off, I examined Philip's body very carefully. Luckily, there was no outward sign of any cuts, and when he urinated there was no blood in his urine. I pulled the bed sheets off his bed and stomped on them in the bathtub. Believe me, it was REAL blood, and lots of it. His dream had become a physical reality.

A few months before Philip's death, he related another such dream to me of a fight with aliens. In this one he talked about how one alien got him around the neck with a wire weapon but he had fallen hard against the ground, dislodged the weapon, and had killed the alien. He then woke up. Philip was not wearing a shirt when he had come out of his bedroom while visiting him at his apartment with my children. This was not so unusual, as he often slept naked during our marriage. What I saw, however, after he detailed this dream, was again really physical evidence. He had what looked like a "wire burn" where something had been held around his neck, but it was only visible in the back part (an area Philip could not see), and there was a large bruise on the back side of his right shoulder!

After Philip's murder I wondered if he was not caught up in some "dreamscape" experiment by the government, or if these were something else.

IMPLANTED

Philip was really upset when he told me he thought he had been implanted by aliens (in conjunction with the government). He stated he had missing time, but gave me no other details, and I'm not sure he had any memories. He had examined his body after the missing time and found a "zit" like sore on his leg that had not healed for the last couple of weeks. So, he went to a doctor to have the "zit" looked at. The doctor felt something in his leg, so he decided to open it and "extract" what he thought would be liquid. Instead there were 7 "pinkish" crystals in this tiny "zit", and he laid them on a tray by Philip. He made some excuse about having to make a phone call, and Philip became suspicious that the Dr. was making a call to "government" personnel over the unusual nature of these "implants". Anyways, he "accidentally" knocked the tray over, scattering the crystals all over the floor, and quietly pocketed one of them without the Dr. noticing. When he showed me this minute thing it had a definite crystal form, and was very hard. I could scratch the glass container Philip had placed it in. Looking in the Mineralogy books Philip had in his apartment, and using my own experience with crystallography (I have a B.S. in Geology) we determined that this was an unknown crystal form and shape. I am unable to locate this crystal from his apartment after his murder, so I can assume that it is just one more item "missing", that has been "reclaimed" by the government.

EXTRA INFORMATION GLEANED FROM THE INTERNET

Philip Schneider's life was certainly as controversial as his death. Born on April 23, 1947 at Bethesda Navy Hospital.

Al Pratt suspected something was wrong with his friend Philip Schneider. For several days in a row, Al had gone to Philip's apartment, in Willsonville, Oregon, saw his car in the parking lot, but received no answer at the door. Finally, on January 17th, 1996, Al Pratt, along with the manager of the Autumn Park Apartments and a detective from the Clackamas County Sheriff's office entered the apartment. Inside, they found the body of Philip Schneider. Apparently he had been dead for 5 to 7 days. The Clackamas County Coroner's office initially attributed Philip Schneider's death to a stroke. However, in the following days disturbing details about his death began to surface, leading some to believe that Philip Schneider had not died from a stroke, but had in fact been murdered.

After the initial cause of Philip's death was listed as a stroke, Cynthia asked to see the body before it was to be prepared for cremation. She was dissuaded by the funeral

director who felt that the body's advanced state of decomposition would be too traumatic. However, she could not shake the feeling that something was wrong. The next day Cynthia was contacted by Detective Randy Harris who said that "something was wrong" - that there were marks on Philip's neck. Philip Schneider's body was removed from the funeral home and autopsied by Dr. Karen Gunson, Medical Examiner for Multnomah County, Oregon.

The autopsy revealed that Philip had in fact died as a result of having a rubber hose wrapped three times, tightly around his neck and tied in a knot. The conclusion from the autopsy was that he had committed suicide. He had wrapped the tubing around his neck, tied it in a knot, blocked the flow of blood to his head, became unconscious and finally died.

More surprising was Cynthia's discovery that Philip's lecture material, unknown metals, military photographs, and all notes for his unwritten book on UFOs were missing from his apartment. However, money and other valuables were left untouched.

When he was found in his apartment, Philip's body was in an unusual position. His feet were under the bed, his head was in a wheelchair seat, at an unusual angle, the rest of his body was on the floor, hands by his sides. There was blood found on the floor near the wheelchair, but no blood was found on the wheelchair. There were no apparent wounds on Philip's body to account for the blood. No sample of the blood was taken due to the initial belief that Philip had died of natural causes. No suicide note has ever been found. In fact, Mark Rufener, a long time friend of Philip said, "I saw Philip the weekend of January 6 and 7th 1996. We were going to buy land in Colorado. We were excited because he was going to hire me to help write a book about his knowledge on UFOs and aliens, the One World Government, and the Black Budget. He did not commit suicide, he was murdered and it was made to look like a suicide."

One of Philip's more amazing stories was his father's alleged involvement with the "Philadelphia Experiment." When Philip's father, Captain Oscar Schneider (Navy Medical Corp.) died in 1993, Philip discovered original letters in his basement. According to Philip, the letters were evidence that the Philadelphia Experiment actually existed, and that Oscar Schneider had been a participant in it after the crew members had been quarantined in a Virginia psychiatric ward. Captain Schneider supposedly autopsied the bodies of the crew members as they died, and found alien implants in their arms, legs, behind their eyes, and deep inside their brains. Captain Schneider was confused by these implants, so they obviously were not military. They had to have been alien in nature, and the small "transistor" like item was discovered before transistors had been invented. Here was evidence that either by accident, or on purpose, aliens were involved with the Philadelphia Experiment, and were probably responsible for its failure.

Also discovered in Oscar's basement were photographs taken during Operation Crossroads, in which a nuclear

device was used on Bikini Island. Authentic military photos taken from an airplane showed UFOs raising up from the lagoon and flying through the mushroom cloud. These photos however, mysteriously disappeared from Philip's apartment at the time of his death.

Some investigators in Philip Schneider's mysterious death have had problems believing some of the incredible claims he made before he died. Even those who knew Philip when he was alive didn't always accept the validity of his stories. Cynthia Schneider noted that when Philip was under crisis or pressure, he would tell people that he had been arrested, or that people from the sheriff's office or government had been at his door. This was the way he expressed his crisis. Unfortunately she claims, sometimes it was true. Like "the little boy who cried wolf," his friends became numb to his reports.

Despite the fact that Philip's claims seemed too wild or disturbing to be true, he obviously believed in what he was saying. Philip claimed that his life was in danger because he was revealing the truth, a truth that some would kill to keep secret. He borrowed a gun from his friend Ron Utella, stating that he felt he needed protection and that there had been several attempts to have his car run off the road. In the end, though, Philip's safeguards were not enough to save his life. On either January 10 or 11, 1996, Philip Schneider died under mysterious circumstances.

When he was alive, Philip enjoyed eating out at the 76 Truck Stop in Aurora, Oregon. A waitress named Donna remembered his stops when they would talk about his work. Philip mentioned to her that there had been 19 attempts to stop him from talking. Donna states that Philip said "If they ever say that I have committed suicide, you will know that I have been murdered." She said that Philip believed he had a mission to talk about a government cover-up about aliens and UFOs, and that there were forces out to stop people who talked.

Was Philip Schneider murdered? His ex-wife Cynthia believes this to be the case. She thinks that Philip was met by someone he knew and injected with a drug in order to incapacitate him. The assailants then wrapped the rubber hose around his neck, asphyxiating him. In fact, shortly after Philip's death, several friends told Cynthia that they had seen Philip with an unknown blond woman several weeks before he died. During the course of the meeting, Cynthia noticed a long-haired blond woman in a car, watching the meeting through the window with a pair of binoculars. When they tried to approach the car, the woman quickly sped away. Cynthia later traced the license plate number and it turned out to be from a truck, with the plate reported as stolen. Cynthia thinks the reports of a blond haired woman is significant because Cynthia's mother, through a channelling session, had told her that a woman wearing a blond wig was involved in Philip's death.

Despite the fact that officials have closed the case as a suicide, and Philip's surviving siblings have tried to persuade Cynthia to accept the ruling, Cynthia has not persisted in her efforts to discover the truth in her ex-husband's death. She says that she knows in her heart and

soul that Philip would not have committed suicide willingly, and she still hopes that Philip's blood and urine can be relocated by the Multnomah County Medical Examiner's Office and examined for traces of drugs that would not normally be there. However, as the days go by the reality for such tests grows smaller. She still hopes that someone will come forward with pertinent information to help her find justice for Philip's death.

Until that time comes, Cynthia Drayer will continue her task, perhaps putting her own safety at risk. That prospect doesn't frighten her anymore, "I just want people to know the truth about Philip Schneider, a person who died trying to expose the difficult truths of this world."
