



UPDATE

In last months edition we heard about Mexico UFO video footage of Winter 1997 which shows a saucer flying behind an construction building. We can now confirm that extra witnesses have verified this footage. Initially some found reason to doubt the footage because of its apparent anonymous source. Now not only the source is verified but these two extra witnesses have come forward to say they were in close proximity to the same filmed UFO and one claims that they suffered skin burns from close proximity to the object.

OIL PLATFORM IN GULF OF MEXICO NEAR TEXAS

Jeremy Clark Packer, a 32 year old engineer reports a UFO sighting on a Monday morning in late December 1997, from an oil drilling platform in the Gulf of Mexico 30 miles from Corpus Christi, Texas. Jeremy reports: " Out of the West we saw what looked to be about 25-30 Helicopters on manoeuvres...not an uncommon sight. What was uncommon was that the rig commander came up and told us he had no alerts to any military manoeuvres from the coast guard that day. Suddenly, something very large surfaced beneath them. It was a huge metal object about the size of our platform! It just came straight out of the water and straight into the air!

It hovered over the helicopters for about two minutes. Enough for us to use the telescopes to check it out! It was as large as about two football fields, concave underneath with four large bulbous domes in the concave part of the bottom of it. It turned on its side and we saw that it looked like a huge flying cigar, which was tapered at both ends. On the top of the thing was another concave indent that had lights circling within it. Every colour you could possibly imagine! It was beautiful, then it was gone. Photographs were taken of the object, our watches showed 30 minutes at about the time the sighting took place. The day was cold and windy.

ARIZONA UFOS CAUSE STIR

Tom King reports multiple UFO sightings over three large cities in Arizona. The new flap began Sunday afternoon, January 11, 1998, when residents of Phoenix (the state capital), reported spotting "three shiny silvery objects flying at a high altitude" above the city. That night, at 9 p.m., a TV station in Tucson (population 405,390), a large city 117 Southeast of Phoenix, aired an amateur videotape showing "a large bright orange glowing UFO" flying near Mount Lemmon and Spencer Canyon north of the city. The news broadcast described it as "a possible campfire." According to Tom King, director of Arizona Skywatch, park rangers investigated the event "and found nothing."

On Monday, January 12, 1997, at 12:30 a.m., witnesses in Mesa, Arizona (population 288,091), a city 19 miles east of Phoenix, "saw the strange orange object. It brightened and dimmed several times," King reported. "It split in two and headed in formation towards Phoenix" at "three times the speed of any normal military aircraft." The object's estimated speed was about 1,800 miles per hour. On Wednesday, January 14, 1998, at 10 p.m., Arizona Skywatch received calls from several residents in the Broadway Road/Southern Avenue section of Phoenix. They reported videotaping "mysterious orange lights" over the South Mountains, scene of the big UFO flap on March 13, 1997. King said his group has "obtained the schedule of military flare drops" and will compare these times with the UFO reports. On Thursday, January 15, 1998, at 10 p.m., witnesses in Phoenix and the city of Casa Grande (population 19,082) about 40 miles (64 kilometres) to the south reported seeing "three glowing objects with slight pulsating motions" over the nearby desert.

Robert Michael states, "I was driving up past Casa Grande on January 18, 1998, and observed objects to the west as I pulled off onto Route 387, north of Casa Grande. At that point, I counted 9 and up to 11 Orange Globes strung out all the way from west to east, north of my position over Phoenix. You could see the normal Phoenix air traffic between these lights: I had Bushnell Binoculars on these Orbs and at times I could make out some sort of Disc structure on one or two of them. I was getting a lot of atmospheric diffraction effects from the lights. This short wavelength cohesive type visible light scatters very well in the Phoenix polluted air: Observation times were from 7:25 to 7:55 PM MST: Two Orbs were still visible as I left observation point. I'm sure there is much more to come and there should be lots of good video of this mass sighting.

CONTROVERSY OVER MEXICO FOOTAGE RAGES

The August 6th 1997 Mexico City UFO footage (previously covered in Truthseekers) has created a lot of controversy within Ufology. Unofficial copies became available after it was shown on Mexican TV during September 1997, when it was aired on '3rd Millennium' hosted by the well known investigative journalist and Ufologist Jaime Maussan. Soon after it was put on the Internet and that's where it all started.

A recent article by Graham Birdsall in 'UFO Magazine' is very sceptical of the footage, implying that the UFO seen on it is computer generated. Whilst an article in 'Alien Encounters' by journalist Tim Coleman claims that the footage is most likely real, ruling out any possibility that it is a computer generated image. Unlike Graham, Tim has been to Mexico and has had the opportunity to view a first generation copy of the video and interview Jaime Maussan in depth about it. In his article it stated that Jaime Maussan now knows the person who took the video. The reason for his anonymity being that he is an illegal immigrant working in Mexico! Of the 11 eyewitnesses so far located (at the time of the article), one of them was a 14 year old girl who witnessed the UFO from the street below where she was selling Tacos. Some of the witnesses have also reported irritation caused by being in close vicinity to the object.

We at Truthseekers have been very impressed with the footage, even in it's quality from the Internet site that digitised it off the TV clip shown in Mexico. Our impression of it is that it looks genuine, time will only tell. We will give a full report on this footage as Chris Fowler will be attending a special lecture on this video given by Jaime Maussan at the annual Gulf Breeze UFO conference in March.

ECHELON REPORT TO BE TABLED IN EUROPEAN PARLIAMENT

A GLOBAL electronic spy network that can eavesdrop on every telephone, email and telex communication around the world will be officially acknowledged for the first time in a European Commission report to be delivered this week. The report - Assessing the Technologies of Political Control - was commissioned last year by the Civil Liberties Committee of the European Parliament. It

contains details of a network of American-controlled intelligence stations on British soil and around the world, that "routinely and indiscriminately" monitor countless phone, fax and email messages. It states: "Within Europe all email telephone and fax communications are routinely intercepted by the United States National Security Agency transferring all target information from the European mainland via the strategic hub of London then by satellite to Fort Meade in Maryland via the crucial hub at Menwith Hill in the North York moors in the UK."

The report confirms for the first time the existence of the secretive ECHELON system. Until now, evidence of such astounding technology has been patchy and anecdotal. But the report - to be discussed on Thursday by the committee of the office of Science and Technology Assessment in Luxembourg - confirms that the citizens of Britain and other European states are subject to an intensity of surveillance far in excess of that imagined by most parliaments. Its findings are certain to excite the concern of MEPs. "The ECHELON system forms part of the UKUSA system (see 'Cooking up a charter for snooping') but unlike many of the electronic spy systems developed during the Cold War, ECHELON is designed primarily for non-military targets: governments, organisations and businesses in virtually every country.

"The ECHELON system works by indiscriminately intercepting very large quantities of communications and then siphoning out what is valuable using artificial intelligence aids like MEMEX to find key words". According to the report, ECHELON uses a number of national dictionaries containing key words of interest to each country. For more than a decade, former agents of US, British, Canadian and New Zealand national security agencies have claimed that the monitoring of electronic communications has become endemic throughout the world.

Rumours have circulated that new technologies have been developed which have the capability to search most of the world's telex, fax and email networks for "key words". Phone calls, they claim, can be automatically analysed for key words. Former signals intelligence operatives have claimed that spy bases controlled by America have the ability to search nearly all data communications for key words. They claim that ECHELON automatically analyses most email messaging for "precursor" data which assists intelligence agencies to determine targets.

According to former Canadian Security Establishment agent Mike Frost, a voice recognition system called Oratory has been

used for some years to intercept diplomatic calls. The driving force behind the report is Glyn Ford, Labour MEP for Greater Manchester East. He believes that the report is crucial to the future of civil liberties in Europe. "In the civil liberties committee we spend a great deal of time debating issues such as free movement, immigration and drugs. Technology always sits at the centre of these discussions. There are times in history when technology helps democratise, and times when it helps centralise. This is a time of centralisation. The justice and home affairs pillar of Europe has become more powerful without a corresponding strengthening of civil liberties."

The report recommends a variety of measures for dealing with the increasing power of the technologies of surveillance being used at Menwith Hill and other centres. It bluntly advises: "The European Parliament should reject proposals from the United States for making private messages via the global communications network (Internet) accessible to US intelligence agencies."

The report also urges a fundamental review of the involvement of the American NSA (National Security Agency) in Europe, suggesting that their activities be either scaled down, or become more open and accountable. Such concerns have been privately expressed by governments and MEPs since the Cold War, but surveillance has continued to expand. US intelligence activity in Britain has enjoyed a steady growth throughout the past two decades. The principal motivation for this rush of development is the US interest in commercial espionage.

In the Fifties, during the development of the "special relationship" between America and Britain, one US institution was singled out for special attention. The NSA, the world's biggest and most powerful signals intelligence organisation, received approval to set up a network of spy stations throughout Britain. Their role was to provide military, diplomatic and economic intelligence by intercepting communications from throughout the Northern Hemisphere. The NSA is one of the shadowiest of the US intelligence agencies. Until a few years ago, its existence was a secret and its charter and any mention of its duties are still classified.

However, it does have a Web site (www.nsa.gov:8080) in which it describes itself as being responsible for the signals intelligence and communications security activities of the US government. One of its bases, Menwith Hill, was to become the biggest spy station in the world. Its ears - known as radomes - are capable of listening in to vast chunks of the communications

spectrum throughout Europe and the old Soviet Union. In its first decade the base sucked data from cables and microwave links running through a nearby Post Office tower, but the communications revolutions of the Seventies and Eighties gave the base a capability that even its architects could scarcely have been able to imagine. With the creation of Intelsat and digital telecommunications, Menwith and other stations developed the capability to eavesdrop on an extensive scale on fax, telex and voice messages. Then, with the development of the Internet, electronic mail and electronic commerce, the listening posts were able to increase their monitoring capability to eavesdrop on an unprecedented spectrum of personal and business communications. This activity has been all but ignored by the UK Parliament. When Labour MPs raised questions about the activities of the NSA, the Government invoked secrecy rules. It has been the same for 40 years. Glyn Ford hopes that his report may be the first step in a long road to more openness. "Some democratically elected body should surely have a right to know at some level. At the moment that's nowhere". [Daily Telegraph, 16th December 1997]

OFFICIAL REVELATION OR COCK-UP?

On an official website for Wright Patterson airbase a reference was made to the Aurora spyplane by Wright Patterson officials. The existence of the advanced secret aircraft has long been denied by the USAF and other government sources even though certain uses of the code name Aurora have been found on government records and expenditure audit accounts.

The text reads:

"This heritage includes legendary aircraft like the P-51 Mustang and the B-17 Flying Fortress, as well as the indomitable B-52 Stratofortress. More recently, versatile aircraft like the F-16 Fighting Falcon and the F-117 stealth fighter have extended this heritage. Now the B-2 stealth bomber, the F-22 Advanced Tactical Fighter, and the Top Secret Aurora are proud additions to Wright Field's tradition of aeronautical innovation."

So is it a case of openness or just a case of a slip up. Sometimes mistakes like these are made on purpose by staff who want information to get out to the public regarding new and secret projects.

EXPORT CONTROLS ON ENCRYPTION SOFTWARE

You may be aware of the problems which had arisen in the United States in relation to the encryption software PGP which uses military grade encryption and is available for public use. In a legal case, a Scottish businessman was arrested by the FBI for selling computers to Libya following an undercover operation.

Even if you are buying a computer in the UK for use in the US, you may be caught by US export rules which apply not only to goods exported from the US but also their subsequent re-export from the UK.

In an encryption case, a man was told that he would require an export licence to take a BT phone disk from the UK to Jersey (which is not part of the UK for these purposes). The CD contains encrypted software and therefore is treated as the supply of "military encryption devices" by the export control rules. With the move towards encryption of data on the Internet and the V chip, the use of encryption technologies is set to increase - although its development may be stymied if governments continue their insistence that they be given the necessary codes to read the encrypted materials.

MYSTERY LIGHTS

INTRODUCTION

The following report deals predominantly with sightings of an enormous double circle of lights observed over Bristol and the surrounding areas in the July period of 1996. The most witnessed sighting of these lights was in the early hours of July 6th.

The report also deals with aspects of the investigation, which may not have a direct bearing on actual sightings, but may have relevance to investigative Ufologists in general.


Witness drawings have been re-sketched using computer graphics for the purpose of providing more clarity to the reader. I have endeavoured to keep them as accurate to the originals as possible.

LEAD UP OF EVENTS:


I began receiving a trickle of reports about UFO activity over Bristol in early July 96, one of my first lines of enquiry was to contact Bristol Airport to see if they had any radar contacts with unknown air traffic within the time frame of reports. Shortly afterwards I received a letter from them along with 2 UFO reports, it was through one of these reports that I first became aware of the large light circles that were also being seen. As well as this I also obtained details of another report via the "British Flying Saucer Bureau" (which is the oldest UFO group in the World), with this second report I now had a confirmed sighting with to investigate.

THE INVESTIGATION:

I have a good contact who does a little work with B.B.C. Radio Bristol, I relayed

the details to him and within days I was asked to do a live broadcast via a phone link. I was pleased with the way that the interview went as I was allowed to talk almost without interruption for some 20 minutes. From this interview came more reports, the Bristol Evening Post put a small write-up in their paper which in turn produced even more response. To my surprise I was asked to give a second updated radio broadcast on Radio Bristol. Through all this publicity I obtained a substantial number of corroborative reports.

The lights were described as being approximately 20 in an the outer circle and 6 in an inner circle, although this number does vary between witnesses. I attribute this to the fact that as the circles were rotating in opposite directions it could make them appear more numerous than may have actually been the case.


My first and most obvious thought was that this was a projected or laser light display. A thought reinforced by the fact that the annual St.Pauls Carnival had taken place the day after the lights were seen. With this in mind I contacted the carnival organisers who informed me that no lights which could produce the observed effect were used prior to or at the time of their event. Still following this line of investigation I contacted local nightclubs, again I drew a blank. I then decided to contact the City council and asked if using such a light display system would require any kind of licence, the answer to this was no, but permission would be required from the

Councils Health and Safety department. They in turn informed me that no lasers or powerful lights had been used within their area since the "Festival of the


Sea" which was held in May.

It then occurred to me that this was close to the date of the release of the "Independence Day" film and that this could have been a publicity stunt. Investigating this aspect I again drew a blank. As a separate angle I contacted a member of the Bristol Astronomical Society who told me that nothing astronomical could be related to such a sighting.

Bristol Airport has an official unidentified flying object report form, on the bottom of which I noticed an action instruction for the person taking the report. The instruction was to immediately telephone a military section (AIS) at LATCC, which I believe is London Air Traffic Control Centre and pass on the details of the report. Following this they should send a written report to The Ministry Of Defence, Secretariat (Air Staff) 2a, this was then followed by a hand written telephone number. Being rather inquisitive, I decided to call this number. When I got through I posed the question "Do you take UFO reports?" I was told to hold the line and was put through straight away to the military AIS department. Again I repeated the question, and was given an expectant yes! I then informed the person that I was talking to that I was a UFO investigator and would like to know what their was exact involvement with UFO information and reports sent to them. The person that I spoke to seemed slightly taken aback by this and told me that AIS was an Aeronautical Information Section, and they distributed information received to other departments. Naturally I asked what departments? The gentleman that I was speaking to became



quite coy and told me that if I required anymore information I should contact Secretariat (Air Staff) 2a, this I did and

- What action do they take when receiving UFO reports, and can these reports be obtained by members of the public?
- Was there any low flying military aircraft or military exercises over Bristol or surrounding areas on the dates in question?

Miss Gaynor South of the MOD answered some of my questions confirming that they had received a report from Bristol for July 6th. What was interesting in her letter was her statement that, "The reports are examined, with the assistance of the Department's air defence experts as required." This then clearly shows that the UFO subject is taken somewhat more seriously than the MOD has previously led us to believe, also that the investigation and consultation aspect is more widespread and goes beyond Air

DEAR MR DAVIES,

1. Thank you for your letter dated 1 August 1996 addressed to Miss Philpott regarding "unexplained" aerial sightings over the Bristol area in July. I have been asked to reply.
2. First perhaps it would be useful if I were to explain the role that the Ministry of Defence has with respect to this subject. The Ministry of Defence examines any reports of "UFO" sightings... it receives solely to establish whether what was seen might have some defence significance; namely is there any evidence that the UK Air Defence Region might have been compromised by a foreign hostile military aircraft? The reports are examined, with the assistance of the Department's air defence experts as required. Unless there is evidence of a potential military threat, and to date no "UFO" sighting has revealed such evidence, we do not attempt to identify the precise nature of each sighting reported to us. We believe that down-to-earth explanations are available for most of these reported sightings, such as aircraft seen from unusual angles or natural phenomena.
3. You have asked what procedure is followed when the MOD receives "unexplained" aerial sighting reports and the role of AIS(Mil). Reports from members of the public are usually made to Police stations, RAF stations and air traffic control centres and are then forwarded to this office. AIS(Mil) act as a co-ordination point as they often receive reports from other RAF bases and forward them to us. AIS(Mil) have no other role in respect of "UFO" reports. Members of the public sometimes telephone this office directly to report a sighting. The reports, which are usually very brief and vague, are considered in consultation with air defence advisers within the MOD, and a decision is taken as to whether what was seen represents a threat to the security of the UK. Sightings reports are kept on file within this office for future reference.
4. With regard to your request, I have looked back through our files and have found that no "unexplained" sighting reports were made to the MOD for 14 or 15 July in or around Bristol. However, there was one sighting report made to the MOD for 6 July in the Bristol area. At the time, this report was examined by air defence


asked the following: -

- Could they confirm that they had received reports of UFO's for the periods in question?
- Could they enlighten me as to their procedure when they investigate alleged UFO sightings?
- What is AIS's involvement in taking UFO reports?
- Who do they distribute the information to?



which led me on a hot and cold trail from Swansea to Slough. In spite of this I thought that I could see some light at the end of the tunnel.

I discovered that on the night in question the Welsh National Orchestra performed at an open-air concert in Singleton Park in Swansea, this show was later shown on BBC 2. What was of concern to my investigation in respect of this concert was the use of a Skytracker light system, although unlikely

some models have the capability to display something vaguely similar to what was seen over Bristol.

Still with the opinion that these lights were of a man made origin I began chasing the suppliers of light display systems. I started with a company called "Fine Line Lasers" based in Failand This in turn led me to a company called "Theatre Projects" who I understand may have supplied the lighting for the Swansea concert. They were very helpful in supplying information about the Skytracker systems although they were doubtful that these were responsible for what was seen over Bristol. Theatre Project in turn put me on to a company called "Anark Lights" in Slough, the gentleman that I spoke to was extremely helpful and was quite bemused that lights of the type seen could be mistaken for UFO's. He was quite sure that was what was seen was a system known as a Space Flower or a Strobe Flower which was capable of making the lights pulse.

What also lends weight to the light system theory was that some witnesses mentioned a repetitive triangular path taken by the lights, this could indicate a chain driven system.

I was informed that when these light systems are going to be used it is the supposed practice that the Civil Aviation and local Authority be notified, this does not appear to have been the case with the lights seen over Bristol if indeed any of these systems were used.

There is still several points of contention that I feel I will never find an answer for.

1. The overhead whirring noise heard by several witnesses.
2. The observation of the lights going behind the cloud layer.
3. If the light source did emanate from a central point in Bristol, the failure of all but one witness to observe the beams which should have been clearly visible from a 2 mile radius.
4. The lack of an event or function, that

5. would warrant the use of such lights.
5. Failure to notify the authorities.
6. Also the fact that these lights if projected would have had at least a 25 mile visibility range, why then were there no witnesses from much further afield?

MORE LIGHTS

In early 1997 I was contacted by a witness who while returning from Holyhead with his family and heading towards their hometown of Neath, in Wales observed a large illuminous cone shaped object near the Shrewsbury area at around 8pm. They described the object as having circular lights rotating on the bottom. The object appeared to follow them for several miles and at one point they thought that it might actually land close by. I was told that while they were driving the family group was apparently dumbstruck! They eventually stopped in a Diner or café a little afraid. This experience prompted the driver to seek out a local UFO investigator, and that how I became involved. I immediately put out feelers with the local press and radio to try to find more witnesses or a definitive answer. I spoke on the local radio and had an article put in the press all the while I continued to contact local clubs and track down events. Another witness came forward with an identical story but this one was travelling in the opposite direction. Then Bingo! A local night-club confessed they were responsible for what was being seen. Also I started to get letters from local people confirming that it was a regular display by the night-club. What is

most interesting is that the observers were some 8 miles from the point of origin yet still they claimed absolute clarity in what they saw and were sincere in their belief that this may have extra terrestrial origins. I am now wholly convinced that all lights of this type described as UFO's, are nothing more than man made light displays. Many times they are seen around the country and no source can be found but I do not waver in my opinion. This does not appear to be the case with many Ufologists who without being able to find a definitive source are all too quick to rubber stamp a sighting as genuine. 23/01/98



STUNNING ISRAELI EVIDENCE EMERGES

By Barry Chamish

One might think 1997 was a poor year of UFO activity in Israel judging by the paucity of media reports. In fact, the media clamped down hard in January '97 after they were burned on the Achiod alien/lizard story and the false prediction of mass landings on Jan.5. However, due to the superb research of David Ronen, Doron Rotem and two young newcomers, Gil Bar and Eddie Shpitz, it turns out that 1997 was a vintage year for Israeli Ufology. Some of the most dramatic physical evidence of the country's intense ten years of activity emerged last year. Following is a summary of 1997.

FILMS

Over three nights in September 1996, Elad Niger filmed a remarkable UFO over the coastal plain city of Kochav Yair from his vantagepoint in the nearby city of Kfar Saba. He released the films to David Ronen in March of 1997. They reveal the prettiest UFO ever filmed in Israel. It looks like a colourful apple wearing a three-pronged crown. - 1997 saw three UFOs filmed in Rishon Letzion, 20 miles south of Tel Aviv and a centre of UFO activity since 1993 when giant aliens visited the apartment of Batya Shimon. Of the three clips, none is so memorable as Gil Bar's November filming of an ellipsoid disk captured in 4 PM sunlight being chased by an Israeli Air Force F-15. The UFO's high-speed manoeuvres to escape the jet are most acrobatic. This is the first known instance of a military plane chasing a UFO captured on film in Israel.

Then on November 26, Nahum Shomroni videotaped an afternoon invasion of low flying UFOs over Tel Aviv. The light conditions were perfect and the craft were flying at only an estimated 700 meters

altitude. The result is a breathtaking view of three sponge-shaped, dark UFOs of a type possibly never seen before.

PHYSICAL EVIDENCE

1997 saw two disturbing animal mutilation incidents associated with UFO sightings. They continued a pattern that began in the Negev village of Klachim in Dec. '96. Sylvia and Yitzhak Kadosh witnessed "an image as big as a house sparkling like a welding torch" land near their donkey compound. The light vanished before their eyes and they hoped it would be the last time their farm suffered such an intrusion. But their hope was not realised. Two nights later, 2 donkeys were mutilated. The older one had its eyes and tongue removed and its rib cage was exposed by a surgical removal of skin and tissue. The younger animal only had the latter operation performed on it.

In July '97, the Glam family of Sde Uzhiah, thirty miles west of Klachim, had a UFO experience which culminated in Mrs. Glam being chased by a projector light from an unknown source. Again, two nights later, their sheep pen was invaded and five sheep were drained bloodless from precise holes drilled in their cheeks. Doron Rotem researched both incidents and to this day, keeps an example from Sde Uzhiah frozen in his freezer. He admits his wife is not happy about this mutilated carcass sharing space with the family groceries.

The final incident made national news, the only UFO story to do so all year. On Nov. 2, a silver ellipsoid disk hovered over the Gaza Strip settlement of Paat Hasadeh. On Nov. 8, Yaacov Mazal-Terem awoke to discover a row of twelve pairs of holes, 5 cm. deep along the fence which enclosed his horse. The horse itself had two 1 cm. holes surgically drilled into its front hooves. The national media photographed the row of holes and their origin remains a mystery. Speculation is they were alien

tracks or pods from a craft. And finally, the famed hotspot of Kadima returned gloriously to Israel's UFO history. From 1993-95, approximately 20 landing spots were discovered after nights of UFO activity in the skies. Within were shards of material

later tested worldwide and found to be nearly pure silicon. This year, the same shards were found twelve miles to the west on the beaches of Gaash and Shfayim after UFO activity was reported. On October 10, a UFO was seen over the Kadima suburb of Tel Yitzhak. Idan Levy discovered its landing circle and found within, not shiny silicon but an unknown material that looks like grey-branched coral.

SOMETHING TO LOOK FORWARD TO

I will be bringing the videos of the low flying invasion of Tel Aviv, the F-15 chasing a most distinct disk over Rishon Letzion and the colourful apple-shaped craft with a crown over Kochav Yair to the Laughlin, Nevada conference. I think conferees will agree this is a most dynamic and important trio of films. I will also be bringing photos of the three mutilation cases as well as samples of the Kadima "coral" to be offered for serious laboratory testing. Israel's unique and powerful wave did not diminish in 1997, it simply went unreported. That will end in Laughlin.

DIANA: A MANIFESTATION OF THE 'LAW OF HIGHER PERSPECTIVE'

The Divine Plan is very complex, but, even so, it is important that we should strive to observe World Events that are being orchestrated from the Higher Spheres in order to support the activities of Light that are taking place on the planet. paparazzi in the other; the withering attack on the monarchy and the establishment in general; and the incredible emotional response on the part of almost every man, woman, and child on the planet. But how are we to view the event in the light of the Law of Higher Perspective?

The 'Law of Higher Perspective' requires that we see good in all things. This means that it is not functional to dwell on the negative aspects of situations, such as asking 'Why did so-and-so deserve this?' Instead, what is required is for the heart to perceive the positive benefits of all things and how they contribute to the greater plan of creation. For we must recognise that when high-level souls become involved in bizarre 'accidents' or seemingly unpleasant events, such as betook Princess Diana at the point of her death, it is USUALLY FOR A HIGHER PURPOSE. Many of the souls who are involved in such incidents are Ascended Masters in disguise and are often individuals who have achieved high visibility in the eyes of the general public. When a high-level soul becomes involved in such an incident, it is more than likely that an agreement was made with that individual's Spiritual Self to undergo the experience. In such a case, the individual concerned would have chosen to experience the incident, as unseemingly as it might have been, because the enactment of such an event would serve to arouse a specific response on the part of the general public. When this is the case, the 'sacrifice' serves to accelerate humanity's consciousness and what would normally take years to achieve in acceptance and tolerance, takes only a few moments or days because of the love and emotions emitted.

Seen in the light of the 'Law of Higher Perspective', what, therefore, are we to make of the death of Diana, Princess of Wales? Basically, the death of Princess Diana was designed to accelerate humanity's consciousness in at least three ways. Firstly, it was in order that we might grasp the difference between the transitory and the transcending. For we live on a planet, which, for the most part, focused on the delusory and illusory 'glamour' aspects of life, craves for the material. The world's 'National Lottery' craze - which is, at depth, anything but an altruistic thing - is illustrative of this. In other words, it craves for anything other than that which endures. So, Princess Diana, during the

last few months leading up to her death, permitted herself to be saturated with the material. The most-photographed lady on this planet sacrificed herself on the altar of the world's media in order that the whole world might see 'the happiest days of her life' which she spent in the company of her friend Dodi. She offered herself up in order that we might all drool over what we perceived she had, for what wouldn't any of us have given to be in her shoes? Then 'bang!' At the very height of her luxurious enjoyment, which we all craved for, she was gone.

But Princess Diana was not just a glamorous limelight-hugging figure. For a habit would have sat as comfortably upon her shoulders as designer clothes. She would have made as gracious a nun in the 'Bells of St Mary's' as Ingrid Bergman! Little wonder that she so easily aligned herself with such a self-sacrificial being as Mother Teresa, who, surely uncoincidentally, drew her Earthly days to a close but a few days after the passing of her Earthly friend and spiritual colleague. For, as she was, in lives past, to be found in many positions of public eminence - especially in the royal courts of Egypt and Syria - so was she to be observed doing homage to the mighty in many convent and monastic situations in both the Orient and the Occident. She was indeed a Queen -the Queen of People's HEARTS, as she herself said. It was her open heart, which enabled her to comfort, orphaned children; to caress those plagued with AIDS, to walk in the midst of landmines. And so we come, quite naturally, to the second reason for Princess Diana's 'untimely' death. Her open heart ENABLED US TO OPEN OUR HEARTS, IN A COLLECTIVE SENSE, as witnessed by the amazing scenes on the day of her funeral, and for many days afterwards. A humanity, which had been well-and -truly polarised, consciousness-wise at the level of the solar-plexus energy centre of the body (the narcissistic centre of the lower self) had, at long last, OPENED ITS

COLLECTIVE HEART.

And so to the third 'higher-perspective' reason for Diana's death. As the years went by, so she became stronger in her own spirit,



so much so that the 'Establishment' didn't really know what to do with her. It is even purported that the Queen herself called her 'That IMPOSSIBLE girl.' And, of course, she was 'impossible.' All people, who stand in the strength of their own spiritual power are 'impossible' so far as the Establishment is concerned, and our history books are littered with such individuals who have been strong enough to cock a snook at it.

We stand at a point in time in humankind's history when the Establishment is cracking at the seams. This statement is not made in any anti-Establishment sense. It is merely a fact that the collective thought-forms and archetypes that society's structures have been founded on are being re-evaluated at such depth that the structures themselves, which form our 'Establishment', are past their sell-by date. However, it is doubtful whether the people recognised this in any meaningful way until the day of Diana's funeral. Then, on that day, it became apparent that the societal structures which we had were quite insufficient to contain the newly-awakened spiritual power - symbolised by Diana - which is beginning to surge through the people. For the day of Diana's funeral, released, in the immortal words of the late Sir George Trevelyan, a 'Rising Tide of Love' which futile attempts to reform the monarchy, modernise the government, and update the church, will NEVER be able to contain. Indeed, such attempts would be to miss the point. The point is this: on the day of Diana's funeral, the Establishment was quite unable to

gauge the feelings of the people. It was not so much a day, which marked the ending of old, worn-out Establishment, forms - it was a day which marked the RE-EMPOWERMENT OF THE PEOPLE. It was a day in which new archetypes, on which a new civilisation is to be founded, flooded into our consciousness from the Etheric World

It was interesting - and almost amusing - to note some of the unctuous comments of the religious leaders about Diana. The Archbishop of Canterbury and others of such ilk commented that she had not been overmuch interested in organised religion and THEIR conception of God. Of

course she hadn't. There had been little reason for her to BELIEVE in ANY god 'outside' of herself. SHE WAS A LIVING EXPRESSION OF THE GOD-FORCE WITHIN HERSELF. And if, as some commentators have pointed out, that her life was less than perfect, we should exclaim 'Thank God for that!' The time of plaster saints is over. The Spiritual Masters are again beginning to walk the Earth. But such are not dressed in ecclesiastical vestments, habits, or white robes. They are dressed in anything from tiaras, tracksuits, and trainers. It was the perceived IMPERFECTION of Diana with which we, the people, identified: an imperfection matched with unbridled spiritual power. Little wonder that the day of her funeral was, according to the Mayan Calendar, the Day of the 'White Galactic World-Bridger.' For Diana had truly, 'bridged the gap' between the terrestrial and spiritual worlds: something that no organised religion could ever do. She gave US - the people

- The impetus to say 'I, despite all of my imperfections, could express MY spiritual power like that.' For she was, in truth, a living symbol of an imperfect personality aligned to its perfect spiritual self. One national newspaper suggested that Diana had created a new religion in which the first commandment is 'Adhere to your inner self. Has any other TRUE religion ever existed? In our re-recognition of such, she gave -and gives - us eternal hope.

There is a tendency, after the most remarkable and Earth-shattering incidents have passed, for life to settle down in its old familiar ruts again. But not so this time. Diana, despite the world-wide popularity of the song, was no 'Candle in the Wind.' She was a brilliant, blazing, burning light, which shone like a comet in the darkness of our world - and in the words of St John's Gospel, the darkness will never be able to overcome it. It is a light that will NEVER be extinguished. For that light will continue to glow in the hearts of us all, as people re-empowered, till such time as we build a new, spiritually orientated, civilisation upon the Earth.

For such will be the ultimate outcome seen from the 'Law of Higher Perspective.'

{Unfortunately I do not know who John Crowe is, and I am perplexed by this article. VAUNDA HOSCIK - PART II

Last July, Jan and I met with our friend Chris Martin at Hyde Park, London. As mentioned in our previous article, Chris used to be the boyfriend of contactee Vaunda Hoscik, until their separation in October 1996. A chapter is devoted to them in Nick Pope's second book, *The Uninvited*.

One purpose of this meeting was for Jan to channel for the third time, the hybrid alien called Minnie (see previous article). This entity is apparently the offspring of Vaunda Hoscik, and took Chris to be her adoptive father since his time with Vaunda.

Minnie settled into Jan's body, very excited and tearful to see Chris again after some ten months of separation. They hugged and caressed one another throughout the meeting, conversing on matters completely unknown to Jan and myself. At one point Chris pulled out a packet of menthol cigarettes - immediately Minnie's (or Jan's) eyes lit up as she asked for one. Upon being reminded that she was 'borrowing' someone else's body, Minnie reluctantly changed her mind. Chris then revealed that menthol cigarettes were her favourite.

After 35 minutes, Minnie's time came to an end. She left after giving Chris a big hug, and Jan returned seconds later. We could see Chris was clearly moved by the extraordinary experience, exclaiming that he was totally convinced of its genuineness.

Here we obtained further **repeatable proof** that the body is but a mere channel for any non-physical personality who wishes to inhabit it.

THE DAY AFTER ROSWELL

The Day After Roswell by Colonel Philip J. Corso (Ret.), is an astonishing story of how the US military allegedly won a secret, 50-year war against hostile Greys by turning their technology against them; consequently

saving the entire planet. From 1961 to 1963, as part of Army R&D's Foreign Technology Division at the Pentagon, Corso claims to have spearheaded a plan to adapt and use viable technical components of the Roswell craft, for military and commercial purposes. According to Corso, much of the technology we now take for granted was derived from the Roswell craft (and others retrieved since). Such as night vision, lasers, fibreoptics, integrated circuitry, supertenacity fibres, and biofeedback headbands.

The book begins with a composite account of the alleged UFO crash, claimed to be based on military and official sources. The book contains a chapter on EBE physiology, according to official autopsy reports (which corroborated data already received by Jan). Corso also confirms the nearby San Augustin crash, Majestic-12, animal mutilations, human abductions, Area 51, alien moon bases, anti-UFO technology, reasons for UFO cover-up, and a reluctant treaty with the EBEs. "These creatures weren't benevolent alien beings who had come to enlighten human beings. They were genetically altered humanoid automatons, cloned biological entities, actually, who were harvesting biological specimens on Earth for their own experimentation. As long as we were incapable of defending ourselves, we had to allow them to intrude as they wished. And that was part of what the working group [MJ-12] had to deal with. We had negotiated a kind of surrender with them as long as we couldn't fight them. They dictated the terms because they knew what we most feared was disclosure. Hide the truth and the truth becomes your enemy. Disclose the truth and it becomes your weapon. We hid the truth and the EBEs used it against us until 1974 when we had our first real shootdown of an alien craft over Ramstein Air Force Base in Germany."

Toward the end of the book, Corso attempts to make the reader feel as though

the world is safe from hostile aliens thanks to the almighty US Government. He claims the Strategic Defence Initiative is up and running, busy disabling incoming UFOs. Apparently this has forced the aliens into a stalemate, yet he fails to mention how the military could successfully combat a UFO armada nor huge motherships (miles in diameter), let alone other races with even superior technology. Throughout the book, Corso naively implies that all UFO craft are piloted by hostile EBEs (alias Greys), and does not even consider that there may be benign visitors; even of that *same* species.

During his career as an intel officer, Corso admits to having worked for counterintelligence; so should be an adept at bending the opinion of others through cleverly constructed disinformation.

JOINT ENCOUNTER?

On the morning of Saturday, 11th October 1997, both Jan and I awoke with a severe headache. Upon getting out of bed, we noticed that the covers had neatly rotated 90 degrees, with the sides now top and bottom. They were certainly not like this the night before.

We suspected a visitation may have taken place, so I persuaded Jan to investigate with remote viewing. Here is what she saw...

While both asleep in bed at around 4am, a luminescent figure entered the room through the closed French doors. It glided toward the foot of the bed and looked at us. In turn, it came round each side and stared at our heads - Jan felt that the entity was accessing information stored in our head implants, concerning our physical health.

The entity, whom Jan recognised as Anraa (see *Contactee Viewpoint* #1), then disappeared.

Jan and I then got out of bed, pushing the covers to the floor, and walked to the centre of the room. As we left the bed, a

vertical shaft of pale yellow light appeared in the room's centre, from floor to ceiling (and strangely, did not illuminate the surrounding darkness). In what seemed to be an altered state of consciousness, we entered the shaft (some 3 feet wide), embraced, and began to ascend in a rotational manner through the ceiling. While remote-viewing this, Jan felt we were being shifted into dimension 3.5. She saw us rise through the roof and proceed upwards until entering the underside of a stationary disk-shaped craft, about 30 feet in diameter.

Still in an altered state, we found ourselves in what appeared to be the control room of the ship. Already present in the room were four Greys, around 3½ feet tall. One of them then led us to a doorway, at which point we both heard a voice in our heads that said we were going to a warm, sunny beach; and all we'll want to do is make love.

Unescorted, we entered the room, which was dark. As it became light we found ourselves on a beach as described. Both naked, we proceeded to make love until some 20 minutes later when the sky became stormy and dark. The scene faded away, and a Grey then entered and led us back to the control room. Present were three other Greys and Anraa, our acquaintance.

Next we descended the light shaft, still in an altered state, back into the bedroom. After putting the covers back onto the bed (wrong way round), we got in and went to sleep.

If true, this account further corroborates other independent abduction stories that feature what appears to be an advanced 'Virtual Reality' technology. It is possible to alter a person's perceived surroundings under hypnosis, but not with two persons experiencing an identical illusion. Maybe the Greys' VR technology involves hypnosis and a telepathic computer-brain interface to regulate the shared experience?

ALLEGED INTERFERENCE BY US GOVERNMENT REMOTE VIEWER

On 20th October 1997, I invited any non-hostile ETs who were in contact with the US Government to talk with us. Janice began to receive mental pictures of several beings, then fell into an unexpected trance. Regaining consciousness a minute or so later, Jan claimed that while looking at these beings, she suddenly became caught inside a 'net' and felt as though being scanned. She felt whatever it was that 'caught' her took a look through her physical eyes (still open) before releasing her from the trance state.

Upon my request for identification, Jan began to hear an American female voice inside her head. The 'woman' stated that she worked for the US Government. I questioned as to what she was doing. She replied that her job was to intercept any telepathic communications directed at ET races working with the US Government. During the conversation, the lady sounded very patriotic and seemed to perceive non-Americans as an inferior species. I asked if she had a family, to which her reply was no. She belonged to a team of remote viewers and lived on the base (Janice felt was in Michigan). Her team worked two 4-hour shifts with a 2-hour lunch break. I asked what she would do now that she was aware of us, and she replied, "Make a report." After asking a couple more questions she abruptly ended the contact. Janice felt that we were being watched by four remote viewers, the other three remaining silent. Unfortunately, my suggestion to talk via telephone was declined.

Next, I asked our non-physical helpers to prevent this from happening again, then repeated the invitation. Janice now received a mental image of a group of seven Greys. Before opening contact, I asked her to scan them and discern their level of consciousness. She felt they were neutral, of the 'Grey-Two' category (see *Contactee Viewpoint #3*).

They seemed to be okay, so we exchanged a few words. Apparently, the US Government has agreed to give them a piece of barren land in exchange for technology; in particular, weapons. I asked why they were giving the US Government weapons, when (according to Colonel Corso, etc.) they have been turned against them. They admitted that members of other factions have been killed by the Americans, but not them. They agreed that interactions with the 'rogue' Greys were a big mistake - "The US Government have dug themselves a big hole." Apparently, our governments do not pose a threat to them, as their technological gifts are merely 'placebos'. Within 2½ years, they said, the US Government plans to announce their existence.

When talking about the acquired land, Janice received images of Arizona. At the moment, this Grey faction claims to be extensively examining the environment, in preparation to constructing a subsurface base there.

ONI COLONA

On 29th October 1997, Jan

telepathically received the following poem from Oni Colona (see previous articles):

*Learn to live, learn to die,
Open your heart and learn to fly
Amongst the flowers and the trees,
Be like the leaves in the warm, gentle sun
In an Autumn breeze.
Feel the life all around,
For a leaf doesn't die when it falls to the
ground,
Life and death are a circle,
They go round and around.
It's easy to say, 'Look away, look away,'
But life won't stop turning
And the Earth keeps on learning.*

Oni Colona often communicates through song and poetry. At the time of receiving the above, Jan was upset because a close friend had been acting out of character and avoiding contact. This friend finally admitted that she had a great fear of aliens, especially the thought of them freely entering her bedroom. That same day, another ET friend called Anraa (mentioned earlier) offered the following condolence:

"Now you see why we must take care and act in the manner we have chosen to observe. Even those around you, whom you have deemed open and ready to receive information, have disappointed you with their responses. This is why we must continue for the present time in your linear world, to try and remove the trauma of memories most of you cannot understand.

"Some of you are ready, and it is the hardest task of all to relay your perspective on these matters to those who are living in fear of themselves. Let this not discourage you, for you are the golden ones and will continue with your quest. Try not to bear ill will towards those who will not listen, for they are the ones who need you most. Give them more time and their questions will come. It is our love for you that brings us here and now. Our love is the strength that will give the power for your survival. Continue."

"If we are being visited by aliens, why don't they just land on the White House lawn?" is a question often posed by sceptics. Obviously, this question is based on very shallow thinking. Many of us realise that the matter is far more complex. Repeatedly, contactees have been told by the aliens that the world must be deemed ready for 'open contact' before such a scenario can take place; that humanity's 'collective invitation' has to reach a critical mass. Many ET groups hope this will be fulfilled by the New Millennium. Assisting this process, many claim, are UFO sightings, telepathic communications, close encounters, and crop

formations. Also the media?

QUESTIONS AND ANSWERS

The following questions were telepathically answered by a 400-year-old, benign Grey called Téó (meaning, 'Anew'). From the year 2356, he claims to be the evolved version of an entity called 'Antholas'; once known to contactee Vaunda Hoscik. According to Téó, 50 years earlier, while in contact with Vaunda, he experienced a 'crisis of identity' that led to a psychological rebirth. Téó says he is a scientist, specialising in human culture and education.

Are you slaves to Reptilian Overlords, as some researchers believe?

"I am aware of no such creatures aforementioned. However, if in some points of our lives it was to our advantage to let others believe that we are not responsible for our actions, what better way than to falsify this image and project ourselves as a controlled lifeforce."

Does your race, as some researchers claim, work with a group of Reptoids from the Draco constellation?

"There are many races, and also countless variations within one race type, that we have contact with. Over millennia, types have changed directives and service to their own and others' environment. Those who have chosen to conflict at one time may have settled their views or learned to accept their differences.

"Service-to-self types have found that association with other service-to-self beings can manifest advantages which would otherwise be out of reach. Those who practise 'service to others', could look upon this as unacceptable - but only in relation to their puritanical views. Because a race chooses service to self, that does not make it evil, just part of the whole.

"I have evolved because it served more purpose for me to do so. In my earlier existence, there were those who chose to communicate on our level, who were not of our kind. These beings were almost opposite in appearance to ourselves - large, heavy set, small eyed; although technologically speaking, equal in achievement and therefore intellectually comparable.

"It was agreed between our two species to work alongside, absorbing the benefits this liaison could bring."

What do the Draconians want from Earth?

"It has been the knowledge of Vindaas, that the planet of Earth is transforming. An evolvement of any kind is always beneficial to many species and thus causes great interest. Is it necessary to explain what the Dracos require from Earth? Anything that becomes available, anything that is given or can easily be taken. The Dracos are not particularly human-friendly, nor are they consciously preparing for combat."

[Apparently, 'Vindaas' is a Reticular name for the Cosmic Consciousness, whom they regard as God.]

Do you foresee any government announcements of ET contact, made in the near future?

"Ask them yourselves. Ask yourself - utilise the dormant part of human brain and do some thinking. Make it happen, wake up refreshed from your millennia of slumber and realise your potential.

"It is a case of who will dare to traumatise their nations first. All countries have prepared announcements, absolving them from any blame of secrecy. The knowledge will flow from a very small area and escalate. The problem with human race is the consuming passion for materialistic possession, which drives man to lie, cheat and deprive those who are dependent."

The Roswell Incident - what do you believe happened?

"Through this mind I can experience the beauty and innocence of a world overcome with greed and destruction. There is hope for some of you - great hope for us both. The eagle flies in the thoughts of this one, as on the day near Roswell, America.

"To focus on an aim and to execute a mission with intent to succeed at whatever cost, shows strength within our race. If some are misguided, this does not mean the intentions are negative, only different to your own.

"Two factions died on that day and many more since. All were volunteers and knew what had to be done. Neither faction were wrong, just had different answers to the same question. *Canzelat* [rest in peace]."

With regard to the Roswell Incident, benign Greys have informed both Janice and I that the event involved two crashed UFOs - one piloted by neutral Greys and

the other by rogues. Apparently, the rogue Greys had devised a plan whereby they could establish contact with the US Government, free of interference from the Galactic Council (see *Contactee Viewpoint* #1).

According to our information, the rogue Greys decided to crash one of their ships in the New Mexico desert and wait in hopes of receiving an invitation of contact from the US Government. Apparently, this invitation was received - allowing the rogues to appear as passive participants in an exercise of human free-will. This stunt has supposedly prevented their immediate removal by the Galactic Federation, whose 'prime directive' is to honour our free-will.

The other craft, said to have crashed in San Augustin, apparently collided with the 'Roswell' UFO while attempting to escort it away from the planet.

Obviously, most claims made by these entities are difficult to verify - so make of them what you will. Our minds remain flexible.

This article concludes the regular *Contactee Viewpoint* series, although the story is far from over. Recently, Janice ceased to be alone in her ability to trance-channel our UFO contacts; a local investigator friend suddenly found he shared this ability and is now channelling entities familiar to Janice and myself. In addition, he claims to recall meeting with these beings in abduction-type scenarios across 20 years. Unbeknownst to himself, Janice recently claimed that he was present in one of our joint abductions. Watch this space...



Book Review

'A Covert Agenda' by Nick Redfern (Simon & Schuster)

I first became aware of Nick Redfern and his investigations into our MoD and it's interest/involvement with UFO sightings back in 1992 when I got my first UFO book, 'The UFO Report 1992' by Tim Good. Nick's chapter was well written and researched and it was obvious that he was a good levelheaded researcher, which is something that is really called for in the minefield that is Ufology. As I bought more books and magazines on the subject I saw Nick's name come up more often. The first I knew of that Nick was writing his own book was in late 1995 in a letter from Tim Good. Tim informed me that Nick was writing a book about our MoD and UFOs, so I looked forward to its release, as there has never been such a book written entirely on this mater.

Nick's book, 'A Covert Agenda' was finally released in October 1997 and was eagerly awaited by me as I had myself become familiar with our MoD and its position with regard to UFOs. I found that their stance was very shaky indeed! By this time I had visited the Public Records Office in Kew and had seen some of the released documents relating to UFOs firsthand, many of these contradict what the MoD will tell you when you write to them yourself, as I had done. For a number of years Nick has been visiting the


leads in such documents. This has lead Nick to a wealth of useful and informative information. Nick also spent a considerable amount of time interviewing people himself, many of which being ex service men and women who have related details of many officially reported sightings that have occurrd over the years. All of this makes very interesting reading indeed.

I found the book very easy to read and found it hard to put down once I had started. The book has the same feeling of credibility as Tim Good's classic 'Above Top Secret', leaving its contents hard to knock down, unlike some other UFO books I had read. The case Nick puts forward for our MoD being 'full of it', in so many words, is a very good one indeed. After reading 'A Covert Agenda' it's clear that contrary to the claims of people such as Nick Pope, it's does seem that there are other departments than Air Staff 2 who have more than a passing interest in UFO sightings. Anyone who is interested in UFOs should add this book to their shelves, read it first though!

Nick has also written a book on the FBI and UFOs called 'The FBI Files', this looks to be just as good and will be in the shops in April of this year, published again by Simon & Schuster.

The WOLSTONBURY

Experiment

I find starting this piece difficult. Perhaps it's because I'm still reeling from the impact of what appears to have been achieved atop Wolstonbury Hill, West Sussex, on the 28th June 1995. I say 'what appears' to have been achieved because other, seemingly unrelated at the time, pieces of mystical mayhem are still making themselves known, perhaps on a global level. I think I'd better make a start on this tale and take a stab at trying to bring it all together.

For some years now I had felt that some Crop Circles were formed where ancient Stone Circles, ancient places of power, once were, and that those same Stone Circles/Complexes were built on already existing patterns of sacred geometry, patterns that could only have been found by dowsing or clairvoyance. Also that these patterns created, by shape alone, a type of energy used for the maintenance of the earth and man and woman kind, cradling them in a cosmic balance so rare and fine that we can only guess at the harmony that existed then, perhaps hundreds of thousands of years ago, not even a blip in cosmic-time.

As is now well established we 'know' that Crop Circles are fed by an earth energy line coming from a major earth energy source i.e. Cissbury Ring, Wolstonbury Hill, the Rollright Stones, Avebury, etc. There is usually water running underneath the site in much the same way that pre-reformation churches are usually built on old power sites used by the ancients and where water is still dowsable. We also know that 'sound' is very important. Think of ANY major religion where ceremony is performed and you will find that 'sound' always plays a great part in raising the energy of ceremony, even some of the weirder sects. (OOPS!)

A group of us from CCCS Sussex had been involved in several attempts to interact with the circle-making force in previous years. So the idea formed that this year we would try and trigger one of these earth energy patterns into forming a crop circle by pouring energy into the grid by ourselves.

What I needed to do was to find a site that had an etheric pattern already there, a cornfield that was already fed by an earth energy line with water underneath. I map dowsed the local area and came up with a site at Saddlescombe near Pyecombe just west of the A23. I got David Russell to

check my findings and he confirmed that it was a Place of Power. Although on a slope it was a fine cornfield.

Next we had to contact the Guardian of Wolstonbury (Guardians are spiritual entities scattered throughout the landscape who look after the well being of areas about three or four miles square) from where the earth energy line was fed. Wolstonbury Hill is well known as a place of great energy, plus the fact that it is very beautiful and full of mystery and magic. Jason Porthouse and I set off for Wolstonbury one day in February. We drove to the bottom of the Hill, parked the car and sat there.

DAMUS

As Jason is a novice channeller (and getting better all the time) I suggested that he open up' too to trying to contact the Guardian. It was a struggle. The Guardian had a couple of goes at connecting. In the end he made it and my face took on a very broad smile. Jason felt him too and that smile was endemic of the being we came to know as Damus. Jason questioned him and asked him whether he would help us in our quest to bring down a crop circle that was fed by an energy line that came from Wolstonbury Hill. H said that he would be delighted! I could 'feel' the joy in him, as if he were a child that had been 'kept in' and then was let out again to play with the human beings that he had not 'played/worked' with for many hundreds of years, perhaps thousands. He would help us all he could but could guarantee nothing. From that moment on whenever Jason or I went near the Wolstonbury Hill area Damus would make a friendly 'grab' at us and we would feel his gleeful presence and a large smile would appear on our faces as he grew close. God knows what our passengers thought - "What the hell are you smiling about?" they would say. "Oh nothing, just thinking about someone I know."

Andy Thomas, Barry Reynolds and Martin Noakes already knew what was in the air and had their full support. Michael Green was notified and other trusted members of Sussex Centre for Crop Circle Studies who were in on the Cissbury Ring 'Transmission from Sirius' on June 28th 1994, and a date was set for us to

congregate at my place in Lancing to have a serious talk with Damus and to hear from him what should be our duties concerning the stimulating of the earth energy line that ran through our chosen site.

About a month later we all gathered to hear what Damus had to say and we were not disappointed. He 'came through' beaming and smiling and expressed how happy he was to be "working with humans again". He gave us a brief history as to how he was chosen to be Guardian of the Whistling Hill. (Damus's name for Wolstonbury Hill. He said that in time past when the wind was in a certain direction the hill whistled but now with the new roads etc it was a rare event.) He was a Druid, he said, but that was not what they were really called. He said the word was nearer to 'Drood' than Druid and anyway was a collective name for the many priesthood's in England at that time. He was chosen to take over from the Guardian BEFORE he died in the earthly sense. It was a very great honour and he was delighted to except. He had to 'strike the oak' six times to complete his promise that he would serve the area known as Wolstonbury. Damus was asked what we needed to do in order to pour as much energy down the line as we could. He agreed that crystals should be held that would amplify the energy.

He also told us that the use of sound was very important. Prior to our meeting with Damus I had dowsed out a chord of music that would, perhaps, resonate with the natural sound that each of the eight sections, or Courier lines, of a main energy line possessed i.e. 1st Courier line is C natural, 2nd Courier line is d natural, third courier line is E natural, and so on. The chord that I dowsed out was, A B Flat C Sharp D F and G Sharp. This was recorded and played for Damus to hear. He approved. A proper studio sound was later produced using only pure tones. The sound was eerie but very mystical. (Later folk were to say that the sound was very like the sound that had been heard many times before or just after a Corn Circle had gone down. Something that I knew nothing about.) Damus was asked on what date we were to proceed. He told us: "the last new moon in June, at sunset." Sunset and dawn being powerful times when the elemental forces, or Divas, were at their strongest. So we had the 28th June ... agin. By now I was beginning to lose him, or he was beginning to lose me. At one stage I

lost him altogether, after about a minute he returned. But it was a strain to hold on to him and he said his goodbyes and told us that he was at our disposal. What a nice man. Damus is tall with a very large, kindly face, a huge beard and long hair. And 'yes' he WAS wearing a long white robe! He also carried a very long staff in his right hand that had the symbol of a half moon at its top.

Meanwhile, back in the psychic workshop, I decided that I would seek out the help of one Jan Linch, a healer who uses colour and crystals in her work. We both knew that each Courier line that made up a major earth energy line corresponded in colour with the "Chakric"centres¹ in the human body, as we are, every one of us, linked into the earth energy grid whether we like it or not. (See later article: EARTH COURIER LINES.) Not only were the colours the same and the sound vibrations the same but there were crystals that also resonated for each Courier line and human "chakra". It will take too long to go into detail as to what represented what but the correctly corresponding crystals were found.

And so it was the long wait. Keeping the whole thing a secret was always difficult but necessary. Meanwhile Jason and Andy went and checked out the site at Saddlescombe to see where we could best sit facing the field. A route was finally found that would enable us to get somewhere near the top of the hill where easy access was available for a bloke being wheeled up a mountain. Namely me! Sadly we couldn't actually see the field in question but was assured by Jason, no mean dowser, that the line that we were to lend the weight of our bottoms too was *the* one. (I decided that this year I would write an Invocation instead of uttering one off the top of my head.)

Then came the part that shifted my perceptive. I got a call from Tony Mezen, a fellow psychic, who had received information for me, at 2 O'clock in the morning, the day before the experiment from someone calling herself Elle. "Do you know who Elle is?" I asked him. "No," he said, "I just got the name Elle." I told Tony that Elle or Ellen is one of the names of the Earth Spirit and that Lady Ellen was once my pet name for Gaia. Tony read the message out to me over the phone whilst I wrote it down. This is what it said:

"I am your Wyvern. It is the top, not level nor rocky, but earth on top. That is where Elle sleeps. But warning: do not wake Elle without magic iron. Bring song and word. But not when the sun sleeps, only in the light. Bring fire and water. Fire without soot, water without mud. Pure fire, pure water, earth and air are (as they are).

Move where the path leads. Only three, no more. One staff, three stones. Many lie there, with marks, without marks. Between two..." Message ended abruptly.

This message hit me right in the Solar Plexus. I knew I had to make sense of it. I KNEW it was a reference to the 28th, the next day! Tony had no idea of what we were intending. No idea that we were engaging in any sort of experiment, let alone the next day!

I read the message over the phone to Andy. I then asked him whether the description of: "It is the top, not level nor rocky, but earth on top." whether that fitted where we were going on the evening of the 28th. He said that it wasn't quite the top but as high as we could get with a wheelchair. It was indeed "not level nor rocky." The earth on top' he wasn't sure about. I told him that I was taking this message seriously and told him that I felt that when the message said 'Only three, no more. One staff.' This referred to Jason, Andy and myself. The staff was Damus! I told Andy not to worry; I'd sort it out. The reference to a 'Wyvern' was significant, a Wyvern is a mythical and Heraldic animal resembling a dragon.

INVOCATION

Dragon energy, or serpent energy is very often used to describe earth energy, or indeed the Kundalini energy. I charged some water to purify it then left it out in the sun for all of that day and the next. The reference to 'three stones' was to my mind perhaps, three stones that we would find on the top of the hill and decided to wait and see for myself. Meanwhile I got together an agate 'Fire Stone' to represent the 'Fire without soot' (the fire that does not burn), for the 'iron' I used a rare Iron Stone, or Bunge Stone that had been given to me by Tony many months before. I wrote another Invocation for just te three of us and 'knew' that this small ceremony with the Fire stone and Iron stone and purified water must be performed BEFORE the main Invocation and main activity of the whole group.

I didn't have long to wait. The 28th arrived. We all met up in the Jack and Jill pub car park, much to the annoyance of the landlord. We promised we'd be back for a beer or three later after we had a walk! We took two cars to the first gate up the hill of Wolstonbury. I was then transferred to the wheelchair where we made our way to the target, or 'Transmission area'. Those involved were Michael Green, David Russell, Martin Noakes, Barry Reynolds and his wife Linda, Karen Douglas, and

her boyfriend Steve Alexander, (who in fact was manning the video camera much further down the hill covering our chosen field,) Andy Thomas, Jason Porthouse and myself.

Earlier in the day I had received a call from Jason, whose job it was to dowse out which person should sit on what Courier line. He had a problem. For some reason which he could not fathom Karen was not supposed to sit on any of the eight lines. Jason asked me to check this. I got the same result. This was insane. Karen was a lovely lady and perfect for the job. How could we tell this sweet lady that she should not sit? Jason phoned Andy who suggested she sit on the number 9 Courier line! Now we weren't going to use number 9 because it was not fully activated, only working on 25%. However we dowsed this out and got a very firm 'yes'. I had to hurriedly come up with another crystal for her as Jason had found that I too must sit on a line, namely number 8, I had thought that I was to sit apart in case Damus wished to say something. That was not to be. Later on of course I found out why we had to use number 9 Courier line.

On reaching the top, just before the last gate, we stopped to rest and look around. The wind was so strong up there that you could hardly hear each other speak, it was also very cold, even though down at ground level it was, or had been, over 70 degrees. We just weren't dressed for it. Andy lent me his sweater. I noticed that we were standing between three tumuli, two on one side of the 'path' and one or more on the other. I 'knew' there and then that this was where 'many lie there. With marks, without marks. Between two.... I 'knew' this was the place where we must start the proceedings, Jason, Andy and I, this was 'where Elle sleeps': the sleeping dragon (energy), the life energy of Gaia Herself. The Tumuli (man made earth mounds) carry the remains of the ancient ones. Perhaps these burial mounds were once 'marked' with stones, now fallen and carried away.

CROWN CHAKRA

Time was running in all directions and the sun was making a rapid decent before it melted in its own crucible to be cast once again to ring the changes for the new day. We intended to start the main proceedings at 8-45. Meanwhile David Russell had marked out the 9 Courier lines for us all to sit on. David also found that each line went in the opposite direction. One flowed toward our field the next would flow the other way. Michael Green checked David's findings and found them sound. Each was allocated their particular crystal and were told that at the given time they were to open their Crown

Chakra (like a flower opening on the top of the head) and bring down the golden light of the Christ, take it into their bodies, then let it stream out through their solar plexus and into their crystal and thus into the ground in front of them. This we would do for 30 minutes from 8-45.

At about 8-20 Andy, Jason and myself made out way back to the burial mounds. To Andy I gave the Purified water to sprinkle on the mound, or very near it, as we couldn't get beyond the fence, at least with a wheelchair! To Jason I gave the Ironstone, for my part I had the Fire stone plus a small written Invocation to Lady Ellen (or Ayesha as Joeb calls her). The three of us crowded near the edge of the mound. I read the Invocation. I felt the strong presence of Damus. At a given point Jason buried his Iron stone. Then it was my turn to bury the Firestone, after which Andy sprinkled the area with the holy water. Damus came on strong then. I felt him raise his staff and plunge it into the earth. After a few minutes we made out way back to the others. "I don't know what you did over there, Paul," said David Russell, "but the lines have shot up in number from 9 to 18 and then up to 27." Something was happening!

I read the Invocation that I had worked on days before. We called on Lord Michael, Lord of the Angels of Light and mediator between the Human race and the Devis forces. We made out request for their co-operation with our project and that it would be granted. I asked that Damus would be supported in his work. We asked that we be guided and sustained and that all this be done in the name of the Light. So be it. Damus came through then and had us start the proceedings. It was 8-47. The musical chord played constantly and seemed perfect for the job. 'Bring song and word', we had done that. 'Not when the sun sleeps' (at night) we had done that. No one pretends that meditating in that high wind was easy but at 9-10 Damus brought the proceedings to a close. I felt a lot of energy and so did Michael Green, but we were so cold. David Russell did a spot dowse. The lines had now risen to 72! We came down the hill full of hope but expecting nothing. I was cold and tired and went straight home to bed.

The next day I waited for the phone to ring. Nothing happened! I thought to myself: another psychic dead-end. That night Damus paid me a call: "You have done far more than you know. The number 9 Courier line has now risen from 25 per cent up to 40 per cent. I glimpsed Lady Ellen. She told me about three circles that had been formed. She was smiling warmly. I was tired and wanted to sleep. But this was so strong. The next morning I woke refreshed

and immediately dowsed the 9th energy line. It had risen from 25 per cent to between 40 and 45 percent. I couldn't believe it! I tried to phone David to check it out. He was out. I left a message on Jason's answering machine to dowse it out. I phoned another fellow dowser Hilda Bell and asked her to check it out also. Then the phone call! A crop circle had gone down in East Grinstead at Imberhorne Farm near the A22. According to Barry Reynolds it connected in a straight line to Wolstonbury Hill. I needed this confirmed. Then I got my first call back from Hilda. She confirmed it. The energy had risen to at least 40 per cent. Jason phoned in. He got between 40 and 45 per cent! Meanwhile David had got the correct map readings from Barry and confirmed that the crop circle was connected to the energy line that we had meditated in but that it had GONE DOWN IN THE OPPOSITE DIRECTION! The energy we sent had gone not to Saddlescombe, but to East Grinstead!

Not only that but the farmer was extremely friendly and so was his staff, plus the fact that I could, for once, drive my car to within 50 yards of the formation. The farmer told us that he had visited the field on Monday and Tuesday and one of his men had checked it on the Wednesday and there was no formation. But on Thursday morning there it was! After David had told me his findings I asked him to check the number 9 line. David got 40 per cent! I asked him to check whether this was global. I heard him mutter: "You bugger!" He told me that the pendulum swung back and forwards. Which meant neither yes nor no. Jason tried it and got the same effect but when asked whether the energy was spreading around the grid he got a 'yes', and so did I.

I kept wondering about Lady Ellen and the THREE circles. Perhaps the others would appear soon or have just not been found yet? Barry Reynolds had already suggested beforehand that he believed the six notes in the chord that I had dowsed out might result in six circular elements in any resulting formation, worked out from the diatonic scale. He phoned to tell me that this indeed corresponded with the six rings and circles found in the formation, each ring being of a different size and resonance! I asked Barry to tell me, as I hadn't had a chance to visit it yet, what the formation looked like. He described THREE SEPERATE RINGS riding due east west. "Did you say three SEPERATE rings. I mean not superimposed on one another?" "That's right," he said, "one ring at the top, the second ring underneath containing a single ring within it and a

third circle containing two rings!" "So that's what she meant!" I almost shouted. "She meant three crop circles IN THE SAME FIELD!" I wasn't going balmy after all. (Tha's a matter of opinion, I hear you scream.)

But to cap it all, and for my money put the lid on it, we had three circles that corresponded in size to six circular sound elements, the very sound that we had played during that wild and windy time atop Wolstonbury Hill!

At the last count the number 9 line has risen to 47 per cent. My understanding is that it will not be 100 percent until 1999. But the way things are going. Who knows.

COSMIC SCHEDULE

My information HAD been that the number 9 Courier line would not go up in strength until the end of July, beginning of August 195. Looks like the cosmic schedule has been brought forward somewhat. I also believe that what we achieved concerning the 9th line will become global by this same date. "These are the days of miracles and wonder, don't cry, baby, don't cry." We're heading toward a greater reality. The Truth itself never changes, only our conception of it.

After all these years of trying it would seem that at last one of the Circle Makers has taken us into their confidence, that Circle Maker was the Earth Mother herself. Perhaps it just took patience and trust mixed with dedication and love to come up with the right formula. Whatever it was we owe it all to forces outside of us who seem intent on plying us with knowledge.... a tiny piece at a time.

FOOTNOTE: As I understand it the 'iron' and the 'fire stone' (agate) was an alchemical process. The two elements, a cocktail of two frequencies, needed a catalyst to release the energy they produced. The catalyst was the 'charged' water.

High Strangeness

Continued report on the strange incidents of Ray Wardle

Interview between Ray Wardle and Matthew Williams conducted Winter 1997.

MW: I know that you have had a lot of strange experiences and that your video footage and explorations into Area 51 have got you into some trouble. Readers have already heard about the incident in a hotel room during a UFO convention where you were drugged and hypnotised by suspect "UFO researchers". Can you tell us something about your other experiences.

RW: I had a strange experience whilst driving in the desert one time. Out there the speed limit is about 55 Mph. I started to pull over, when I heard the siren of a police car. Now, not only was there no police car but there were no other cars at all. I was on my own. The very same thing had happened to me previously. I thought that I must be tired and had imagined it but since it happened a second time now I am wondering if I didn't imagine it.

So after I thought I had been stopped by the phantom police car I drove another 10 miles to my home. I got in and then went to wake my wife, who was asleep on the couch, and the time was around 20 minutes after 3. I never realised back then that I had a period of "extra" time there until I looked back after the whole five days of that week.

ELECTRONIC NOISE

I was with my wife back in 89. By this time the weird stuff with the saucers, my filming them etc, had started happening but not to any great extent. It was an October evening and was very warm and was bright with moonlight. So my wife and me were on Highway 168 which runs between "I93" and "I15" so it was a small and very lightly travelled road, except for this night! As we drove along and looked around we had seen some odd lights in the sky. They were way off in the distance and could really say if they were this or that. Then we heard this noise - an electronic noise. We had a full 360-degree view and we could hear this sound but could not see where it was coming from. The noise kept coming closer and closer and in the end, when it got to be about what sounded like 12 feet away. I was then so scared that my knees were knocking. This is odd because that is not normally how I feel I would react to something like that. I remember myself saying, although I don't know why I said this - "It's the human

element that is scaring me".

There was a gap, at the time I wasn't aware that there was a gap, but suddenly the object/sound is in the distance going away from us. Now instead of me being frightened I am calm and relaxed. My wife and me then decided that we would go straight home. If I hadn't have been so scared in the beginning I would not have noticed the gap, but it was the stark contrast between one minute being scared and the next feeling fine that shows me the possible gap or time-loss.

When we get home my wife goes to the bathroom and I get ready for bed. We are both very tired. When I got into the bathroom I noticed a scar on my left shoulder which I didn't have when I went out. There was also a scar on my right upper chest. A scar is the only expression I have for the marks. I have never had any marks there before!

There were other strange things that went on, little things, too many to remember and some that I have forgotten now that caused me to be in such a state that I would come home frightened by what I expected I would find in the house. In time you would find me coming into my house every night with a 357 (gun) in my hand. There was one day where I thought I would set up surveillance in my house to see if I could catch some strange things happening whilst I was out. My regular job was in setting up surveillance in Casinos and so I knew exactly what I was doing.

When I would get home I would review what had been recorded on tapes that I set recording. This particular night I was viewing about the last hour of an 8-hour tape and then I noticed the sound had died down. I thought it was the batteries of the active microphone that was being used. I later found that the batteries had gone from the microphone! The funny thing was that these had vanished in view of the camera because the microphone was in plain view of the camera; so there was no way that somebody could have taken them without being seen! On top of this I eventually found the two batteries and they were placed inside the sleeve to a Liptons tea bag - the pouch you get with dip in tea bags! Now if I drunk a cup of tea in a year


that would be it because I never really drank tea, so these tea bags had been there for goodness knows how long! Still on the night that this had happened I decided that I wanted a cup of tea and low and behold there were the two batteries. That is odd, and nobody could tell me that this was coincidence.

This got me more interested and I decided to have another look at the tape. So when I ran the tape again, up to the point where I come in to the house that night. I do not appear to come into the house - I just appear out of the blue! Also behind me there is a light from the back bedroom of the house, which I was sure wasn't switched on that particular night. Another strange thing is I looked at the tape on freeze frame and it doesn't look like me for the first second and then it does. It is made more obvious that I did not edit the tape because you see me at the very last minute picking up the remote control and pointing it at the camera and you then see the infra red flash as the remote is activated. I still have this tape although I don't know what use it would be, as I cannot work out what is supposed to have happened here.

WEIRD VIDEO

I have got a lot of weird video footage of this and many other things. I have got too much footage! I think the air force and the military have got something to do with it for sure.

MW: Can we talk a little about the incident in the Hotel. I saw the video of you in the hotel room being interviewed by Miles Johnson. It appeared you had been drugged

and hypnotised by suspicious people at a UFO conference. The film shows an unusual blanking of the audio, which should not have been there. Can you explain about this?

RW: I don't know what all this is about; Miles has got all this nonsense stuff on there (the videotape). I mean I am not saying that it didn't happen - just that it is nonsense - (i.e.) it makes no sense to me. I have no idea what took place. But then this happening is no more nonsense than what happens so to me in general. I don't recall the interview at all, you see. I didn't even know that Miles had taped me and that the thing existed. Miles sent my parents a copied tape of the hotel room interview and my parents are telling me about it and I am saying to them, "nah I don't know what this is". It wasn't until June or July of the next year that the tape got to me via Bill Uhouse.

Well actually I remember bits about what happened. I think I wrote notes about the situation but upon reading these notes back, they didn't make sense. I can remember thinking that the whole situation seemed nuts, like a sketch out of Monty Python. Vaguely I can remember being on this bed and there was a red head (woman) on the other bed. I can remember at the time thinking that they were a bunch of perverts and they wanted me to "give her one" and for them to watch <laughs>. I am laughing because it helps me with looking back on it.

DRUGGED

MW: Were you taken against your will.

RW: I was taken against my will for sure, somebody drugged me, that's for sure! It took me a week to get over it. I think that somebody forgot to take me out of a trance state or something. Was due back in work on a Wednesday. I phoned up the insurance people and said I needed to find a hypnotist straight away, well working for security at a top Las Vegas casino and asking the people there to get you a hypnotist doesn't sound right does it... Then they wanted to know why. I had to tell them that somebody had hypnotised me and forgotten to snap me out of it. I know it sounds "nuts". My wife was looking at me in a strange light and she found it hard to believe.

MW: What about the footage you have got which you allege shows you being shot at from a helicopter.

RW: I tried to get it shown on TV. London Weekend Television have got the tape, CNN have got it the FBI have too. The FBI sent me a fax back saying that they see no reason to investigate it any further. What, are they mad? I go to internal affairs over

this - there are some people from Internal Affairs who get heavy with me.

I can tell you something else, which I can't quite come to terms with either. Miles Johnson says he came to see me in Vegas, I don't think it was Miles Johnson who came to see me in Vegas. I don't think he even got to Vegas - he may have a memory of being here but I don't think. When I met him at the airport that was strange because he was shorter than I remember him being. Also he wasn't such a big build as the Miles I remember. When he was waiting for his luggage he let his bags go straight past him and didn't spot them the first time. They are very distinctive aluminium flight cases and he lets them just go straight past.

Miles is a good drinker and he can certainly knock back his pints of Guinness. Well not this Miles - he drank one and a half bottles of beer and he was blotto. I thought that he must have been tired from the trip.

Thinking back another strange thing was whilst I was waiting for him at the airport I was instructed that everyone who had got off the plane was coming down the escalators. I was waiting at the bottom for him and all these people who had just arrived came down and he wasn't one of them. The next thing I see is Miles coming out of a door marked private on the ground floor.

{I checked with Miles Johnson. Miles does remember the door being marked private. Miles did not know the style of the airport and doesn't think this was strange. He seems to remember all of the events of his getting off the plane. -ED}

There is a shot of Miles in my room when the video surveillance camera is on. He is there looking in the mirror and this is the only shot I have of him on video to prove what he was looking like whilst he was over. I think I still have this on tape.

Miles was supposed to have come from Ireland to London to get on the plane, which would take him to Las Vegas. He was getting to Vegas because he was fogged in. Then suddenly he changed his story to say that he came direct from Shannon to Las Vegas and that he was fogged in there. I brought this point up and said "hang on, you just said you were coming from London." Besides that I checked to see if there was any fog over in the UK and I found that there was none, not even anything close to fog.

{Miles later explained this as bad

recall from Ray - and his version is that the mix up was due to fog and that he had landed at Cardiff Airport as a stop before going to London. Miles says that Ray probably didn't hear him correctly - MW}

RW: He was booked into one hotel, but decided that he didn't want it. Apparently he had booked himself in on the wrong dates also. I don't quite know how he could make that mistake, but he did!

We were driving through Las Vegas and I was chatting to Miles about a few things. I knew that he had a Toyota Supra (car) back in the UK - I have been in it. When we were driving along a Supra passed us and I pointed out that it was the same car as he has. He said "No, I've got a Celica". I said that last time I had been over he had a Supra and to this he got really angry and snapped at me and said "No, I've got a Celica! I should know what car I have got!" The way he reacted was quite strange. Also the guy usually had a big appetite... Not over in the US.

I haven't spoken to Miles since all of this happened anyway. He doesn't speak to me anymore - I don't know why.

MW: I know that he attributes the strange events at the Hotel where you were abducted by humans and drugged and the subsequent strange effects on the video recording sound. He is now convinced that you are carrying around some sort of negative spirit force or energy with you and that if he bothers with you that this will in some way rub off on him.

RW: Well I wouldn't know exactly - well perhaps there is? (laughs)

MW: I heard that there was an event whereby somebody had seen you change in physical appearance from human to reptilian alien in appearance. Do you know anything about this?

RW: I don't know anything about it. Ohhh (pauses) I don't know what you would call it. Something channelled itself through me - I know that. Then I go to channelling sessions with people such as Darryl Anka. He channels "Bashar". I was doing automatic writing stuff at that time and my wife read it and tore it up and was very upset what I had written.

(Ray backtracks) The entity that came through me seemed to be able to switch "me" off and work directly through my body. It is as if I wasn't there and didn't know what was happening - like as if I was in a corner somewhere, except for the one time when I was still in control of my body and

"it" (the entity) told me to ask my wife a question. I was to ask my wife "What was your reaction when I told you I saw the saucers through the window." Her response was "I don't remember you telling me anything like that", which shocked me. The entity, or whatever it was, then said to me, "Point made". It had made a point actually. It made a very strong point. The same intonation and tone and sound of that statement "Point made" I heard on a channelling tape of Bashar recently. {which was taped via an internationally known channeller}. Reflecting back on the incidents which occurred during that period I wish I had asked the entity to identify himself.

{Ray has since explained that the entity was making the point that his wife had forgotten an important and memorable event – the event was where Ray had seen saucer shaped UFOs through the window of his house. The entity was trying to show that for some reason Ray's wife had forgot the event, was made to forget or perhaps, more strangely, was somehow not present when Ray is left believing that she was. How these or other things could be possible were not explained by the entity, but the fact that the entity was able to show this lapse seemed important to Ray. Incidentally Rays wife came to see the same saucer two weeks after the initial sighting.– ED}

IMPLANT

MW: Has anything strange happened to you recently?

I have obtained an implant in the last few weeks. I have a scoop mark on my right thumb. It actually fooled me because on occasion I have arthritis on the left-hand thumb. It flares up infrequently and it is painful when it does. When it did I thought that it was back. It took me two days to realise that it was the wrong thumb. When I realised and I looked and there was a scoop mark there. I actually know about a scar on the left thumb and the reason I remember this is because of the earlier injury on that thumb that I now have arthritis. There was no such scar or mark on the right thumb until this scoop mark recently.

MW: Was it true that at some time in the past when you were in the services you had a UFO encounter.

RW: I was in the Royal Air Force. I saw an object. I was with somebody else who saw it at the same time and I can't remember who that person was. This bothers me. Also I didn't remember that I had seen the object for a lapse of 25 years which also bothers me greatly too. It is in the book Above Top

Secret and it is not how it happened. It was implied that some guys were drunk. I was 16 years old at the time. Had I been drunk then they would have locked us up.

I've had some flash backs of working in an underground base somewhere. I know that the base is about 20 Miles up the Newmarket road, twenty miles exactly - up from Oakington. It was on the left hand side and it was named "Eureka". At the time it was an abandoned airfield and a bombed out control tower and stuff. I had a motorcycle and I had to cover it with tarpaulin and walk across to a trapdoor and get down via that entrance but I can't remember any more than that because for some reason it hurts when I try to think of those things. That memory is blocked by pain I know this much. I didn't even remember that memory until one day I was driving in the desert. Goodness knows what went on down there in that underground base.

Still I can't believe that somebody aged 15-18 is going to be privy to anything of any consequence, that's for sure, unless by accident.

MW: The Las Vegas footage you shot showing the lights, can you explain what is going on there. Well I looked at that footage the other day and realised that there is more going on there than I ever realised before. There is stuff on the mountain. I also made a mistake and thought that the mountain that I was photographing was the one with the antennas on it, it is not. It is the other one - the aerial mountain is on the left of the range. I can't understand how I made that mistake. The new UFO looks like an upside down triangle with lights on it. I know it shouldn't be there.

Let me tell you something else. March 28th last year, I went out with a couple of guys to Area 51. We saw some strange stuff, it was at night and I didn't bother to record it. Early in the morning just after dawn there were B2 Stealth aircraft flying over Groom Lake and as one was banking suddenly I realised there was no ambient sound around me and also there was no engine sound. Suddenly the aircraft dissipates into a cloud and completely vanishes. I have it on camera. Nobody has seen that yet.

After the interview I checked some details with Miles Johnson

Miles said it wouldn't have occurred to him what Ray was thinking about whilst they were together unless Ray had told him. Miles claims that Ray did not mention

any of this to him. This is why until I mentioned these things Miles had not wondered about this. However he does vaguely remember Ray mentioning something about Miles not being quite the same.

Miles does not remember any incidents at the Airport with any mix up over baggage.

Miles thought that Ray's reactions to him were a little strange and that Ray was disturbed about something but Miles doesn't think that anything else was odd.

Before his arrival in Las Vegas, Miles had his guard up because he had a dream telling him that Ray was a reptilian alien. This was only a dream and Miles never saw anything of the sort whilst awake. The dream was quite unexpected but because it disturbed Miles he had shut off his psychic abilities, so he would not to pick anything up – Miles "just wanted a nice holiday". Miles says that for this reason when he got the airport he was not using his sixth sense and some unusual psychical events may have gone unnoticed by him.

Away from the Ray situation Miles did observe that the taxi drivers and everybody he met seemed to be aware of his arrival. Some people he met at the airport were acting almost familiar with him and they had never met him before. Apart from this Miles saw no strangeness between him and Ray up until the point of after the Hotel interview when it was realised that some odd energy had attached itself to Ray - which was confirmed by a number of psychics. It was at this point that Miles started to keep a distance from Ray.

110101 HACKER 110101

Mathew Bevan is a 23 old computer hacker with an interest in UFOs. Recently he made front page world headlines when he was charged with hacking offences which included access to the most secret military computers of the United States Military. Mathew was able to access computers, which had the ability to launch nuclear missiles or other missiles. Described by one pentagon spokesman as being "The biggest threat to world peace since Adolf Hitler", Mathew Bevan talks to Matthew Williams about how he did it and the fact that whilst in Wright Patterson Air Force Base computers he saw plans to a secret Anti Gravity propulsion engine....

Matthew Williams: How many years have you been into the Internet.

Mathew Bevan: Since about 16. It was a case that over here there were very few Internet providers. The only one was Demon Internet and the closest phone number to dial was in Bristol, so it was just easier to do a free (hacked) phonecall to the States and use a free provider and not worry about paying any bills.

MW: How does one "hack" the phones - what is the procedure involved.

MB: You use a little program on the old computer... The Amiga was the first computer to be used for "Blueboxing" (hacking phones) and the reason was that it has four channels of sound whereas the PC could only go "BEEP". To get the blueboxing to work you had to play dual tones into your phone. There was a set of frequencies of tone not dissimilar to DTMF which is on most modern phones (DTMF - the tones played when you press a number on your phone keypad). When the special tones were played it would cause the network to do a number of special things.

What you then needed to do is to call a 0800 number for a foreign countries operator service - such as Columbia or Hawaii. You would play a few tones down the line and it would cut the operator off and BT would think that you had hung up the call but in fact you were still in the trunking system and you play a few more tones and you could re-route your call anywhere.

MW: Is it complicated to do these things because playing sets of musical tones down the phone line sounds quite complicated and what if you make a mistake.

MB: Well it is complicated but is a case of playing around to see what you could do. If you make a mistake you just hang up and try again. There were some other interesting things you could do like dialling a number and when you get the engaged signal then play a couple of tones and break into the call and listen without the two parties knowing you were there.

MW: You are saying that there are ways to listen to calls without being detected and this can be done from any home phone with such codes! Are you saying that you could

listen to another call anywhere in the world?

MB: Yes but most of the time I was calling into the States anyway so that's where I did it the most. I think that secretly listening in is what it was designed for.

MW: So when did you go from hacking innocent university computers into hacking the military computers?

MB: It was a case of getting onto a system and getting the password file and then running the encrypted passwords through a code cracking program so that you get the passwords. Once you have the passwords then you can get a higher level of access and get into peoples files and folders and you can monitor the system to see what it is happening. You can see that there are people that are themselves who are going from computer to computer with legitimate reasons. Now it would just happen that some of these people would be working on projects with the military. You could find that a professor would be contacting a military site (computer).

One would get fed up with doing small computer systems and would want to try to hack something bigger.



The thing with people is that they tend to like the same password for multiple systems and so if you have hacked their account on a relatively unprotected system then the password will probably work on another more well protected system. The professor probably has some silly password like "professor" on the university computer and more often than not would use the same on a military system.

It is not a case of sitting there typing in millions of passwords and hoping that you get the right one. There are much more intelligent programs to do that for you and get you in to a system.

We now use things called SNIFFERS, which are covert and do not harm the system in any way. These sit in the background and watch for people's passwords and they send them back to you. This is something that I was charged with and the offence read "modification to a system with intent to impair the operation of the computer". Well the whole point of a sniffer is that it sits there and nobody knows it is there - if it did any harm we wouldn't use them.

Well once inside you would use various hacker techniques to bump up your access level to that of systems administrator, so that you would have the entire system under your control. You could connect to other systems on the network with the same authority. You could monitor people's emails and you could get into their project folders and look at their research and development work or papers that they have written. Occasionally you would get into somewhere that was quite interesting but it wasn't always that way. Most of it was quite boring. Back in the old days before Internet Browsers that give you nice pictures and buttons to click on, it was all text based and you had to use the keyboard to type commands. There were pictures, but you had to manually download them and view them "offline".

MW: So what were the most exciting computer systems you hacked?

MW: Firstly there was the FLEX system. This stands for Force Level Execution, and this is the thing which the News of the World newspaper picked up on. The reason this system was of interest because it had control of nuclear missiles. To explain what this

program does; the official line is to plan an air war and to find out what things are incoming and what air strikes are pending. The system would then advise you of where to strike next with the best killing ratio and where to launch you missiles etc. From looking on the computer and through the "source code" I got the impression that the system had direct access to real missiles. What type of missiles I do not know and the News of the World printed that these were in fact Peacekeeper Missiles, but that didn't come from me - I don't know where they got those details from...?

The easiest comparison I could make is that it was a very similar system to the Skynet System in the Terminator movies. This means that the computer has access to all available information and can make intelligent decisions about how to operate a war and even control the weapons.

Of course the FLEX system is secret and something that they do not want the public to know about and the fact that weapons are controlled solely by computer. You would think that there would be other failsafe system but, as far as I could tell, that was not the case.

There were other systems such as Wright Patterson Air Force base and White Sands Missile Testing Ground, some now I forget - I went to a lot. I had been to so many I had to tell the police that I could not remember all the systems I had been in.

The lawyers couldn't get their stories straight even for a trial of this



type, which you would have expected. They would not present evidence to show how I was able to hack into their systems. So with the details of the computer systems real purpose having been removed from the case then I am now pretty sure that I did have a good idea about the real function of the programs - they didn't want this information out in any form. This was probably the reason that they were so pissed off about it because I came forward and told everyone. You see after I was arrested then I started to get some very strange phone calls from people claiming to be in the military, Koreans and other people. I had weird semi-threatening things said to me and this is why I moved away to get away from these treats and this is another reason that I spilled the beans, in order to keep myself and my wife safe, after all what is the point of silencing me after I had talked.

MW: Where were you living and did the police give you any assistance in your moving because of these threats.

MB: Firstly I was living in Grangetown and then I was moved by the benefits agency to another location. They were aware of the court

case and the sensitivity and people from Scotland Yard were helping in this respect also. I was given a new name under the benefits agency computers and was living under name of Mr Smith for a while.

MW: Why do you think they were prepared to go to this trouble to help you?

MB: What you have to understand is the fact that there was a big Senate hearing on the fact that two hackers had got into secret computer systems. One of these was a 16-year-old who they had arrested and the other person was supposedly thought to be a foreign spy who was paying the 16-year-old for information. I was made out to be the foreign spy and I was prepared to believe from the threats I was getting that these people were serious. So I had to move home.

To give you an idea of the level of the ominous phone calls I was getting, at the time I was just about to change my phone over to British Telecom. Just days before I was arrested I was due to sign the BT phone forms and send them off, but had not done do at that point. Then I had another threatening phone call and I told them to **** off and said that I was now having my number changed. The voice on the other end of the line said "yeah we know that your new number is going to be 01222 233blah blah blah" and so they knew my new number already! My wife asked often who was speaking and one name we got was Chung Lee Makasaki and he gave some phone number in China, I think.

MW: When you were arrested what happened?

MB: I was working at Admiral Insurance at the time in their computer department for around a year and a half. One of the managers came in and asked me to come and have a look at one of their computer systems and I got up and went with him. I went with him to the MDs office and there were seven people in the office, your typical men in black so to speak but as this was the MDs office I didn't at first see this as abnormal. When I got inside one of them said to me "Mathew Bevan" and I replied "yes" and then he put up his hand and said "I am placing you under arrest for hacking of NASA and various Air Force bases." I was standing there stunned and I was going "Oh, gosh... ummm." They then told me

that they were going to search my desk, which they did, then they took me back to my house and searched there too.

When they got to the house they took all my X Files videos and X Files posters and the reason was because the "KUJI" hacker that they were after had a computer user description which read "The Truth Is Out There". So they wanted to use the X Files material to prove that they had the correct "KUJI". They just wanted to pin me on anything they could. They took all of my computer kit as well as my passport.

During the interview I agreed that I used the handle 'Kuji' and afterwards the police gave me my property back such as the X Files videos, posters, monitor and the keyboard back but they kept everything else.

I was taken to the Central Police station in Cardiff. The officers were from the computer crime unit of the Met Police. I believe that the C.C.U. also uses the code S.O.6 which leads me to believe that they are intelligence (MI6) related but I don't think they would admit that.

MW: What was the atmosphere like in the interviews?

MB: It was a good cop bad cop scenario. The one person was very nice and the other guy was quite nasty and was giving snide remarks and shouting at me. There were bits in the interviews that were really stupid too where I was asked by the nice cop if I had any political leanings and I said no - then the other cop stepped in and said "Yeah, but your a vegetarian" and he then said "So you do have a leaning then.". To this I then replied "Well if being vegetarian is a political leaning then I plead guilty!". The other copper then steps in and make a lighthearted comment and then the other one steps in again and says "ah so you indicate a leaning then" and so on.

I was under arrest for the best part of 36 hours but there was about 28 hours spent in the cells. I wasn't allowed to speak to my wife or anyone else. They threatened that they would arrest my wife and I pointed out that she knew nothing about computers and they said tough because they would arrest her anyway. This was part of their oppression tactics. I said

what do I have to do to stop you arresting her and they said that if I co-operated then they would not arrest her. So the only telephone calls I was allowed were to my solicitor because they didn't want me to tell anyone I had been arrested.

One thing I didn't realise but found out was the fact that in Cardiff police station they bug the cells with listening devices and recently a few people have had tape recorded evidence used against them when they have admitted to things whilst in custody. This is immoral but they seem to be able to do it.

MW: What sort of specific questions were you asked by the police in the interview.

MB: They asked me about the Rome Labs computer and if I had placed a sniffer program on the computers. I would not admit to this. They also asked me about Goddard Space Flight Centre and Wright Patterson, I admitted to these but was never charged with them! They don't charge me with the right things. They then charge me with conspiracy with the other hacker, but by the time they realise that they don't have any evidence to prove this it transpires that they could not charge me with the original intended charges anyway because they are out of time by 6 months; They would have had to charge me with a summary offence within six months of my arrest. They also found out that they were out of time for a 3-year clause

The Americans position in court was that they claimed that they had to spend ½ a million dollars to repair their computer systems. A fundamental question that my defence asked was could we see a backup of the system to show before and after these so called repairs to prove what was being claimed. The Americans said that we could not see the records because they were so sensitive and also said that it was not in the jurisdiction of the British courts to order them to show the files. If it were any other trial then you would ask how could we accept this evidence but because we are asked to take the Americans word, this is supposed to be good enough.

The next thing that happened was that my barrister had meetings with the prosecution and he then turns around to me and says that he feels

that they will find me guilty on some charges so I should give in and change my plea to guilty. So I 'relieved' him of his professional duties and got a new barrister who was then completely on my side and who felt that I did indeed have a worthwhile and quite solid defence.

MW: What was the final stage of the case and how did you get acquitted?

MB: The judge surprised everyone by saying to the prosecution that because my charges were lesser than those of the other hacker and that the other hacker had received a small fine of £1200 then my sentence at best would be non-custodial so to proceed with such a case would not produce a large penalty whilst the costs for running such a case would run into millions. It was estimated that if I would be found guilty I would get a £450 fine and considering that the court's daily costs would be £10,000 it would not be worth it.

However the prosecution was determined still and said that they would still proceed and then at the last stage they pulled out and said that they wished to offer no evidence and that it wasn't in the public interest to run the case. Verdicts of not guilty were entered, this being the equivalent of a full acquittal and so ensuring that the police would waive the right to re-arrest me in conjunction with these charges.

This being the case I was then free to admit to the press and everyone else that I had in fact done some of those things and that I did hack those systems. This pissed Scotland Yard off immensely and they are now being very awkward about returning the seized goods that are in evidence storage even though the case has been dropped.

MW: How were you tracked down?

MB: I cannot be sure because this was never disclosed - I have my suspicions that I was grassed on by a hacker. They said they found my number on somebody's computer system and traced me back like that but I think somebody told them who I was. The point was if it took them 2 years to find my number on the other hackers hard-drive as they claim then that is incompetence, as a search of a 250meg drive takes less than five

minutes.

MW: Where does the story take a turn to where you started hacking military sites for UFO information?

MB: In a hacker magazine called PHRACK, it gave a list of sites that people who said they were interested in UFOs would like to see hacked and that hackers should check these out. Allegedly there were forty people who were trying to penetrate these sites and they got into some of them but they all went missing?

MW: A group of forty people went missing?

MB: Apparently so. They said in the magazine that if you were going to do it then do it carefully and printed a list of the sites. I used that list and used it and I also used some of the folklore of UFOs like "Roswell wreckage taken to Wright field", "Lockheed space missile company have connection to Area 51" etc. It is then just a case then of picking up the addresses and names of these computers. They are quite easy to find as the military provide you with as much information on their computers as you could ever want.

It was a case of "go for it", "lets have a look". As far as I was concerned I was not traceable and not causing any harm to anybody. If I couldn't get in then no big deal, if I could then I was not going to screw the system up.

MW: You did gain access to some interesting UFO type files - what were these?

MB: The information was obtained through the Wright Patterson Air Base computer system. I was looking for information on the Roswell crash. On one of the computers at Wright Patterson the systems administrator was very un-secured. Captain Beth Long was the system administrator she is supposedly working in a pumping station in Alaska now instead of working at Wright Patterson - the reason being, because she had no password so this meant that anyone logging in as her meant they had the highest level of access on the system with no password needed!

Wright Pattersons' computers were strange because unlike all other computers I had hacked which had

clear warnings to hackers and people using the system regarding the classified information, their system had a banner which read in flashing red letters that no classified information is to be stored on the computer system. This throws you a bit. I was unsure if it was a real banner or if it was to put off people who had got that far.

In getting into that there was one machine on the network where I read current files and future project proposals. I read documents which gave me the impression that they had an anti-gravity engine which was capable of at least Mach 12 to Mach 15. I don't know how exactly how fast that is but I think that is faster than most aircraft we know of today. Supposedly the aircraft which employs this engine uses a reactor to which there were a lot of detailed numbers and figures for, but I have no idea what all this meant. I can remember that the documents referred to a super heavy element, whatever that means. The element is the main fuel for the reactor. The engine worked by making a disturbance of molecules at the front of the craft so that it was able to stop the inertia or G-force inside the craft. I got the impression that this information was the type of material I was looking for because it was far in advance of our current technology and could be something to do with the Roswell UFO. Finding this threw me because I didn't know if this information was a disinformation exercise and that people were meant to get in and find this stuff or if it was real. I can't be sure and this is the one annoying thing.

In the interviews that were carried out with the police Wright Patterson was mentioned. Officer D S Janes asked me, had I been in there and I said that I had. He then asked me if I had got any information from this computer and I said that I had found details of an anti-gravity propulsion system. He asked if I downloaded any files from this project and I said no and I had only read the files online. As I said earlier I admitted to this but no charges were brought against me on this matter which is a bit odd. Then the interviewing officer asked me if I knew what Hanger 18 meant. I said "well if you are thinking of a building where they store extraterrestrial aircraft then this is what you might mean but perhaps you mean it is a computer or a bulletin board - is this what you mean?". He replied that this could be the place that he was thinking of. This was the only

time that Hanger 18 was mentioned in the interview.

In one of the hearings at magistrates' court there was a special agent who came over called Jim Hanson. When asked what did he feel I was trying to achieve by my hacking he said that he believed I was not trying to do any harm but was just looking for information on Hanger 18. The prosecution then asked Jim Hanson in a light-hearted manner if he could confirm if Hanger 18 exists and Hanson responded "I can't tell you that because I am not party to that information".

What surprised me is the fact that I was asked about the little known Hanger 18 story instead of somewhere well known such as Area 51. Some members of the press alluded that I had hacked into Area 51, but I never said this and I refused to comment on the UFO issue to them. There were things I was not prepared to talk about to the press because I was not sure if I would be able to sell my story or not, so I did not want to give the information away.


The point was that I knew where Wright Patterson airbase was but I didn't know, until I read a UFO magazine recently, that Hanger 18 was located at Wright Patterson. This was the first I ever learned about this.

When you put it all together it seems weird - the fact that I hacked into Wright Patterson and found details of a secret gravity engine and then the coppers asking me about Hanger 18, even to have a secret service agent in an open court saying about Hanger 18 and then me later on finding out that the two places are the same.

MW: Wasn't there a ban on press

reporting of your case?

MB: The press were there and they heard many interesting things which they failed to print but yes there was a ban on reporting the case, they said because they did not want the press opinion to influence the case in



any way. This is the principal of subjudicy.

The prosecution had originally intended to have the case heard in secret (In Camera) but we did not allow this to happen.

MW: Have you ever seen any UFOs yourself?

MB: There was a time when I was going back to Newport from Cardiff and there were two very faint lights which were like passenger plane lights at first. They looked like they were going towards Rhoose airport but in-between them there was a start which was shooting back and forth between these two points. I had to force my friends to look at the lights because they would not look and said was crazy but when eventually they did look they agreed that they had seen something strange.

My Wife and I went on holiday to

Fuertaventura in the Canaries and there were unusual lights in the sky above us which we watched for many hours. They changed colour and went on and off. They seemed so far away that they couldn't be sure if they were satellites or not. I am not saying that this could not have been explainable phenomena.

MW: What interest did you have in UFOs before the trial.

MB: Just before I got into the hacking scene I was making the free phone calls and I found a Bulletin Board in Australia which had loads of UFO files. There were about 500 or 600 text files on offer so I downloaded them all and waded through them slowly. I found it really interesting and I wanted to know more. I go into the MUFON files and Keelynet Bulletin Boards and they had interesting things on them also.

It seems to me that far more people have seen UFOs and have evidence of this than there is evidence of GOD but people go around believing in GOD and are not ridiculed for this in any way!

My opinion is that there is a lot of information UFO information out there and it is hard to separate the liars from the truthful people. The thing is that some of the wilder claims may also be the truth but sometimes you cannot be certain of any claims either way.

The types of thing I mean are cases where people say that they have been onboard spacecraft and seen the classic alien with big black eyes and that they had experiences which are consistent with other witnesses. You then hear from the same person that the aliens took her for a ride and they were walking around on the moon without a spacesuit and the story starts to take a strange turn. It seems that people seem to go overboard but who knows that person may in fact be telling the truth.

MW: Do you know much about Bob Lazar? Tell me what you about his story.

MB: Well yes, Bob Lazar was able to show documents from his previous work to show that he worked with certain companies, but they deny he ever worked for them.

As I remember he is a really nerdy looking guy that claims to have worked at Area 51's S3 complex I think? He claimed to have been working on crashed UFO technology. He said that he had seen saucers in hangers and had seen one flying one day. Only recently I saw the original interview he gave on video where he talked about his work and was drawing on a blackboard. I think he got prosecuted for running a brothel, I don't know much more than that.

MW: Do you know anything about the propulsion systems he was talking about in his work on the saucers?

MB: No not really - I can remember the shape of the craft and I can remember that the propulsion system was in the bottom of the craft and that it is like a segmented thing. I remember a little area in the middle where the "guys" would sit. I don't really remember the details or specifics of that.

MW: I am interested because you used the term "heavy element reactor" earlier on and I wondered if you have heard about something called "element 115"?

MB: No I did chemistry at school but was very bad at it and got kicked out. I don't know anything about elements full stop really.

MW: Bob Lazars story was that he worked on propulsion systems, which utilised a reactor, fuelled by a super heavy element. Everyday scientists do not know of the element 115 of which he speaks. Does this mean anything to you?

MB: Maybe that is a parallel. The only things I know about him really is that he worked on UFOs and his involvement in the brothel and the fact that he looks a bit "geeky".

MW: Can you remember any names of people on the project. Were there dates on any of the letters you



saw regarding the propulsion system?

MB: Nope, as for dates all the information was current at 1994. Whether this was a totally new engine or if it was a new version I can't be sure. I do know that it was a working prototype.

MW: Did they say what type of aircraft the propulsion system would be used in?

MB: Not that I remember, although I believe the engine was in use.

MW: Do you fear going to the United States?

MB: I am, not so much worried about being tried in the US for these things because they still have the same flawed evidence - but I fear that over there they would just stick me in prison without a trial and leave me to rot. This is something I have to look at carefully and to study the international law on these matters because there is a question of where was the crime committed on my computer in my house in the UK or in the US on their systems. This is a legal dilemma and is open to question.

A point is that there is a hacker out there now called Kevin Minick who did some minor hacking and has been in prison for 2 years and hasn't been charged with anything yet! This can happen.

MW: Why did you do all this? Are you an anarchist or is this political or just for pure curiosity?

MB: I just get a thrill out of exploring new computer systems. If you could see my CV I now have knowledge of all these computers systems I have used. If employers wanted to know how I got that experience it may get a bit awkward to have to tell them that these were military systems I was playing with - but it still makes for a good CV! I can now admit to my hacking and not have any fear because it may be a plus point in that I know a lot about systems security.

I did it for the pure adrenaline buzz of hacking a secret system. This can keep you awake on no food for hours and this is one of the other reasons - because of the thrill.

MW: Thank you very much.

MB: Thanks.

In final clarification on some of the interview I asked Mathew if he saw any images on the computer systems at Wright Patterson Airbase. He says he saw one but remembers that the antigravity engine was a working prototype and is fitted in some form of aircraft and is in use although the type of aircraft was not disclosed. The information was dated around 1994, when the system was originally breached. It is now up to researchers and hackers alike to try and find out more.

Mr. Todd soon learned that this inner core were continually fearful that the lower-ranking members of the occult societies would turn against "them" if the lower members ever found out that this inner council were merely using these "lower pawns" to increase their own wealth and their god-like power and authority over the rest of humanity. The Rothschilds of London, he also learned, were at the very heart of this conspiracy, along with the Jesuits in Rome. The Rothschilds were considered to be "human gods" by many occultists and, according to Mr. Todd, were in constant communication with "Lucifer", who they themselves considered to be god. There are also indications, as we will give later in these texts, that they were/are also in contact with the serpent race as well, which would make them an integral part of the "serpent cult". Dennis Brunnell, John Todd and in fact millions of former Communists, realized that there was an incredible contradiction between what these world socialists were telling their "followers" and what these inner elite were actually practicing. The connection we make between Illuminism and Communism (which is still very strong in mainland China) is no coincidence, as both are socialist movements. Also, according to well-known geo-political analysts such as Dr. John Coleman, Karl Marx himself had known ties with 33rd degree Masonry and the Jesuit Order. As for John Todd, he later "defected" from this secret lodge after he "suggested" to the other members that in light of recent events the prophecies of the Bible should be studied. Their answer to this, he claims, was a murderous stare from most if not all of the other members of this council of 13. He believes he was lucky he got out of there alive. These men, apparently, did not even want to consider the possibility that the Holy Bible could be true, for they knew well enough that it was against every imperialistic and deceitful practice that they were involved in. John Todd

later became a Christian and spoke to various audiences around the country until, according to some sources, he was later assassinated. Brunnell alleged that some within the Illuminati were so heartless as to believe that their socialist "World Order" must be brought about even if the orchestrating of wars, etc., had to be accomplished in order to create the conditions necessary for establishing it... or, in other words, that the end justified the means. These lost souls were and are apparently convinced that they have the divine right to decide the fate of nations, and that the masses of humanity exist for no other reason than to serve their cause. They consider themselves "gods" and the rest of humanity as "mere mortals". So much for the end-result of the false promise that was given to man by the serpent race as revealed in Genesis chapter 3, which was that men could be as gods, and that the creature could be independent from or equal to the Creator. The serpent race knew full well that the disconnection of man from their trust and reliance in the Godhead would result in lost power and dominion over the earth and the beasts, including the serpent race, and as a result the reptilians could take control of that which mankind forfeited, including man himself! Since that ancient time the saurians have been able to find those among humanity who would be willing to believe their false promises in exchange for temporary physical gains.

One of Dennis Brunnell's "Gemstone" research papers (which also described the Mafia-CIA-oil company connection to the John F. Kennedy assassination, confirming the original "Gemstone" reports of Bruce Roberts) included a scenario developed by Kissinger and other Illuminists in the early 1980's or before. This scenario showed one such proposed plan as to how war could be used to bring the United States - the last obstacle standing in the way of absolute Illuminati rule of the world - into subjection to the one-world Socialist state. This scenario, possibly one of many developed, was in the form of a speech given by a U.S. president. George Bush was cited as a very possible candidate to this "speech" (This was years before Bush became vice president, which suggests that Brunnell was in fact tapped-into some very sensitive information). It was basically written as a possible emergency address to the nation which would supposedly take place after years of American involvement in an - Illuminati orchestrated? - war in the Middle East. The scenario continued as "the President" informs the nation that, due to the long drawn-out (Korea/Vietnam like no-win) war which has depleted our national resources, a certain Executive Order was to be issued for the "good" of the nation which would result in practically ALL PRIVATE AGENCIES coming under the absolute control of the Federal

Why are the MOD refusing to sell a disused American Airbase? Why did they "rob" a business man of 2 million pounds deposit when he offered to buy the base and develop it? What se-

For the past year I have been in touch with Chris Parker, managing director of the C.P.G. (Chris Parker Group). The C.P.G. put in a bid for the Bentwaters airbase in 1995, after the previous sale failed. Chris Parker is used to going to bases of all sorts and stripping them of all saleable assets, turning them into large development projects. This time however, things didn't run as smoothly as he was used to.

Suffolk Coastal and District Council had already agreed with the MoD that the base just a blot on the landscape as it had not been in use since 1992. They had decided that the best thing to do was arrive at a quick sale and sell the base for the land value as opposed to the building value. This seems to be the best solution in effect because the projects being considered by the C.P.G. were development projects and as such would have created jobs in the area and greater commerce.

The Americans, since their occupation, financed the buildings on the base under the NATO agreement; which took place after the war. In this capacity the MoD were not losing out by selling the base cheaply. C.P.G. made an offer to the MoD to buy the base, a deal which was accepted and upon which a deposit had been paid. Why then did this deal with the C.P.G. fall through towards the end of 1996, after the deal had been on the table, and in agreement, for one year? Why did they not give him 14 days notice. Did the Mod not know that by not giving 14 days notice that they were breaking British law?

The answers to these questions are



troubling because they rely on investigators delving deeper and deeper into a possible nuclear incidents in the area and possible nuclear storage at this and other nearby airbases. To answer the first question, the MoD cancelled the deal with the C.P.G. because Chris Parker was not doing the right form of development. The only acceptable form of development for that airbase as far as the MoD was concerned is maintaining it's use as an airport, in this case to be used regularly instead of Ipswich airport. I for one, knowing the amount of nuclear weapons that were stored in the base and according to many military witnesses in a secret underground facility, would not travel from that airport. Is it reasonable for the MoD to force a developers hand in this manner?

STRUCTURALLY UNSOUND

Mr Chris Parker's story starts when his company starts trying to do some borehole testing on the runway. His first observation was that this particular runway was one of the most structurally unsound runways of all the airbases he had visited in the country. It was not level and had many dips in the concrete. In order to get a better idea of the level of inconstancies he needed to do testing of the base runways and earth. To be able to do the borehole testing in the first place he had to request permission from the MoD which was subsequently denied on more than one occasion. When permission was finally granted he was directed to certain spot on the base and told that he was only able to conduct drilling tests at this location. In addition these tests also had to be conducted whilst under supervision. Never in the Parker groups history had they ever had to go through so many formalities in order to do a simple drilling test!

Chris believes that topside of the base was built to house an underground facility. Many military personnel have attested to this fact area and small groups of Ufologists also. The structure of the drainage

systems is unnatural in that these tunnels are apparently unable to hold water. This fact also attributes to his belief in the idea that there is an underground facility beneath Bentwaters. There also seems to be other tunnels present, which have nothing to do with drainage at all and their real purpose is still unclear.

An interesting twist takes place after the deal fell through with the MoD. Chris Parker now claims that he has been "robbed" by the Ministry to the extent that he has had to order a writ against them requiring them to cease and desist all operations with respect to the base. The base was being sold to him for the sum of £10.2 million, over £2 million was taken from him, in the form of a deposit by the MoD and not returned. The deposits included planning permissions fees. Chris Parkers and his company now believe that because he was going to have to drill away 16 feet of runway the MoD didn't want to sell the base to him. This is a fair assumption based on the fact that all the elements were in place for a quick sale to his reputable company that had the resources for the development; So what else could frighten the MoD into not wanting the runway removed?

Well, that wasn't the end of the story by far. The next thing to happen is that a group known as the "MUARD Corporation" put in a bid for the base and contracts exchanged hands at a mere price of £7 million! Thus the MoD accepted an offer which was less than the Parker groups offer, less by the sum of several million. Due to the ease of the sale to MUARD, it also appears that unnecessary delays must have been introduced to C.P.G.

which delayed the sale of the base, for no apparent reason.

MUARD

Companies that buy these bases are now, for security reasons supposed to have a ten-year checkable history of trading in British military hardware, doing engineering contracts etc. It turns out that upon closer inspection the "MUARD Corporation" formed one week before they put in a bid for the base. This newcomer company were apparently never effectively investigated by the MoD. One of the investors on the original Chris Parker project - Tony Hunter - pulled out and joined the opposition (MUARD), so to speak. It then surfaces that John Masters, the solicitor for the MUARD Corporation, along with Tony Hunter, were both under suspicion of fraud in the Virgin Islands. This did not seem to deter the MoD from letting them buy the base. Perhaps the quick sale the newcomer company had something to do with the fact that the MUARD corporation had agreed with the MoD's firm wish for the base to maintain it's status as an airport!

Some of Chris Parkers ex-military sources have told him that before the base closed there was a fire in one of the underground bunkers below. These same sources have suggested to him that the reason a lot of the underground region of the base was closed is due to the fact there is some serious 'hardware' still down there. What kind of 'hardware' - nobody knows? What we do know is that the nuclear weapons were stored underground on the base and that there were a great deal of bunkers in an area known as the WSA (Weapons Storage Area), a place the Americans nicknamed "Nuclear Alley". The bunker entrances had lift platforms that brought missiles from underground to the surface bunker entranceways. There were also similar platform lifting devices present in the bombproof aircraft hangars in Bentwaters. So it is quite conceivable that

there is still a large amount of nuclear weapons being stored underground there and possibly also a great deal of nuclear research, which would have been typically in-line with many other research establishments in the area.

The final needle in the haystack comes straight from Chris's secret source in the Ministry Of Defence. The deepthroat source tells him that the MUARD deal had the backing of both John Gummer MP and Michael Portillo MP (former UK Minister for Defence), who had apparently kept a watchful eye on the sale of the base ensuring that it went to the MUARD corporation.

Ever since it was told to me several months ago at a lecture I gave on the Rendlesham Incident, one incident has stuck in my head. It was relayed to me that seventeen people were witness to luminous aerial phenomenon in the forest region around Woodbridge airbase. Of these witnesses two were policemen and would appear therefore to be a credible source. The witnesses had seen many things that myself and other ufologists could not put down to simple 'Project Blue Book' explanations.

The local "rag" newspaper interviewed two of the observers. The reporter in this case claimed to have an interest in UFOs and found their story rather remarkable. However when it came to the story being printed, the sounds that were heard were attributed by the newspaper editor as 'animals pulling the "legs off barbecues"' and all kinds of weird things were put down to physical explanations. It appeared that the paper no realistic results to any possible causes of the things seen and heard. As we see so often these days, it is a sad fact of journalism with respect to the UFOs and other paranormal phenomenon that the investigative approach of many journalists is non-existent.

Away from the final editorial cut of the story, one

interesting piece of information came up in the course of the events, as told by the journalist in one of his more sympathetic moments. This was that "the US government are paying the British government £6 million each year for them not to sell the base." Whether this is true or not, I don't know. The source for this questionable gem of information reputed to be a small arms dealer that the journalist was in contact with.

With all this tantalising evidence, one thing seems clear - The MoD does not want to sell this base. In fact even now there are court battles taking place between the MoD, the new owners of the base and between the investors that are backing the owners. This can only give rise to more suspicion that a mystery is lurks beneath the feet of many Sussex residents, in the area which has had more than its fair share of UFO sightings.

{Also the base was scene to a set of UFO sightings around 1980 where Triangle UFOs and "Ball Of Light" phenomena were observed near the base. It is now part of UFO history that one event took place where US security personnel were witness to a landing of a UFO and met some of the occupants. Strange tales still abound in the area of "black hooded figures" who take an unhealthy interest in the nuclear storage areas - seen floating unsupported near the runways and also in nearby forests. Psychic mediums are often telling us that there is a strange aura of alien activity near the base, and indeed all the way back to 1950 there have been stories of UFOs in the general area. Could the reason for the blocking of the sale of the base have some other meaning. Is there something of a sinister or extraterrestrial nature in the area which is in some way connected to the base - something that might be exposed if the base were demolished. - ED}

GRAN HERMANDAD BLANCA

In the following article, I have attempted to explain as thoughtfully and as respectfully as possible to those people involved, some of whom are my friends, the facts and details surrounding a New Age UFO-Spiritual group/cult/religion centring around Raul Yepes, a mild-mannered and very likeable fellow from Medellin, Colombia.

While not subscribing (specifically) to

the belief systems of the group, I have found the investigation to be very valuable and enriching in the areas of personal experience, and various aspects of the "channelling" phenomenon have proved themselves to me to be of a very real nature, as will come apparent as this article progresses.

It is not the purpose of this article to debunk, criticise or slander the group Gran Hermandad Blanca, or any member/person mentioned. During the latter part of

my investigation, certain people became aware of my journalistic activities, and volunteered themselves to give personal interviews. Some of these people have requested that their identities not be disclosed, while others have made it known to me that they are more than willing to give information with their identity known.

To those of the group who feel offended or upset by some of the content of this article, I can only express my regrets, and re-assure that it is not the purpose of the

"Greetings to you, great beings and higher spirits here on Earth, I have come to bring you council and love from the galactic community that watches you so closely...." So starts the oration of one man, a supposed channeller who claims to have unique contact with certain spirits, angels, higher beings and extraterrestrials. During my sojourn in Central America, I have come to find that Catholicism doesn't reign quite so supreme as I thought. Indeed, it has taken rather a backburner as new alternative religions have been sprouting up all over South and Central America, among these the hugely popular Mission Rama, headed by Sixto Paz in Peru.

COLOMBIA

During the last 15 years, one man; Raul Yepes of Medellin, Colombia, has single

handedly caused quite a controversial storm throughout his land. Yepes, in his forties has a very amiable appearance, with cut extremely short hair and a paunch any beer drinker would be proud of. It was during a casual conversation in the early part of 1997 with some Rosicrucians over a plate of typical Colombian food in a restaurant on the Island of San Andres that I first came to hear of this man, Yepes, and his growing movement of "Brotherhood" followers. It peaked my interest to hear these rather sober yet devout Rosicrucians talking about the man as if he was some sort of demi-God.

They went on to say how UFOs followed Yepes about, and he had been able to heal the sick and cause unexplainable phenomena such as causing people to enter into trance like states to



free them of negative spirits and energies.

By the end of the conversation, I was convinced of the fact that I had to assign myself to investigating this man and his group, the Great White Brotherhood. A group that has over 500 members throughout Colombia.

RACIAL GROUP

Sounding more like a group from the oppressionist fifties America, the Great White Brotherhood actually is supposed to represent a band of people who are trying to achieve a state of spiritual purity of whiteness, not skin color! In reality, the name of the Great White Brotherhood is a global term, with many groups from Sedona in New Mexico, Canada, France and Italy all being comprised of channellers and followers using it as a group

name of unition.

My experience investigating the group located on the Island of San Andres in the Caribbean began in the early part of July, 1997, after visiting a spacious office area on the second floor of an office building. I found myself surrounded by pictures of the Indian sage Sai Baba on the walls as well as mandalas, incense burning and various coloured candles. I was pleasantly surprised to find that the secretary of the group was a former English student of mine, so, she greeted me warmly and proceeded to give me some background information on the group, but told me that I should really wait a week to meet the Big man himself, Raul, who was coming to give a week of meetings to the followers here.

I decided at this point to play dumb and pretend to be genuinely interested for reasons of spiritual advancement, instead of declaring myself to be nosing around for the sake of journalism. She explained to me about the various entities that Raul channelled. I was a little dismayed to learn that he claimed to channel Jesus Christ, but then again, I've heard of other channellers claiming to channel Jesus as Sananda. She went on to say that at all meetings, everybody except Raul must wear white apparel, for the sake of purity and positive energies!!

MOUNTAINS OF PERU

I asked her if there were to be any charges for attending the meetings, to which she replied that there were indeed charges, but that they were at the discretion of Raul. It was at this point that I asked her if she had witnessed any curious things that had happened while she had been in his presence. She recounted to me an episode that occurred two months earlier while on an expedition with Raul and group members

from all over Colombia to Macchu Picchu in the mountains of Peru. She said that during one session, a group of strange dancing lights had swept up from deep in one of the forested valleys and shot up into a clear night sky, breaking formation and climbing independently higher out of the atmosphere.

I asked her if during the sessions, his voice would change, and she nodded thoughtfully. She explained that his whole stance would change. He never looked anyone in the eye while he was "occupied", as she put it, but instead looked at people indirectly, staring into the space above a person's head. His voice would change profoundly, reflecting the calmness and tranquillity of the entity being channelled. He would also walk in a strange manner, sometimes doubled up like an old man, and sometimes, prancing like a prince.

RAUL YEPES, MAN OF MYSTERY

She explained a little history about the channeller. He had been actively channelling for some 15 years, ever since being consciously contacted by higher beings mentally. He had been informed that his mission is to develop and help assist in a change of consciousness that will herald the change of the

Earth vibration to that of the fourth dimension in the year 2013ad. During this time, he would broadcast the messages of friendly extraterrestrial entities operating within and without the solar system to the people, and also teach them by allowing himself to act as a channel to be able to attain higher spiritual states of being while existing in the Earth plane of existence.

As well as channelling entities from other worlds, Raul also claims to be able to channel angelic entities, and indeed the son of God, Jesus Christ, as well as the virgin Mary (Blasphemy total to the Catholic religious authorities here). Among these entities are; Mer, Moria, Sanat de Kumara, Maytrella, Venus, Philip, German, Kutumi, Bisirio, Yesel, Rama, Gabriel, Michael, Rafael, Ilato, Hilario and a host of others.

The group is spread out all over Colombia; but centred in Medellin, the hometown of Raul Yepes. Also there are branches in Bogota - the capitol city, Cartagena, Cali, Baranquilla and San Andres Island (subject of my investigation).

Government. In short, according to this scenario, if such a plan was carried out then the entire nation could be brought under absolute socialist control in one night. Such a scenario may not be too far-fetched when we realize the following: 1) George Bush was, during his years at Yale University, initiated into the "Skull & Bones" society, also known as the "Brotherhood of Death".

Bush, like many misled "insiders", was no doubt largely a product of his environment, as well as a member of a generational "Establishment" family, and more-or-less a puppet or voicebox of secret government policy. This fact should be taken into account, as well as the fact that the major "enemy" is the draconian influence as it exists in and behind the secret government establishment.

There were, nevertheless, less-than-honorable motives on the part of the United States in its decision to fight in the Gulf War (see: YOUTH ACTION NEWS - Oct. 1990., Box 312., Alexandria, VA 22313 - this source gives much evidence that Bush and Company more-or-less "encouraged" the Kuwaiti invasion and, when faced with irrefutable proof that such an invasion was coming, did absolutely nothing to warn the Kuwaitis or the Iraqis against such an invasion. Was Bush and Company willing to risk the lives of thousands of people just so his One World Government could be established and a "trial run" of the global U.N. Police Force could be initiated?). According to Dr. John Coleman (World Intelligence Review., Box 426., Metairie, LA 70004), the ancient Babylonian Serpent Cult, or what is known today as the "Illuminati" (33rd degree Freemasonry) is under the direct control of some very nefarious forces. Coleman in fact provides much evidence that 33rd degree Masonry has been used not only to infiltrate and take over many political, economic and religious institutions, but has also been used to "create" such institutions as well, organizations to which people will flock and submit their power and energies to unknowingly serve an agenda that they know nothing about. This was and is carried out through the 22 "Palladium" Lodges which, according to various sources, can be

traced back to the Grand Masonic Lodge in England. According to Coleman and many others, the Grandmasters of Masonry AND of Jesuitism (ie. the Illuminati) are working together in this conspiracy. In many cases the individuals involved are both Jesuits AND Masonic initiates. Such was the case of Guisse i Mazzini, who was a Jesuit-Mason, and a satanist-witch to boot, and was second-in-command to the Masonic "Pontiff" Albert Pike - whose rotting remains now lie beneath the "House of the Temple" in Washington D.C. (see Dr. Coleman's tapes: CONSPIRACY CULTS AND THE ONE WORLD GOVERNMENT, and FREEMASONRY AND THE ONE WORLD CONSPIRACY).

Other works that may be very revealing along this line, as we indicated earlier, are the writings of former 33rd degree Mason and former Past Master of all Scottish-Rite Masonic bodies, the Rev. Jim Shaw. This is especially true with his book THE DEADLY DECEPTION (P.O. Box 884., Silver Springs, FL 32688). In this work Mr. Shaw exposes the blatant SERPENT worship secretly taking place within the Masonic HOUSE OF THE TEMPLE in Washington D.C. Mix this with the accounts of "Masonic" street-outlays built into Washington D.C. itself and accounts of tunnels beneath the city which connect many of the important Federal buildings and which allegedly extend to extreme depths and distances, then you have a recipe for something very strange and sinister which is undermining our nations capitol. No wonder the Christian- Patriots within the American Republic have had to fight "the enemy within" for so long with so little aparent results from their efforts. Concerning Bush's one-world policies, we will quote here from a few letters to the editor which appeared in various issues of the UTAH COUNTY JOURNAL, as confirmation of some of the statements which we have previously made. One letter, appearing in the April 30, 1991 issue of the U.C.J., stated: "Editor: The April-May '91 issue of COMMON CAUSE reports that the first successful exploration for oil in Kuwait was done by the Zapata Oil Co., of which current President George Bush was a founder and director. The President's son, George W. Bush, is now the third largest insider stockholder in another off-shore oil drilling company located in Bahrain, 15 miles from Saudi Arabia. This is Harken Energy Corp., with its home base in Bedford, Texas. "Does this information explain the Rambo-like "hurry up" war in Kuwait? Does it explain marked shifts in acceptance or castigation of Saddam Hussein? Does it offer an explanation for the terrible destruction of the Kuwait oil fields and Persian Gulf waters? Do these two leaders really have the welfare of their respective peoples at heart? I would give anything to read one of the history books on this war written 25-50 years hence. - Eugene J. Faux; Provo." And in the Feb. 26, 1991 issue of the same publication: "Editor: In the Feb. 12 issue of the JOURNAL an obviously well-intentioned lady suggested that we pray for President Bush because he has 'awesome responsibilities.'

"He has, indeed, many awesome responsibilities: a responsibility to uphold and defend the U.S. Constitution; a responsibility to weed out those in our government who, by intent

or neglect, work to undermine the Republican form of government given to us by our founding fathers; a responsibility to tell the American people the TRUTH about the incredible, rapidly escalating national debt and what the debt will mean to our children and our children's children 'unto the seventh generation' and beyond. He also has a responsibility to expose the hypocrisy of those who are working diligently to bring about a new constitutional convention, supposedly to propose one or two new amendments, while they already have entire new constitutions written and waiting. - Albert V. Burns; Spanish Fork." Another letter which appeared in the UTAH COUNTY JOURNAL during the Bush-Iraq controversy, Mar. 5 1991 issue, stated: "Editor: Mrs. (Colleen D.) brought up a very good point about my criticism of George Bush and his New World Order agenda. Rightfully, as a leader of a nation, he might be considered exempt from censure for any mistakes that he might make through oversight or a lack of proper information. Unfortunately, this is far from the case with Bush.

"Sadly, the president is very cognizant of his actions and exactly where these actions are speedily leading us - to a world government ruled by elitist insiders. History can conclude nothing less than this result. For a complete analysis of Bush, his political history, and his leadership of the Council on Foreign Relations and the Trilateral Commission, I enthusiastically recommend the new book on George Bush - THE ESTABLISHMENT MAN, available through The John Birch Society. Well documented, this book will put to rest any remaining praises for our chief executive. "In fact, my critique of the executive is founded upon my patriotism, not turning against it. President Teddy Roosevelt stated: "Patriotism means to stand by the country.

IT DOES NOT MEAN TO STAND BY THE PRESIDENT OR ANY OTHER PUBLIC OFFICIAL SAVE EXACTLY TO THE DEGREE IN WHICH HE HIMSELF STANDS BY THE COUNTRY. It is patriotic to support him insofar as he efficiently serves the country. It is unpatriotic not to oppose him to the exact extent that by inefficiency or otherwise he fails in his duty to stand by the country." As Bush has repeatedly violated his oath to defend the Constitution, I will continue to patriotically reproach his intentions. "As for being in the White House when Bush sent National Security Adviser Brant Scowcroft and Deputy Secretary of State Lawrence Eagleburger to Beijing immediately and secretly after the Tienamen Square massacre, no, I was not present when he made that call. That's why we have the press. The White House announced that such was the case on Dec. 18, 1989, to anyone listening. Such betrayal of freedom-fighters is par for the course when we look at Bush's policy toward other people seeking liberty, but receiving only his true objective: World despotism in his New World Order. - Bruce J. Martin." In relation to the above concern of whether we should unquestioningly trust our elected (?) heads of state, it is interesting that of all the presidents which have been in the White House since the assassination of John F. Kennedy (which many allege was actually an Illuminati-inspired coup), EVERY SINGLE ONE OF THEM have been

supportive of the one-world government movement as it is incarnate in the Council of Foreign Relations and allied global organizations. Coincidence? Finally, we have this letter from the September 18, 1990 issue of the same publication: "Editor: In his September address to the nation, President Bush stated his five objectives for the massive deployment of U.S. troops. The fifth is the fundamental reason for this operation. As Mr. Bush stated himself, "The crisis in the Persian Gulf, as grave as it is, also offers a rare opportunity to move toward a historic period of cooperation. Out of these troubled times, our fifth objective - a new world order - can emerge... We are now in sight of a United Nations that performs as envisioned by its founders." "The U.N. 'founders' included U.S. communist traitor, Alger Hiss, who was the acting secretary general of the conference in San Francisco in 1945. Hiss was accompanied by a contingent of U.S. communists and a swarm of Council on Foreign Relations members. The communists wanted world government by revolution and the others wanted it by way of socialism. In either case, these individuals did not want national sovereignty of the kind fought for by our founding fathers.

"The fundamental difference between a "new world order" under the United Nations and an independent United States are nowhere clearly indicated than in our DECLARATION OF INDEPENDENCE affirmation that "men are endowed by their Creator with certain unalienable rights." The UN's total exclusion of God means that rights do not come from God, (but) that they proceed from government, and government can and will take them away. "Our country has suffered in the past from U.N. decisions and action. U.N. advocates gave away all the gains our fighting men bled and died for in Europe and Asia after World War II. We fought Korea and Vietnam under U.N. sanction and command with victory denied even though over 100,000 men lost their lives and hundreds of thousands were wounded (in addition to this, several sources allege that communist nationals working within the U.N. constantly betrayed U.S. positions and strategies to their allies in North Korea, and repeated this betrayal during the Vietnam conflict as well. It is a fact that the MAJORITY of the "United" Nations Secretary Generals have also been communist nationals - Branton). Nixon and Kissinger operating under "new world order" dictates gave South Vietnam to the communist enemy after our military fought so valiantly even with the treasonous restrictions imposed on them.

"Now, George Bush wants the men and women of our armed forces to die... for the new world order... George Bush's drive for a "new world order" is not worth ONE DROP of American blood. But blood we shall have until we once again elect constitutionalists to office instead of one-worlders. - Mike Thomas; Pleasant Grove." The January 26, 1990 issue of THE NEW FEDERALIST revealed even more about the Bush - one world connection. In his article, BUSH'S CHINA POLICY: SKULL AND BONES, Joseph Brewda writes:

"Jan 19 (EIRNS)--An obscure secret society known as "Skull and Bones" may have more to do with George Bush's obsessive support of

Beijing's mass murderers than one may think. "Skull and Bones is a secret fraternity at Yale University which is restricted to a mere fifteen student members per year. The society was formed in 1832 by General William Russell, whose shipping firm later dominated the U.S. side of the China opium trade. Yale University was founded by Eli Yale, who made his fortune working for the opium smuggling British East India Company. "Skull and Bones became the recruiting grounds and preserve of the most important New England-centered families--families who also made their money in the opium trade. These families, whose sons regularly join Skull and Bones, include the little known, but powerful, Coffins, Sloanes, Tafts, Bundys, Paynes, Whitneys. They are a dominant element of the U.S. 'Eastern Establishment' to this day. The Bush family is one of a cluster of lower-level Establishment families controlled by these interests. "What has this to do with Bush policy towards China--or for that matter, Bush's "War on Drugs"? (Note: the last television news reporter to ask Bush a critical question concerning the many narcotics agents who are complaining about how bad the "drug war" was going, was promptly fired from his job shortly after the press conference - Branton)

"George Bush, the first U.S. diplomatic representative to the People's Republic of China back in 1973, was a member of Skull and Bones. So were his father, brother, son, uncle, nephew, and several cousins. Winston Lord, the Reagan-Bush administration Ambassador to China was a member, so were his father and several other relatives. James Lilley, the current Ambassador to China, was a member of Skull and Bones, as was his brother. Except during the Carter administration, every U.S. Ambassador to Beijing since Kissinger's deal with Mao Zedong was a member of the same tiny Yale cult. A mere coincidence? "MAO WAS A YALIE - Back in 1903, Yale Divinity School established a number of schools and hospitals throughout China that were collectively known as 'Yale in China.' It has since been shown that 'Yale in China' was an intelligence network whose purpose was to destroy the republican movement of Sun Yat-sen on behalf of the Anglo-American Establishment. The Anglo-American "Establishment" hated Sun, because he wanted to develop China. On the other hand, they loved the Chinese communists because they intended to keep China backward, and were committed to growing dope. One of 'Yale in China's' most important students was Mao Zedong. "During World War II, 'Yale in China' was a primary instrument used by the U.S. Establishment and its Office of Strategic Services (OSS) to install the Maoists into power. 'Yale in China' was run by OSS operative Reuben Holden, the husband of Bush's cousin, and also a member of Skull and Bones. "The Maoists made China into the world's largest opium producer. "Yale in China' was also closely associated with the New York-based Union Theological Seminary, which has been a center for U.S. subversion of Asia (literal wolves in sheeps clothing - Branton).

Every prominent radical leader operating in Korea today, for example, was trained at Union Theological. Union Theological was dominated for twenty years by Henry Sloane Coffin, a U.S. intelligence executive from the Sloane and Coffin

families. He was a Skull and Bones member as were a dozen of his relatives. "Nor should it be forgotten that Averell Harriman, the former Ambassador to Moscow who did so much to build up the Soviet Union, was a member of Skull and Bones. Harriman was also a business partner of Prescott Bush, Sr., the father of Maoist enthusiast George Bush." Note: This Skull and Bones - Communist connection is also confirmed by geopolitical and economics researchers such as Dr. Antony Sutton (Sutton's books may be obtained through

THE PATRIOT REVIEW, 33836 SE Kelso Rd. 6., P.O. Box 596., Boring, OR 97099; OR via *THE MIDNIGHT MESSENGER*, P.O. Box 472., Altadena, CA 91001).

Not only did the Skull and Bones (Western Illuminati) help to build up the Communist movement in China, but they gave considerable financial aid to the Soviet Union communists as well. According to Sutton, this power cult has for centuries been playing a "two ends against the middle" type of game, attempting to control America (the thesis) and Russia (the anti-thesis) and other countries or movements, carefully pitting them against each other at the lower levels in order to keep the populations of the world in a state of confusion and despair, to the point that they will - hopefully - resign themselves into accepting the New World Order "synthesis" as the only alternative to solve the very "problems" which THEY, the New World Order initiators, created in the first place!

One startling, though documented, claim which Mr. Sutton makes is that the Nazi Movement was largely financed by the Skull and Bone - Illuminati as well. This connection was recently described in a mailer describing Val Valerian's book *MATRIX III* (c/o Leading Edge Research, P.O. Box 481-MU58., Yelm, WASH 98597). Part of this mailer states: "Interspaced with the material comes a host of data, supplementary material, interviews, and revealing information. The 'Final Scenario' is discussed relative to the New World Order and the plans for total economic control, a one-world religion, and the electronic mind control objectives, schools of thought, and research. *MATRIX III* brings out in detail how various families in the United States and Europe are also involved in a scenario which has as its main tenet the suppression and elimination of human beings on many levels - a scenario which includes worldwide traffic of drugs, vast laundering of drug money by national banks of several countries, and assassination and murder. These are the people who arranged and supported all the wars. There is discussion of the Bush family, and how Prescott Bush assisted the finance and management of the Nazi empire - the so-called Hitler project..." Much of Valerian's writings are very well-documented and can be followed-up, yet the only criticism of his work which we have deals with the fact that, we believe, he has placed too much confidence in so-called "channeled" revelations as sources of information. We believe, based on past experience and research, that much of the information received through so-called "trance channels" should be discarded for several reasons:

- 1) Such information is often self-contradictory.
- 2) Channeled revelations often contradict "revelations" received through other "channels".
- 3) There are supernatural beings inhabiting the aerial realm whose very purpose and "assignment" is to counterfeit "divine" revelation in order to spread propaganda, confusion or mislead the seeker from the truth. This is often, we have found, accomplished by offering the seeker a substantial amount of "truth" in order to uphold one strategic ie.
- 4) Channeled information in most cases cannot be followed up by physical documentation or evidence.
- 5) There are many indications that non-human beings, both supernatural and reptilian, are utilizing occult channels in order to carry out propaganda warfare against those who possess the truth.

As we will see in later writings there is also much evidence that these alien beings have utilized witchcraft and occult movements (ie. the serpent cults) since the earliest times in order to further their reptilian cause. In relation to the Bush - Establishment - Serpent Cult - Reptilian connection, we will now quote from an article which was submitted by one of our researchers. This article, written by a Gerard Van der Leun, appeared in the Nov. 1990 issue of *Penthouse Magazine*: "IS GEORGE BUSH AT THE CENTER OF THE GREATEST AND MOST SECRET PLOT EVER LAUNCHED AGAINST MANKIND? "Dear Reader: It is a well-known fact that: "1) The government has approved and entered into a secret treaty with an alien nation. "2) The government, with this treaty, has traded human lives and property (in the form of livestock and land) for alien technology. "3) The government has murdered, incarcerated, forcibly relocated, brainwashed, coerced, drugged, harassed, and otherwise interfered unlawfully in the lives of patriots, including a president of the United States, who have attempted to expose this murder and treason. "4) In pursuit of bringing all those responsible for these acts to justice, the following are hereby charged with conspiracy, murder, and treason: the Trilateral Commission; the President; the Vice-President; the director of Central Intelligence; certain other members of the CIA; the director of the National Security Agency; members of the Cabinet; the Joint Chiefs of Staff; the director of the Senior Interagency Group (SIG); the national security adviser to the President; and the Navy Department which has field operation control of all alien- connected projects. It is expected that many others who have taken part in the joint government and alien conspiracy will also be charged with conspiracy, murder, and treason. This list will include all those who served in the aforementioned positions from 1953 up to and including the present administration. (Note: Since many of these individuals are merely "following the orders" of the elite insider groups who are ultimately controlled by the Jesuit-Masons; the GRANDMASTERS of Jesuit-Masonry, the inner Illuminati or Serpent Cult,

should be indicted as the major traitors against the human race.

Many of these Jesuit-Mason leaders are members of the ancient generational families who have controlled the drug trade, manipulated wars and revolutions in their favor, and have infiltrated the economic institutions of the world. They have no fear of divine retribution because they believe in no god other than themselves - Branton) "5.) We call for the impeachment of the president of the United States, George Bush. As president and C.E.O. of Zapata Oil, Mr. Bush organized and has headed the narcotics-smuggling conspiracy since its beginning. The off-shore oil platforms of Zapata Oil were used as staging areas from which drugs were moved into these United States without passing through Customs or undergoing inspection of any kind. We firmly believe that George Bush now heads this shadow government that controls the alien technology, the military-industrial complex, and thus the nation. The fact that he is now the president of these United States of America makes George Bush the most powerful and dangerous criminal in the history of the world." Note: Where does all this ill-gained money go? According to many sources, much of this as well as the multi-billions in "Black Budget" monies provided by the taxpayers pours into the insiders' relentless and secret efforts to construct underground as well as off-planet (Moon, Mars, etc.) places of refuge where the secret government members and their families will escape to in the event of a global manmade or natural catastrophe. How thoughtful of us "mere mortals" to give our wealth and even our very lives just so that the "immortal elite" can survive to usher in a "New Age" on planet earth... This reminds us of something the 33rd degree Mason/O.T.O. Grandmaster Dennis Brunnell said: That the creator of the James Bond movie "Moonraker" had inside knowledge of the secret government's end-time plan, and thought that it would make a great movie. But as they say, Truth is even stranger than fiction.

The modern secret societies which are being manipulated by the infernal reptilian races are a merely extensions of more ancient societies who were also manipulated and influenced by these subterranean creatures. Several ancient races in fact believed in the existence of an "underworld" inhabited by serpent-like beings possessed with supernatural powers. Many of these mis-guided souls even worshipped these creatures, not so much out of adoration, but more out of fear or terror. Human sacrifices were even offered in an attempt to ease the destructive influence of these "demon gods", and temples and shrines were often built over or near caverns which were regarded by these superstitious people to be openings to this nether world. One such shrine is located several miles southeast of Oaxaco, Mexico among some very ancient ruins. Among these ruins lies the ancient temple of "Mitla". Various accounts allege that in ancient times this temple descended deep underground into a basement, a sub-basement, and an ultra-sub-basement level. Within this third sub-level a large stone door was said to have concealed subterranean recesses beyond. According to the late subsurface

researcher Charles A. Marcoux, as well as the anonymous U.S. Intelligence worker "Commander X", and others, the native Indians of the area centuries ago used to sacrifice humans to the underworld "gods" that were believed to exist within the dark caverns beyond the stone door. These victims were allegedly thrown into these dark chambers alive and were never seen again. Some centuries ago some priests arrived in this area of southeastern Mexico and commenced to explore the ruins, including the ancient Temple of Mitla. They managed to pry open the door in the third basement level and entered the underground chambers beyond. Torches in hand, they continued deep into what seemed to be an endless subterranean concourse leading in the direction of a distant mountain range. After penetrating a considerable distance they became fearful as they noticed serpents slithering among the rocks off in the darkness, they would see strange shapes and shadows among the ancient stone pillars which lined the concourse, eerie noises and winds began to blow through the large passage, and a they were overcome with a general feeling of fear and dread. Convinced that they were on the outskirts of Hades itself they made a hasty retreat, after which the Priests sealed the door and ordered the natives to fill-in all three basement levels with rock and earth, completely concealing all evidence of the subterranean connection. Another such account involves the ancient Greek "Temple of Apollo", in Hierapolis (now Pamukkale), Turkey. This city was once part of the ancient Grecian empire, which covered an extensive area in and around the Mediterranean sea. One article which appeared in the January, 1989 issue of OMNI Magazine, referred to strange disasters which had taken place in a cavern adjacent to this now broken-down temple. The article quoted from the writings of the ancient Greek philosopher "Strabo" (who lived between 63 B.C. and 24 A.D.), to the effect that animals would often enter the cave and never return. Also MANY PEOPLE throughout history who went past the mouth of the cave never returned. The article also quoted one Sheldon Aaronson, a professor of microbiology at Queens College, N.Y., who told OMNI that several Australian students had entered the cave and disappeared just a few days before his visit in 1987. Sheldon stated: "The Turkish government put iron bars over the opening to prevent other people from ever going in. As far as we knew, the Australians were never seen again." According to the article, the Greeks believed that the cavern was an opening into the "land of the dead ruled by the gods of the underworld." As for the possibility of an underground subterranean "world", science tells us that the lowest depths of the earth (upper and lower mantles) contain temperature and pressure extremes so great that physical life could not possibly exist there. Some however believe that there is evidence for the existence of a vast global network of geothermal and hydrothermal cavities, somehow connected to the ancient deluge wherein the "...fountains of the great deep were broken up". This allegedly occurred as magma-heated strata of subterranean water-filled caverns (brought to enormous pressures by

an expanding and over-heated mantle) suddenly burst through the crust (Gen. 7:11) like a tremendously large exploding pressure boiler. Some claim that the underlying basaltic rock layers within these gigantic global aqua-systems were dissolved into these global subterranean reservoirs as their temperatures and pressures increased. Afterwards these vast amounts of water exploded to the surface, thus explaining why the oceans now contain large percentages of "salt". These underlying chambers, many of which collapsed yet many of which remained intact, are believed to exist throughout the moho and crustal regions of the planet, just above the upper mantle. If evidence of ancient sunken continents ever becomes irrefutable, then such a theory would explain why whole island-continent may have collapsed. Such a cataclysm may have resulted from the possible fact that huge underground chambers, no longer supported by these subterranean waters, suddenly caved-in on themselves. Other higher-level cavities created through seismic activity may also exist, cavities which may dwarf the Flint Ridge-Mammoth Caves of Kentucky or New Mexico's

Carlsbad-Lechuguilla cavern system. It is suggested that THESE may contain conditions sufficient to support physical life (ie. air, water, subterranean flora and fauna, and perhaps even electromagnetically-induced illumination diffused throughout the underground "atmosphere" through a phenomena somewhat similar to the effect produced by the Aurora Borealis or "Northern Lights"). As we've said, there are literally hundreds of accounts which seem to support each other (we will attempt to describe as many of these as we can in future documents), suggesting that the above scenario or theory of a subterranean realm is a correct one. These accounts also suggest that antediluvian "Adamic" races, sometime before their destruction, possessed the ability to construct and excavate vast systems of underground tunnels connecting many of these natural cavities.

Scientific discoveries including "ooarts" (out-of-place-artifacts) also prove that the pre or ante-diluvians were much more intelligence and scientifically-advanced than most think, although of course many accounts state that this intelligence became corrupted, leading in part to their own destruction. Theologically speaking, the Bible indicates that the Adamic races achieved complex forms of scientific invention only a relatively few generations after man was established on this planet. For instance, Genesis 4:22 indicates that by the time of Tubal-cain, 7th generation AFTER Adam, complex iron and metalwork, including no doubt increasingly complex forms of weaponry, were being produced. When we take into account the long life-span of these ancients, which was on the average of 500 years or more (Gen. chapt. 5) and the time-span between Adam and Noah, and compare this with the fact that modern man himself has gone from the horse-and-buggy to interplanetary travel in LESS THAN 100 years, then such a possibility seems even more apparent. Also, Adam was no doubt formed by the Creator as a perfect

"prototype" human being. Of course he would have to be very intelligence in order to carry out the purposes which the Creator charged to him - ie. to name and identify all of the animals and trees, subdue the planet and become it's guardian, care for his wife and so on. As we've indicated, after mankind's fateful encounter with the serpent race and our progenitor's unfortunate response to the subversive strategies of the Reptilians, man lost much of the original supernatural dominion which he possessed over the earth and over the (by that time self-corrupted) serpent race. The war between the humans and the saurians had begun, and according to many sources (many of which, as we've said, we will describe later on) man was forced to defend himself from these reptilian predators.

Some sources believe that this was one of the major reasons why the Adamic race initially began, when the technology was developed to do so, to build the ancient subterranean systems. In these they would apparently be safe from the saurian predators as well as from other human races with whom they might have been in conflict. The serpent race won this battle however in that they were able, through manipulation, to turn these antediluvian human races against themselves to the point of almost complete destruction. At this point we will quote from one of the many sources describing encounters with what may very well be a remnant of this antediluvian "tunnel" network. The following account was given in a letter which was submitted to AMAZING STORIES science fiction/science fact magazine, Dec. 1946 issue, p. 162. The letter was from a George A. Lehew of (at the time) 1918 W. Newport Ave., Chicago, ILL.

Lehew wrote: "Sirs... I have been a reader of AMAZING STORIES for a very long time... I too, know of one of these entrances into the world below. It is about fifty miles south of Pittsburgh, Pa., in the first range of the Allegheny Mountains. My experiment with the caves have been only partial explorations, consisting of traveling about a mile and a quarter down into the cave itself, and returning. The cave IS VENTILATED from below, and stays at a constant 50 degrees no matter what the outside temperature may be. It is a series of rooms or galleries with narrow passages from one to another. In about the sixth room down, there is a large tree trunk which could not have come from the surface as the stratosphere (sic) is almost completely free from local fault; and it could never have come DOWN through the openings in the cave itself as they were small at the top, and kept getting progressively larger as they got deeper. "I traveled down as long as I could find comparatively easy travel--about 45 degree descent all the way--and finally came to what I thought must be the end of the cave, for I could see no more openings into rooms, but on closer examination found instead a bore, about six feet across, straight down into solid rock. I turned my flash downward and could see that it must have gone straight down for at least a hundred feet, the sides were perfectly smooth, and the shaft, or bore, in a perfect round--no apparent irregularities anywhere--I had no way of

descending any further, so I retraced my steps back up through the different rooms to the top of the mountain where the cave opens into this world. I made discreet inquiries of several old timers in that region, and found that in 1915, or about that year, six surveyors took gear and equipment, and spent a month in exploration of the cave, going 18 miles from the entrance, and down almost five miles below sea level. I have never gone back, but I hope to some day in the future, with escort, equipment, and supplies. I'd certainly love to see the machine that made that bore! If you have any information on other caves in that area, let me know—they too may tie in with this one, though if they do, their connections are very deep. Also, if you can, please describe the equipment that made that vertical shaft. Oh, yes, one more interesting item—the surveyors in their exploration of the cave, distinctly heard the rumble of MACHINER—but their calculations proved they were nowhere near a large city (surface), and they were too deep for surface noises otherwise. What is the answer?"

Another account dealing with subsurface phenomena and creatures appeared in the June, 1945 issue of AMAZING STORIES, in a letter submitted to that magazine by Jerry LaPriore (at the time) of 2024 Pleasant St., Fall River, Mass. The letter stated: "You asked for stories that might relate to... the caves. My mother was told this story by an old man who said it was true as truth itself: This man and a friend were hunting, agreeing this time to go to a portion of the wood's to which they did not normally go. They saw a deer and gave chase. It jumped through a clump of bushes and they followed—to find themselves unaccountably in the strangest surroundings. They were in a huge cavern that had numerous passageways leading from it. Before them was a monster-like man they thought was the Devil himself. The monster stared, and the two men stared ack. One of them fainted from fear, and the man who told my mother the story dragged the other away in panic, and as he did so, found himself just as mysteriously in the forest again. The old man's friend died a week later as a result of the shock he had suffered. The old man tried later to find the cave again, but failed. I know this story is true because my mother does not tell fairy tales and because she believes it." The previous letters appeared in the wake of the so-called "Shaver Mystery" which occupied the pages of AMAZING STORIES Magazine throughout the years 1945-1950. The "mystery" was based on the writings of a welder by the name of Richard S. Shaver, who had written several admittedly science fact-fiction stories after his initial manuscript A WARNING TO FUTURE MAN (which was re-written into "science fiction" format by A.S. editor Ray Palmer) originally appeared in AMAZING STORIES. These stories dealt with an underground world inhabited by human-like people called "Tero's" and their mortal enemies - grotesque, inhuman creatures called "Dero's". Both of these "races" allegedly had access to ancient "recovered" technologies including a machine which supposedly projected encephalographic thought-waves via rays electronically over long distances. Richard Shaver claimed to have visited this

subterranean realm only once physically - entering via row-boat through a shore-side cave hidden in a bay somewhere east of Washington D.C. Incidentally, as we've indicated elsewhere, there are accounts which allege that an entire system of ancient "Atlantean" tunnels with extremely hard, glazed linings have been discovered beneath the D.C. area, and that these ultimately lead to an ancient "Atlantean" subterranean complex which some say was in ancient times, and is still now, known as "NOD" - could this be a reference to the descendants of Cain? - see: Gen. 4:13-16 and also the book "WEIRD AMERICA", by Jim Branden, (E.P. Dutton & Co., N.Y. 1978). Shaver claims that while visiting his "Tero" friends in their underground city they were suddenly and without warning attacked by a group of several "Dero" who wielded beam-like weapons, yet Shaver himself for reasons unknown was spared. After the attackers left, and after he realized that all of his "friends" in the underground city were dead, Shaver allegedly then left the subterranean realm the way he came and never physically returned. This was the only physical and tangible encounter Shaver claimed to have had. After this, he says, the "inspiration" for his stories came in the form of messages received from these "thought-projection" machines. His stories, however, became much more confused and occultic after this, and even anti-Christian in nature.

Although we certainly do not doubt Shaver's former sincerity (he passed away in the mid-1970's) nor his intentions, from various indications we must make the definite conclusion that the "voices" which he heard thereafter did not originate from the "tero's" utilizing thought-projection machines but actually from sources far more infernal, and perhaps reptilian, in nature - which were in fact masquerading as "Tero's". In other words - not denying Shaver's original encounter - the powers of darkness, we believe, began manipulating Shaver in order to spread confusion and disinformation about this underground realm and its inhabitants, the reality of which (if we are to believe certain sources referred to earlier in these reports) was beginning to become known by certain groups on the surface such as secret societies, deep-level government agencies, and people such as George A. Lehw, Jerry LaPriore, and hundreds of others who were having physical encounters or knew of physical encounters with the outskirts of this "nether" world. Could this have been the reason that "they" spared Shaver? Is it possible that they cunningly intended to use someone to spread false information about the subterranean regions when in fact that person actually believed in the "information" he was receiving? We in all fairness must state that Shaver accuses RAYMOND A. PALMER of taking his writings such as the original "A WARNING TO FUTURE MAN" (describing an imminent invasion of the surface by a malevolent subterranean race) and "rewriting" it in the form of the novelette "I REMEMBER LEMURIA".

Shaver alleges that Palmer took his writings and expanded them into a science-fiction-occult format so that the original essay would be

acceptable to his science-fiction audience and gain wider exposure. If this was the case then Palmer and Shaver's plan may have backfired since many mis-led souls, aware of the basic truths of the cavern world, began flocking to AMAZING STORIES, believing every word of Shaver's re-written stories. Even though Shaver was apparently convinced that the stories he received via mental projection or the so-called "thought-machines" were true, they nevertheless contained many occultic, confused and contradictory ideas even before he sent them on to the Palmer. However Palmer must also be implicated in this if he is correct in his allegations that Palmer "occultized" his writings even more, and that Palmer also added the idea that the stories were based on "racial memories", among several other alterations. Perhaps Palmer was the one most responsible for squandering what might have potentially been a singular opportunity to educate the masses about the underground realm and the activities taking place there, and the affect some of that activity had upon the every-day lives of surface humanity.

How much of the present travesty taking place in the government-alien scenario might have been avoided if the uncorrupted TRUTH were known in the 1940's when the "Shaver Mystery" was hitting the news-stands and moulding the thinking of literally tens of thousands of AMAZING STORIES readers? The very methods used by Shaver and Palmer to "warn" the human race about this subject to some extent did just the opposite and brought ridicule on the whole field of "parapsycheological" research. Many of Palmer's obviously fictionalized and implausible "additions" to Shaver's writings, originally intended to make the subject "palatable" to the mass readership, may have in fact had an adverse affect. If then Shaver was being used as an unwitting "disinformation agent", then why would these powers of darkness - the serpent races and their demonic allies - wish to hide the truth concerning, if not the very existence of, such a nether region from surface society? We believe that the reasons are obvious. Although not all, much of this nether "world" is being used by the "infernals" as a base of operations in their age-old "Cosmic Conspiracy" or conflict with the Creator and the souls- conscience of mankind. The less we on the surface know about their existence and activities, the better it will be for their hellish cause. Shaver and Palmer as we said may have been unknowing pawns who were being used to not only spread disinformation but also to bring others under the supernatural influence of these dark powers by encouraging the readers to attempt to establish "thought-contact" with these underground races by means which have in the past been attributed to witchcraft and the occult. Many of the researchers involved in compiling these files personally know of several people who have had their lives all but destroyed by taking "their" advice and, via occult methods, have attempted to contact these underworld beings via psychic or telepathic means. And after having done so have become oppressed, tormented or even possessed by beings who are absolutely malignant in nature and insensitive to humanities welfare. Also,

mental illness, schizophrenia, and even suicide is not unheard of among those who have decided through occultic or witchcraft-related means to open up their spirits to any or all parapsychical beings which may be inhabiting the ether around them, in hopes of tapping-in to some benevolent subterranean beings' thought-beam.

We will state here that if anyone is seeking to make their life easier by joining up with an advanced race of technological beings, whether subterrestrial or extraterrestrial, they will be disappointed, as there is no single place in the universe outside of Eternal Paradise itself where one will be completely free from the relentless attacks of the powers of darkness and their insatiable attempts to devour life and vitality wherever they may find it. This is something any society has to deal with, no matter how technologically sophisticated they may be. Physical technology cannot solve non-physical or spiritual problems. Palmer's deeply occultic philosophies are evidenced by the fact that he went on to create FATE and SEARCH magazine(s) which, although occasionally providing some useful information, nevertheless propounded the "virtues" of witchcraft, spiritism and the occult. Our Creator was not being insensitively strict when He warned us to stay away from dealings with the occult or the supernatural outside of his protection. He gave this command for our own good, so that we would not end up as the degenerate spiritual slaves to infernal creatures that are ever seeking to gain control of our spiritual nature.

In Deuteronomy chapter 18: vs. 10-11 we read: "There shall not be found among you any one that maketh his son or his daughter to pass through the fire (child or human sacrifice), or that useth divination, or an observer of times, or an enchanter, or a witch. "Or a charmer, or a consulter with familiar spirits, or a wizard, or a necromancer." In spite of the Shaver - Palmer controversy, there actually have been other accounts which have described alleged PHYSICAL encounters with the underground realm, as well as with beings known as the "dero" and the "tero". It is uncertain whether Shaver intended to describe the "dero" as a runaway race of antediluvian, perhaps infernally controlled, self-perpetuating androids; or as non-human reptilian beings; or as a race of mind-controlled human sorcerers. All three groups have apparently come under the term "dero" in Shaver's stories (and the accounts concerning them which have been related by others), possibly due to the confusion resulting from the source from which Shaver received many of his alleged "revelations" as well as Palmer's own occultic and science-fictionalized installments. Perhaps the term "dero" was meant to denote a more general de-generate state of being, rather than a particular entity!?

One account, for instance, which appeared in an early issue of CAVEAT EMPTOR magazine (P.O. Box 4553., Metuchen, NJ 08820-4533), concerned a physical encounter with a HUMAN subterranean race. The account was related by an individual whose girlfriend 'Laressa' phoned him one night. She was quite shaken up and in tears, and told him that a friend of hers at school had invited her to go for a ride with her out into

the countryside. This girl friend was somewhat strange, and a loner and would often disappear and be away from school for days or even weeks at a time. As they were driving in the countryside, according to 'Laressa', this girl drove the car right towards a hill and before she knew what was happening the hill opened up into an underground 'road' and they eventually found themselves right in the middle of an underground city. She went on to say that the city was used by the 'D-Forces', a human group who used the symbol of a 'wolf' (on jewelry, etc.), and who were in conflict with another human group called the 'T-Forces'. Both, she learned, possessed 'UFO' type craft, and the T-Forces were less powerful but were growing stronger day by day. This might tie-in with Shaver's "Dero's" and "Tero's". Several years ago a man by the name of Steve Brodie claimed to have been abducted into an underground base in Arizona and later found himself walking the streets of New York City six months later with little or no memory of where he had been. Brodie told his story to researcher John J. Robinson, who related it on Long John Nebel's W.O.R. radio show in New York City. Before Brodie mysteriously disappeared again he had told Robinson that he had the feeling he was 'being watched'. His only recollection of the abduction was of being in a dungeon-like cavern in a cage-like enclosure with other humans who had told him that their captors (who wore dark, hooded capes) were known as the 'dero'. This name comes up again and again, but whether it refers to sorcerers, sauroids or synthetic beings is any one's guess. Perhaps as we've suggested all three are involved!? There have nevertheless been reports of 'possible' reptilian hominoids posing as human-like beings, such as the 'alien' described on p. 109 of John Keel's book 'THE MOTHMAN PROPHECIES': "I am an amateur herpetologist and once kept three-fanged cobras in my New York apartment... until my concerned neighbors squealed to the Board of Health. SOME OF THE DESCRIPTIONS OF THE ENTITIES IMPRESSED ME AS RESEMBLING SOME KIND OF REPTILE RATHER THAN HUMAN MAMMALS. I didn't mention the reptile notion to anyone. But on July 24, Lia (an alleged alien tied-in with the Men In Black) visited Jane (a contactee) and refused to talk about anything but eggs. She took some eggs from Jane's refrigerator and sucked out the contents like a reptile! Jane was perplexed by this exhibition and called me soon afterward." And on p. 176-177 of Signet's 1975 paperback edition of 'MOTHMEN', in reference to this same 'contactee' Keel states: "...Meanwhile, Jane's phantom friends were visiting her daily and helpfully giving her surprising information about my own 'secret' investigations. My interview with the Christiansens of Cape May, and the details of their pill-popping visitor, Tiny, was then known only to a few trusted people like Ivan Sanderson. But on June 12, Mr. Apol and his friends (the being that called itself 'Lia', referred to above, apparently being from this same group - Branton) visited Jane when she was alone in her house and asked for water so they could take some pills. Then they

presented her with three of the same pills, told her to take one at that moment, and to take one other n two days. The third pill, they said, was for her to analyze to assure herself it was harmless. They undoubtedly knew she would turn it over to me. Two hours after she took the first pill she came down with a blinding headache, her eyes became bloodshot, and her vision in her right eye was affected. When her parents came home they expressed concern because her eyes were glassy and her right eye seemed to have a cast. The sample pill proved to be a SULFA DRUG normally prescribed for infections of the urinary tract..." The possible significance of the "Sulfa" drugs will become apparent later on in these 'Files'.

Theodore Illion, in his book 'DARKNESS OVER TIBET', the inhabitants of an underground city beneath Tibet which the author claimed to have stumbled on. This underground community was allegedly ruled over by a powerful sorcerer who was part of an international secret society and who kept the inhabitants, many of whom were people who had 'disappeared' from the world above, under complete mindcontrol to the point that they lacked any personality, their eyes were vacant and empty, and their lives were emotionless and drone-like, much like an ant colony. Or in other words, much like certain 'MIB'-like beings who have been encountered by UFO witnesses. This sorcerer was allegedly in contact with an infernal (reptilian?) race via a 'bottomless shaft' which descended through the city itself. Keep in mind the 'drone-like' aspect of certain people tied-in with alien activity, as it is a common threat than can be found in other caves involving UFO's, Conspiracies and Caverns. These two accounts (Illion's and especially "Laressa's" account as given in CAVEAT EMPTOR) tend to confirm that two opposing (?) beliefs somewhat similar to the conflict between socialism on the left and fascism on the right, have caused a great deal of conflict between many HUMAN inhabitants of these nether regions. When we consider that socialism and fascism are apparently being manipulated by the same source, ie. the Illuminati (which in turn as we've seen is ultimately controlled by the serpent race) in order to turn humanity against itself so they can more readily be kept under subjection and control; then is it possible that a similar scenario is taking place in human civilizations beneath the surface of this planet?

There is evidence that the Illuminati is not only aware of the existence of these subsurface communities (for instance the subterranean connection a parently existing beneath the Masonic U.S. headquarters of the 33rd degree of the Scottish Rite located in the "House of the Temple" within Washington D.C.) but is intricately involved in manipulating it's affairs as it has done in surface society. So we see how it may be possible that the entire planet, whether surface or subsurface societies, may be subject to Reptilian - serpent cult - Illuminati manipulation via the Jesuit-Rosicrucian-Masonic movements. The CAVEAT EMPTOR account, as well as many others which have been gathered by various writers, seem to indicate that these two "factions" which largely exist among the

subterranean civilizations are known as the T-Forces (Tero's) and the D-Forces (Dero's). Each of these apparently "worship" either the positive or negative aspects of the electromagnetic "force", possibly similar to the so-called "light side" and the "dark side" of the "force" as depicted in the STAR WARS series. We realize that this concept may sound rather strange to us on the surface, but when we realize that intense electromagnetic currents may exist deep beneath the earth then it is entirely possible that any human civilization which might inhabit those regions may attempt to utilize this energy source to the point of utter dependence. If this is the case, then both of these groups would not be worshipping "God" in the Judeo-Christian sense, but rather a form of pantheistic nature-worship, the worship of CREATED FORCES RATHER THAN THE ONE WHO CREATED THOSE FORCES. This is not to say that ALL who inhabit these regions adhere to this peculiar belief system.

There have been several accounts concerning individuals who have encountered human beings - some who spoke the native language and others who spoke a language entirely foreign - within deep underground tunnels and caverns. There are many such cases, but we will refer to only one of these at this point (and will reserve the others for later in the text), an incident which may be one of the most well-known and most well-documented accounts of this type: Sometime during the 12 century, a monastic chronicler in England by the name of "Gervase of Tilbury" recorded a strange account of two "children" who suddenly appeared near a small town near Bury St. Edmunds, England. The account was also recorded in the writings of several other chroniclers who lived at the time or sometime afterwards. These include: William of Newbury - HISTORIA RERUM ANGLICARUM, written in Yorkshire, England (1136- 1198?); Abbot Ralph of Coggeshall - CHRONICON ANGLICARUM; and also the chroniclers Giraldus Cabrensis and Walsingham. The account was more recently related in FLYING SAUCERS UNCENSORED, by Harold T. Wilkins (Citadel Press., New York, N.Y. 1955., . 97-98). From their combined accounts we can piece together the following bizarre story which the chroniclers swore to be true.

One warm, sunny day in the 12th century some farmers and other residents of the small town of Wolfpittes, England - some seven miles distant from the larger village of Burry St. Edmunds - were startled to see two young children wandering around as if disoriented in some ancient "pits" or "trenches" known to the locals as the "Wolf-Pitts", after which the small village had taken its name. These excavations were ancient, but no one seemed to know when or by whom they were dug, but the consensus was that they were at least partly artificial, and very ancient. The most shocking thing about the children, which the residents of Wolfpittes encountered, was that they had skin which was olive-green in colour, yet the rest of their features were as human as the average Englishman. The villagers attempted to communicate with the children but were unsuccessful as they soon discovered that the young boy and girl spoke a

language which was completely unfamiliar to the villagers. The townspeople had compassion on the children and took them to the village and offered them various different kinds of food, all of which they seemed unfamiliar with and which they refused. However, when they were shown some beanstalks, they took them greedily, but instead of opening the bean-pods, the children attempted to open the stalks themselves, as if they had been accustomed to opening stalks in this way (apparently a practice they had learned in the land from which they emerged). Upon finding nothing in the stalks, the children began to weep. Unfortunately, the shock of entering our world was too much for the young boy, and even though he became partly acclimated to other forms of food, he nevertheless became weaker and weaker and finally died a few years afterwards. The young girl, however, adjusted quite well to her new surroundings. In fact she eventually grew into a mature, beautiful woman, and later married a gentleman from the nearby town of Kings Lynn. As time passed, her husband patiently instructed her in the complexities of the English language, and soon she was able to communicate fairly well, and the story she told of where she had come from and how she had arrived in our "world" with her brother was even more incredible. She told her husband that her people all had skin similar to hers, or rather to what her skin had once been like, as over a period of years the greenish tinge had left her. She described her world as a cavernous, subterranean country of enormous size, a country which went by the name of "St. Martin's Land." The land in which she lived was described as "twilight" in nature, yet there was a large underground river, on the other side of which there was another land more brightly lit. One day, she and her brother were herding some type of underground animal when they heard something like the sound of "bells" emerging from one of the cave passages or tunnels which lined the perimeter of this underground land. Out of extreme curiosity, they entered this tunnel and followed the passage upwards for what could have been a few days, although in their underground land they probably did not have any concept of what "day" or "night" was. After their long and weary journey up the steep incline they suddenly emerged into the brilliant sunlight of the British countryside. The change from their twilight world was dramatic, and the children walked around in the pits or trenches starved, half-blinded and disoriented. They shortly afterwards attempted to re-locate the small opening through which they had emerged, but were unable to do so, because of the blinding light. At about this point the farmers found them and took them to the village.

A somewhat similar incident "may" have been repeated in the small hamlet of Banjos (or Banos) Spain in August of 1887, several hundred years after the incident at Wolfpittes and several hundred miles distant. We state that it MAY have been repeated to some degree simply because there seems to be some confusion surrounding the Banjos account, apparently due to the possibility that some well-meaning researcher may have confused the two

incident, in essence attributing some of the events that in fact took place near Wolfpittes with the Banjos account. Basically, the Banjos incident reportedly had to do with two children who emerged from a CAVERN near the town (not "pits" or "excavations"), spoke an unknown language, and so on, although the details are sketchy. Some of the accounts of the Banjos incident repeat the Wolfpittes story almost verbatim, as if, as we said, someone somewhere mistakenly confused the two incidents, perhaps due to a lack of detail in the Banjos, Spain account. Whatever the case, it seems that SOMETHING of this general nature also occurred in this Spanish hamlet, even though the exact sources of the story are much more difficult to trace than are the sources for the Wolfpittes account. Paris Flammonde refers to this account in his book: THE AGE OF FLYING SAUCERS (Hawthorn Books, N.Y., p. 197), having learned it from an article in the September, 1967 issue of ORBIT Magazine, which in turn gave credit to an article in the Vol. XII, August 1967 issue of Dan Fry's UNDERSTANDING Magazine. Fry claimed that he got the story from an article by John Macklin which appeared in the December, 1966 issue of GRIT Magazine. The account also appears in John Macklin's book STRANGE DESTINIES (Ace Books., N.Y.); Jacques Bergier's LES EXTRA-TERRESTRES; and also appeared in the British periodical WEEKEND, on July 22, 1970. Most accounts tend to support the idea that this nether world is basically inhabited by both HUMAN beings (of many types - ranging from large to small and from relatively peaceful or "neutral" to defensive and violent, usually the latter being controlled or manipulated by the infernal inhabitants of these lower regions); and also inhabited by REPTILIAN beings (of many types), ALL of which are apparently very dangerous and indifferent or outright malicious against the human race and human life. Many of these as we've said are extremely intelligent, although these creatures sometimes, according to various accounts, appear behind occult-technological or biogenetically induced human-like "disguises" in order to increase their dominion and control through infiltration, subversion, etc. All indications seem to point to the fact that these creatures, irreparably fallen and corrupted as a race since the events of ancient Eden, have no soul nor conscience or redeeming virtues but simply operate from parasitical-like motives of gaining power and control over all creation and all life by any and all means according to their predatory nature. This infernal nature is no more thoroughly portrayed than in an incident which took place several years ago near the small town of Dixonville, Pennsylvania.

On July 14th, 1974 an article by Stoney Brakefield appeared in the Pennsylvania newspaper, NEWS EXTRA, reporting an incident which allegedly took place in 1944 near this small coal mining town, yet because of its nature it had been covered-up for nearly 40 years until the son of the mining inspector who investigated the incident revealed it as his father (then deceased) had related it to him.

This mining inspector and a fellow investigator had been called in to look into a

"cave-in" in one of the Dixonville mines. About 15 men had either been killed or turned up missing altogether in the strange disaster. Once inside the mine the inspectors eventually came across the first victim. Although lying under a broken timber surrounded by some fallen rocks and rubble, they concluded that the cave-in certainly could not have been large enough to kill the man. The inspectors were shocked to find that the body of the miner was lacerated with claw-like markings from some unknown creature. They continued and found a few other bodies, all dead and some of which had similar claw-like marks covering them. Several other miners had vanished, and were nowhere to be seen in spite of subsequent diggings. This tragedy apparently took place after the miners had broken into an ancient tunnel of unknown origin deep in the mine. This tunnel (at the time the inspectors didn't fully recognize it as the recently discovered passage or drift) was then followed by the inspectors at a

Approximately a 45 degree angle downwards for about half a mile until they arrived at a "room" which "seemed" to be the end of the passage. At this point the passage behind them just "happened" to collapse (many accounts indicate that these underground creatures can create "cave-ins" at will, as was the case in the Maltese incident mentioned in earlier texts).

A follow-up team was sent in to intersect the inspectors while this was taking place. This other crew followed the tracks of the inspectors into the mysterious tunnel and eventually found the "cave-in" and began digging through in hopes of finding the now missing investigators. In the meanwhile one inspector (the father of the man who released the story to the press) suddenly felt something like "hot breath" on the back of his neck. He closed his eyes, too terrified to see what the "thing" was. As the other workers were breaking through, the "creature" left, perhaps frightened away. The other inspector who was with him however observed the whole thing and in wild-eyed horror he exclaimed, "That thing was not of this world!"

The possibility that an ancient reptilian-saurian race may exist below the surface of this planet is not an idea which is relatively new. This infernal yet physical race has been referred to in spiritual and historical records which date back to the beginning of time. Ancient Hebrew history, for instance, records that our human ancestors were not the only intelligent, free will beings who inhabited the ancient world. Genesis chapter 3 refers to the "Serpent", which according to many ancient Hebrew scholars was identified with a hominoid or bi-ped reptilian being. The ancient Hebrew word for "Serpent" is "Nachash" (which according to STRONG'S COMPREHENSIVE and other Biblical concordances contained in itself the meanings: Reptile, Enchantment, Hissing, Whisper, Diligently Observe, Learn by Experience, Incantation, Snake, etc. all of which may be descriptive of the serpent-saurian race which we have been referring to). The original "Nachash" was not actually a "snake" as most people believe, but actually an extremely intelligent, cunning creature possessed with the ability to speak and reason. It also stood upright as we've

said, as did many of its descendants, the small "saurian" predators which ambled about on two legs. Many of these reptilian creatures retained their bi-pedal form while others mutated via natural selection, adaptation and atrophication into the other "saurian" species.

The Hebrew account stated that the serpent ace (at one time uncorrupted) irreparably sold itself out to demonic entities in exchange for occultic powers and dominion over the human race, since the Adamic race had been given dominion over the earth and "the beasts" (i.e. all non-human creatures) by Jehovah Himself. The fact that "the Beast" now for a large part rules over man is to some extent man's fault.

These infernally-empowered beings, who once roamed the surface of the planet and preyed on humanity, were later forced to go underground and make their abode in the subterranean networks which honeycomb the sub-crust of the earth. From these nether regions they have for thousands of years been carrying out their ancient and secret warfare against God and the souls of men, whom they hate intensely.

Some years ago a lady by the name of Robin Collyns wrote an article referring to this serpent race and its influence upon the human race throughout history. Collyns was of the opinion that (as these creatures alleged) the serpent race "created" man and planted him on this planet. All indications however strongly point to the fact that this is just one of many propagandist lies which this infernal race propagates. If these alien deceivers can convince man that "they" created us and therefore they are our "creator-gods" so-to-speak, then we will be all the more likely to bow down and submit to these vermin in worshipful adoration. Such "revelations" and propaganda often come through "trance mediums" who claim to channel these alien beings. On a few occasions these alien creatures have spewed forth such propaganda directly to "abductees" during "UFO" encounters.

Since their "race" has long since lost any concept of righteousness or moral integrity, "they" will not think twice about using deception or whatever means at their disposal in order to advance their over-all CONTROL of all things. Deception is and has been for thousands of years second nature to them, and therefore any statement made by them should be considered in light of this fact. John Lear alleges, based on what his sources have told him, that these entities, the saurian "greys", etc., even claim to have created Jesus. Even Lear regards this claim with great suspicion, believing that it is one of many attempts by these creatures to undermine traditional values in order to gain further control. Not to mention Jesus Himself condemned the serpent race of being in league with Satan and his demonic hierarchy! Collyns' article nevertheless contained some useful information concerning the ancient influence of these creatures, which we quote:

"...Old Sumerian, Babylonian, Egyptian, and Greek legends refer to the "serpent" deities who were believed to have once resided in the "underworld". The Garden of Eden in this context takes on additional interest and significance, possibly of paramount importance.

Pristine legends from AUSTRALIA and the PACIFIC ISLANDS offer innumerable references to serpent deities/beings who were anciently associated with the creation enigma in the area (note: There are in fact several accounts of caverns in Australia).

"...The spiral serpent symbol is found throughout the Pacific and is associated universally with the creation enigma... From earliest days, the serpent symbol is to be seen in many parts of the world, but undoubtedly the most fascinating portrayal is a detail on an Egyptian "magical" papyrus in the British Museum depicting a serpent encompassed by a ray-emitting disk. The most unusual form of the serpent symbol is a spiral representing a coiled snake; it has been discovered as petroglyphs and other pictorial representations in Britain, Greece, Malta, and Egypt, as pottery designs in New Mexico; as ground drawings on the Nazca Plateau, Peru, and throughout the Pacific Islands (Note: Nearly every site mentioned here has also been the site of intense subterranean activity and encounters with saurid beings, as the reader may recall and as he or she will see further in the text - Branton).

"...Aborigine legends," Collyns concludes, "indicate that the serpent beings were not above waging war, and an identical parallel is also mentioned in the Hindu legends of the Nagas, serpent beings who came from one of seven worlds... Aborigine legends (state that) the serpent beings waged many wars around Ayers Rock, and the vertical gutters in Ayers Rock testify to these wars."

The Nagas "seven worlds", by the way are, according to Hindu tradition, actually seven LEVELS of a subterranean nether world from where these Nagas, or serpent beings, originate.

In "THE WORSHIP OF THE SERPENT," the Rev. John Bathurst Deane made the following statements and observations: "...One of (the) five builders of Thebes was named after the serpent-god of the Phoenicians, OPHION... The first altar erected to Cecrops at Athens, was to "Ops", the serpent-deity... The symbolical worship of the serpent was so common in Greece, that Justin Martyr accuses the Greeks of introducing it into the mysteries of all their gods... The Chinese... are said to be 'superstitious in choosing a plot of ground to erect a dwelling-house or sepulchre: conferring it with the head, tail and feet of diverse dragons which live UNDER OUR EARTH.'"

The Rev. Deane also states that hieroglyphs or depictions of a circle (representing the sun) with wings and serpents emanating from it are predominant features "in the Persian, Egyptian, and Mexican hieroglyphics. China, Hindustan, Greece, Italy, and Asia Minor, as distinctly through more rarely, exhibit it; and it has even been found in Britain." (THE WORSHIP OF THE SERPENT TRACED THROUGHOUT THE WORLD, by the Rev. John Bathurst Deane., London., J.G. & F. Rivington., 1833)

In his book "VENOMOUS REPTILES" (Charles Ceaibrer Sons, N.Y. 1969), author Shirman A. Minton Jr., an expert on reptilian and amphibian biology, reveals some peculiar scientific facts concerning "reptiles". These facts include the following: A) All reptiles have

scales, B) All are cold-blooded, C) All lay eggs, D) All reptiles with well-developed limbs have clawed toes, E) TERE ARE 'LIZARDS' WITH ELONGATED SNAKE-LIKE BODIES - A TYPE OF 'MISSING LINK' BETWEEN THE LIZARDS AND THE SNAKES, F) THE MODERN EVIDENCE (SCIENTIFIC) INDICATES THAT ALL MODERN SNAKES ONCE (IN THE DISTANT ANCESTRAL PAST) POSSESSED LIMBS WHICH BECAME "ATROPHIED" THROUGH NON-USE, perhaps due to the fact they they BECAME aquatic or semi-aquatic creatures (Note: Snakes incidentally bare both aquatic AND land creatures, and can travel through either environment, as evidenced by the fact that snakes have often been seen swimming across rivers and lakes, etc. Not only Holy Scripture, but scientific evidence as well, indicates that "snakes" at one time in the ancient past had limbs but lost them in the process of time, while other reptilian species, at least for the present, have retained their limbs - Branton), G) REPTILES WITH "DEVELOPED LIMBS" USUALLY LIVE "UNDERGROUND"!

The book "VENOMOUS REPTILES" also states the following: "...Cobras (according to legends) are descended from the Nagas, Serpent gods of Bhrahma, or ancient India. Their worship has been traced to prehistoric Dravidian times before the Aryan invasion of the subcontinent in almost 1600 B.C. The Naga's power to inflict disproportionate physical damage or almost instantaneous death is explained in the Hindu Vedas as paralleling the energy of creation or fire." The book goes on to state that, A) The Naga's are said to have appeared at the birth of Guatama Siddharta, who later became "Buddha". - Note: The "Serpent" also played a large part in the legends surrounding another Hindu religious figure, ie. "Krishna.", B) The ancient "well" of Sheshna in Benares, India, is traditionally where the YOGA APHORISMS OF PATANJALI, a classical guide to students of Yoga, was written." This "well" is said to be an entrance to one of the Naga's underworld lairs.

Take note that the same pattern of deception we see here is apparently similar to that which was used against Eve as recorded in Genesis chapter 3. Satan, working through the present-day "sold-out" aurian race (the seed of the Serpent), inspired or inspires these misguided Hindu's, Buddhists, Masons, etc. (the seed of the Woman) with blasphemous doctrines based upon the lie of the original Serpent or Nachash as recorded in the Genesis account: "Ye shall be as gods", a teaching which is at the very heart of occultic Yoga philosophy; ie. that by "tapping in" to the so-called "universal serpent force" one could gain supernatural powers and thereby become a "god". Such an occult practice was carried

out by Adolph Hitler and the theosophist-rosicrucian-jesuit connected occultists who surrounded him, but instead of tapping-in to the mythical "universal force" they instead opened themselves up to hideous demonic powers which had masqueraded behind the deceptive facade of such a pantheistic "force". How else can one explain the horrible atrocities which were carried out by the Nazi's during World War II?

There are indications that Hitler and his occult societies may have subsequently come into contact with this serpent race, believe it or not. These include the fact that: Hitler had himself read "THE COMING RACE," written by the Rosicrucian Grandmaster Bulwer Lytton, describing an underground race which "tapped" a supposed force called "vriil", identical to the Hindu's "serpent force": Hitler had, after his rise to power, sent out numerous secret expeditions to nearly every continent including Antarctica, in order to explore ancient ruins and especially old mines and caverns in attempts to find geographical areas suitable for establishing underground "bases" of operation; A strange cult of Tibetan occultist-monks were actually found in some of the bombed-out ruins in Berlin near the end of the war, who had been killed by the blasts - there were also rumors that Tibetan monks were assisting Hitler in the establishment of a "demonic" world order and religion.

Again, we are not "condemning" any particular group of persons who may have been born into a society which has unfortunately fallen victim to the deception of the draconian. Many of these people grew up in a society where "tradition" and "religion" are one and the same, or in other words they are - whether they like it or not - "members" of their religion (whether it be Far Eastern occultism or other) from birth. Reptilian-inspired "religion" is forced upon a person against their will, for to deny religion would be to deny their tradition. In contrast to this, the religion of "The Lamb" does not force itself on anyone through fear and intimidation nor through traditional dogmatism; but offers itself freely to all who will receive it without condemnation. The way of "The Serpent" uses deception disguised as "secret initiation into higher knowledge" in order to manipulate a person towards believing the reptilian propaganda which they would use to get the believer to eventually worship their race. The way of "The Lamb" does not use secrecy or manipulation, but is open and honest and has nothing to hide, and therefore has no need for "secret" or "occlt" society. Unlike "The Serpent" which must hide in the darkness for fear of being discovered for what it really is, "The Lamb" has nothing to hide and does not fear scrutiny nor challenge, being absolutely perfect in every way. Therefore, this is not an attempt to "condemn" Hindus, Buddhists,

Masons, nor any other such group of persons, but an attempt to show them that there is another and a better path.

The book "VENOMOUS REPTILES" also states that "Sheshna's well", an alleged opening into the underground reptilian realm of "Patala", may be seen today in Benares, India, and according to Minton, it's author: "It has forty steps leading down into a circular depression to a stone door covered with cobras. This is said to lead to PATALA, the reptile netherworld."

Buddhist occultists like Robert E. Dickhoff, in his book "AGHARTA" (Health Research, Mokelumne Hill, CA), a somewhat "occultized" and confused look at the subterranean civilizations of Asia, nevertheless describes one event which seems to tie-in with various accounts which we have given earlier and which we will relate further on. According to Dickhoff, or rather from what he learned from certain Buddhist monks, some time in the ancient past an Asian prince and his followers had learned that a subterranean race of reptilian-like hominoids were causing a great deal of harm in the surface world through their attempts to manipulate the minds of those on the surface through "witchcraft" and "sorcery". This Asian prince eventually led an army of followers into the tunnels and caverns below central Asia and encountered the reptilian or "lizard" people. After a considerable conflict the reptilians-saurians were driven out of these ancient caverns and the (antediluvian?) subterranean cities which later became known as "Agharta". Ever since that time the reptilians, according to Dickhoff, have been plotting a re- takeover of these caverns and have been using occult "channels" to spread propaganda which would favor their cause.

In his book "ON THE SHORES OF ENDLESS WORLDS" (Souvenir Press), Andrew Tomas gives some additional information concerning the "Nagas" or the "Serpent People" who are believed to originate from a gigantic underworld cavern network below central Asia and the Far East. On p. 160 of his book Tomas states:

"...Even in this jet-age every Hindu is familiar with and usually believes in the legend of the Nagas, the "serpents" which live in extensive underground palaces in the rocky Himalayas. It is believed that these creatures are able to fly in space and that they possess amazing magical powers and intelligence. They are not too fond of man if he is a curiosity seeker, explorer or mountaineer. According to the sacred(?) tradition of the Hindus, the deep caverns of the Nagas contain fabulous treasures, illuminated by flashing precious stones. The subterranean abodes are known to be in certain parts of both the

Himalayas and Tibet, particularly around the Lake of the Great Nagas - Lake Manosarowar."

Take note of the remarkable similarity in this description and medieval traditions of hideous and malevolent "dragons" who lived in dark underground lairs along with kidnapped human maidens and "stolen treasures." We've all heard of these tales, which most have formerly attributed to fantasy. However, could such tales actually be rooted in subconscious awareness of actual realities?

Andrew Tomas describes his own personal encounters with those who claimed to have knowledge of these subterranean and space-travelling creatures. On p. 166-168 he states:

"...I decided to go to the Kulu Valley in the Western part of the Himalayas to visit Naggar, where Nicholas Roerich had lived. Since I had known him personally, the trip had sentimental overtones. A narrow curving road, a precipice on one side with rocks and avalanches on the other, were not conducive to an enjoyable journey to this remote region near Ladakh and Tibet. The village of Naggar derives its name from NAGA, the serpent. High up in the mountain lies Roerich's estate. Having been an artist of note, his two-sided house contains a museum of his paintings.

"As I began my ascent on the mountain path, I saw a tall grey-haired sadhu (hermit), sitting by a mountain torrent. In his hand he held a cobra-shaped staff, which together with the markings on his forehead, signified that he was a devotee of Shiva. During the earlier, more peaceful times of the British Raj, these pilgrims would travel to the Lake of the Great Nagas, Lake Manosarowar, or to Mount Kailas, the abode of Shiva (a "god" apparently tied-in with the Nagas - Branton), in Tibetan territory. I climbed the mountain and reached the terrace on which Roerich's house is built. I spent an hour studying (his) paintings. On the way back I admired the narrow valley and the looming snow-capped mountain ridges on both sides.

"The sadhu was still there. I thought, 'A place called Naggar, a devotee of the Nagas with the cobra staff, if he does not know something about the Nagas, then who goes?'"

After Andrew Tomas asked this man, apparently a misguided member of a serpent cult, if he knew anything about the "Nagas" or the serpent beings, the pagan devotee responded:

"I am a poor sadhu, I know nothing, sahib. But about twenty years ago my yogi teacher went into the mountain kingdom of the Nagas. Bright lights everywhere, big halls like Taj Mahal... The Nagas have many, many things and machines. They are clever, like Cambridge men, may be more clever, sahib,' the sadhu said with an apologetic smile...

"Your yogi must have been a Rishi. Don't the Nagas destroy men with their sting?" I asked.

"Yes, though the Nagas are gods and wish nothing but good to man, they do not like men who have no business near their palaces,' he replied."

One can see here the poor, miss-guided and indeed self-contradicting mentality of many of those souls who are caught up in the "serpents cults" throughout the world. In response to Thomas' accusations that THE NAGAS DESTROY MEN WITH THEIR STING, this "devotee" agrees with him and states "Yes" (they do destroy human lives). However, he then goes on to make the absolutely contradicting statement that THE NAGAS ARE GODS AND WISH NOTHING BUT GOOD TO MAN. This poor soul like so many others, apparently desiring to worship a supernatural power "greater" than himself, had actually been deceived into devoting himself to creatures which are in fact a deadly threat to man and are apparent "gods" only in the sense that their intellectual capacity allows them to develop and utilize advanced forms of occult-technology. This apparent schizophrenic or self-contradicting thinking may result from the devotee's DESIRE to believe he was worshiping benevolent entities while at the same time subconsciously acknowledging the threat that these creatures pose to human life is very real as well. Many of these people may have grown up with such false teachings and, simply because there was no alternative presented to them, ended up worshiping the serpent race r "The Beast" (This does not mean that they are beyond salvation as those who take "the mark" of the Beast of Revelation ch. 13 will be, who in essence will through a world-wide initiation willfully turn over their own WILLPOWER to "the Beast" in exchange for supernatural "godlike" powers. These will be irredeemable since their WILLS will no longer be theirs and therefore they will be unable to "choose" to return to the God of the Universe). This aspect of being taught a particular belief-system from birth has to do with the so-called "law of first report", a powerful force which states in essence that a person who learns one set of teachings BEFORE hearing of a contradictory viewpoint will often defend the teaching which he heard "first" to the death, whether that teaching is right or wrong.

The sad fact is, such serpent-race-inspired cults condemn critical, analytical thinking and demand absolute and blind allegiance and obedience to the "masters". The God of Judeo-Christian revelation is not so intimidated by men's efforts to examine His Word, but instead encourages man to "PROVE" His Word, His Prophecies, and the Scientific and Historical reliability of his revelations in an HONEST manner. Unfortunately, many of the serpent cult followers have been so ingrained from childhood with these lies that it is very

difficult to break free from such traditions when they are older. Many of these will not listen to critical arguments against their already-established views simply for pride's sake, or because of the fear or possibility of being proven wrong. This is also true with the many modern "lodge-religions" which are outwardly "Christian" yet inwardly pagan, and which play upon the human ego and the desire for "secret knowledge" which will somehow supposedly make them SUPERIOR to their fellow man if they can "make the grade" by being initiated into the "inner core"; and most who reach this "inner core" must admit if they are honest with their own conscience that much of what they supposedly "learned" there is actually contradictory to what they learned in the lower or outer "levels" when they first joined-up with such a religious movement.

We would say that these "hybrid" religions which attempt to fuse the contradicting teachings of the "Serpent" and the "Lamb" together (the first such post-deluvian cult being the ancient Babylonian Mystery Religion built around the tower of "Babel" or tower of "Confusion") are far more dangerous than the Serpent Cults themselves, as they are more likely to lead souls hungry for truth to their destruction when actually the initiate or member believes that they are on the path of light because SOME of the teachings actually ARSE based on a perverted form of truth. Jesus said "A little leaven leaveneth the whole lump" (I Cor. 5:6), or a little lie can corrupt a great deal of truth. A little "serpents venom" of self-deification, self-centeredness or selfish ego-worship can utterly destroy and corrupt any benefit of any TRUTH which the Creator would plant in a human ear, truth based on the teaching of putting God and others first and in so doing bringing about a better society, and thus PERSONAL benefit.

Andrew Tomas continues by describing other subterranean-related accounts in his book "ON THE SHORES OF ENDLESS WORLDS":

"... Traditions of vaults, labyrinths, tunnels and buried treasures of remote antiquity are found in Crete, Egypt, Tibet, Angkor, India, Mexico, Ecuador, Bolivia and Peru. The legends usually connected with the cult of the Serpent come especially in Egypt, Crete, Angkor, Tibet, India and Mexico."

Tomas also describes one account on p. 165 which stated that an "Arab fraternity" had knowledge of and access to a "subterranean gallery under the Sphinx" near Giza, Egypt which is sealed by an artificial barrier of flame. Such subterranean "barriers" have been described in other accounts, and are often described as a "sheet" of bluish flame. There are many accounts other than this one given by Andrew Tomas which tell of hidden subterranean tunnels, labyrinths, chambers and caverns - even subterranean people - which have allegedly been seen beneath the Cairo, Egypt region. Such accounts also spread to

South America, as we can see by Tomas description (p. 158) of an alleged sub-terran system beneath Peru:

"Legend has it that a vast subterranean network exists in the Andes. This would infer engineering skill of the highest calibre which the early inhabitants of South America did not lack. The megalithic stonework of Tiahuanaco has to be seen to be believed. Stones are fitted together with insets without cement as if they were ivory and not 20-ton stone blocks. These ruins were ancient even at the time of the Conquest, nor could the Indians of the period provide an answer as to the identity of the Titan-builders. Another puzzle at Tiahuanaco is the absence of burial sites in the complex. Does the reign of the Tiahuanacan Empire... go back to an unknown chapter of prehistory?" On p. 159 Mr. Tomas gives yet another account concerning Tiauanaco and the strange subterranean tunnels which allegedly undermine the area:

"The Jesuit Agnelio Oliva (1572-1542) recorded the words of an old Inca quipu reader to the effect that the real Tiahuanaco was a subterranean city exceeding the one above ground in vastness. It was believed that the entrance to the underground apartments could be gained through four tunnels. Last century one passage was evidently found as treasure hunters managed to get in, to look for gold, but only one came out. He brought out with him two gold bars but left behind his sanity. After this incident the Peruvian government decided to wall up the cave entrance..." This tunnel, according to other sources, was actually hidden among the ruins of Fort Sacsahuaman outside of and above Cuzco, Peru. The explorers allegedly found their way into ancient treasure caves beneath the Temple of the Sun in Cuzco, and most of them subsequently became lost in the dark labyrinthine maze, except for the man who returned with two gold bar. There are however "rumors" that the tunnels beneath Cuzco eventually connect with others in different parts of the Peruvian Andes.

In this file we have dealt extensively with the saurian-type alien entities. However, not all of the "aliens" encountered during UFO events or subsurface incidents are of the infernal, "sauroid-reptilian" type. Probably the second most commonly reported occupants or alien entities are the "Nordics" or so-called "Blondes" (as they have often been referred to), described as being human yet usually blond-haired and blue-eyed. These claim to have continuity with ancient earth societies who developed advanced forms of technology, and these "Nordics" or "Blondes" have been associated with nearby planetary or star systems as well as with subterranean colonies possibly descended from ancient Greco-Mayan explorers. It is uncertain just what "their" stand regarding the "serpent race" is, but some sources indicate that conflict between the two "alien" groups has existed for hundreds of years and perhaps millennia, and is increasing in

more recent times. The major centers of activity for one group of blond semi-alien humans, according to several sources, is in a network of subterranean caverns which exist a few miles beneath the surface of California and surrounding regions. One of their major "Capitol" centers of this hidden society is alleged to be a subterranean city by the name of "Telos", which is actually a Greek work meaning "uttermost".

Telos is said in itself to be inhabited by over a million persons, many of whom claim ancient ancestral ties with the old Mayan civilizations. Telos is said to be one of 7 or more subterranean cities below the United States which may have been in existence since antediluvian times and which were apparently re-discovered and re-established by various early native inhabitants of the Americas. Also, some sources claim that these "Blonde" aliens have an alliance with Oriental Subterranean humans from the "Agharta Empire". There is evidence that the subterranean network beneath California may have been inhabited continuously for over a thousand or more years.

The Telosians, etc. are allegedly aware of conditions on the surface of the earth, which they monitor constantly via TV, radio, etc., although they are usually reticent of establishing any major contact with the surface world and carry on their activities in privacy. They are apparently aware of the geological trends which are leading this planet to an eventual crisis point (ie. ozone destruction, pollution, seismic disaster, potential polar reversal, greenhouse effect, etc.) but seem to be just as helpless to do anything to stop it as are the surface governments of the earth. All this might sound like the most daring science fiction, but there are several sources who swear it's true. More on these two groups (the Telosians and Aghartians) will be revealed later on and we will leave it to the reader to decide how to deal with such allegations.

There are other groups which may have been confused with the Telosian 'Blondes'. One we will refer to as the 'Nordics' who have allegedly established bases or communities beyond the earth. Another group which may fit into the scenario will be referred by us as the 'Aryans', an alleged 'pure-bred' race of neo-Nazis who are believed to occupy underground bases below Antarctica and utilize Nazi 'aerial disk' technology. There is still another group which we should include here. There have been some accounts concerning so-called "nordics" or "blondes" or "Aryans" (which one's we do not know) who have been seen working in connection with the sauroids or the serpent race. The serpent races have apparently convinced a relatively few from one or more of these human 'races' just mentioned, to work with them, perhaps

enticing them with certain promises of supernatural or technological advancement.
